Notes to Financial Statements

1. Plan Description

The following description of the DanChem Technologies, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of DanChem Technologies, Inc. (the Company) who are age 21 or older. Excluded employees include nonresident aliens, temporary employees, and seasonal employees. Employees can enter the Plan immediately upon meeting the eligibility requirements. The Plan was amended and restated effective February 1, 2022. The Plan Administrator is responsible for oversight of the Plan. The Compensation Committee of the Company determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the maximum amount allowed by law. Participants are also permitted to contribute Roth after-tax deferrals to the Plan. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

The Company provides safe harbor matching contributions on participants' contributions equal to 100 percent of the first 3 percent of eligible compensation and 50 percent of the next 3 percent of eligible compensation. The Company may also make discretionary profit-sharing contributions to the Plan. There were no discretionary profit-sharing contributions for the year ended December 31, 2022.

The Plan allows for additional non-elective employer contributions on behalf of certain union employees who were employed as of June 1, 2013. These additional contributions totaled \$47,863 for the year ended December 31, 2022.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Investment Options

Upon enrollment in the Plan, a participant may direct all contributions to selected investments, as made available and determined by the Plan Administrator in 1 percent increments. Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer matching contributions, as well as allocations of any profit-sharing contributions, if any, and an allocation of Plan earnings. The allocation conditions for profit-sharing do not apply to the non-elective employer contributions made on behalf of the eligible union employees. The non-elective employer contributions made on behalf of the union employees will be pro-rated in the last year

of an employee's employment. Participant accounts are charged with an allocation of Plan losses, if any, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, the non-elective employer contributions made to eligible union employees, and the Company's matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows: Less than one year of continuous service - 0 percent, two years - 20 percent, three years - 40 percent, four years - 60 percent, five years - 80 percent, and six years - 100 percent. Participants become fully vested in the event of retirement, total and permanent disability, and death.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount with certain exceptions as provided by the Plan. Participants with vested account balances of \$5,000 or less will be rolled-over to an Individual Retirement Account (IRA) provider unless the participant requests a lump sum payment. Participants with vested account balances of \$5,000 or more may leave their balance in the Plan, elect to receive a single lump-sum amount, or choose to roll over their balance into another qualified retirement plan or IRA. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$12,015 and \$10,659, respectively. There were no forfeitures used during the year ended December 31, 2022.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Notes receivable terms range from one to five years or over a reasonable period of time in excess of five years, not to exceed 30 years, if used for the purchase of a principal residence. The notes receivable are collateralized by the balance in the participant's account and bear interest at fixed rates established at the initial date of borrowing. Participants may have one regular and one principal residence loan outstanding at a time. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Compensation Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to specific participant transactions (distributions and use of the trustee's investment advice service) are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net depreciation in fair value of investments.

Contributions

Contributions from Plan participants and Company matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Company profit-sharing contributions are recognized upon authorization and in the year the underlying compensation is recognized under the Plan.

Reclassifications

Certain investment presentations in the 2021 financial statements have been reclassified to conform to the current year presentation. Such reclassifications had no effect on the previously reported net assets available for benefits or changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through December 20, 2024, the date the financial statements were available to be issued.

Effective January 1, 2023, the Plan was amended and restated to merge the Ascent Industries 401(k) Plan (f/k/a Synalloy Corporation 401(k) Employee Stock Ownership Plan) into the Plan.

The total amount of assets merged into the Plan was approximately \$18,000,000 during 2023. The Ascent Industries Co. common stock held by the Ascent Industries 401(k) Plan (f/k/a Synalloy Corporation 401(k) Employee Stock Ownership Plan) remains under the custodianship of Bank of America. The Plan was amended to allow profit-sharing participant account balances from the Ascent Industries 401(k) Plan (f/k/a Synalloy Corporation 401(k) Employee Stock Ownership Plan) to be subject to a three-year cliff vesting schedule and waived for death, disability, and Early Retirement Age which is defined as age 55 and 10 years of service. The Plan was also amended to exclude certain employee groups from participation in the Plan (as defined) and to add recognition of service for certain employee groups in the Plan (as defined). Further, the Plan was amended to add an auto-escalation provision to the Plan whereby there are scheduled increases of 1 percent up to a maximum of 10 percent of compensation to be effective on April 1 of each year. The escalation provision will apply as of the second change date period after the participant first has contributions made pursuant to a default election. The Plan's safe harbor matching contribution amount was also amended to be 100 percent of the participant's elective deferrals that do not exceed 4 percent of the participant's compensation.

Effective February 7, 2023, the Plan was amended and restated to change the employer of the Plan to Ascent Industries Co. and to change the Plan name to Ascent Industries Co. 401(k) Plan.

3. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Fund (CCT) - Valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(b) Under the terms of the Declaration of Trust, retirement plans invested in the trust are required to provide either 12 or 30 months' advance written notice to the trustee prior to redemption of trust units. The notice period may be shortened or waived by the trustee in its sole discretion.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by an affiliate of T. Rowe Price. T. Rowe Price Retirement Plan Services, Inc. is the recordkeeper for the Plan; and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the recordkeeper totaled \$9,426 for the year ended December 31, 2022. The Company also paid certain administrative expenses of the Plan. These transactions qualify as exempt party-in-interest transactions.

Loans to participants also qualify as party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company discretionary profit-sharing contributions.

7. Tax Status

The Plan adopted a pre-approved defined contribution plan document from DST Retirement Solutions, LLC, which received an opinion letter from the IRS on June 30, 2020 stating that the pre-approved defined contribution plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since the date of the IRS opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks, Uncertainties and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2022, approximately 21 percent, 18 percent, 16 percent, and 15 percent of the Plan's investments were invested in the Retirement 2035 TR-E Fund, Retirement 2030 TR-E Fund, Retirement 2025 TR-E Fund, and Retirement 2040 TR-E Fund, respectively.

9. SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly. Certain provisions will become effective in 2023 and thereafter. Accordingly, there is no material impact to the Plan's 2022 financial statements.
