The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**A. Description of Plan**

The following description of Mennonite Home Association, Inc. (the "Company") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**1. General**

The Plan is a defined contribution plan covering all full-time employees of the Company who have completed three months of service and who choose to participate in the plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**2. Employer Contributions to the Plan**

Each year, the Company will contribute to the Plan the following amounts:

- (a) The total amount of the salary reduction elected to defer by employees. Maximum contribution per employee is \$22,500 and \$20,500 and the maximum catch-up additional deferral is \$6,500 and \$6,500 for calendar years 2023 and 2022, respectively. Total deferrals for the plan year ending September 30, 2023 and 2022, were \$42,975 and \$43,229, respectively.
- (b) A matching contribution equal to a percentage of the amount of the salary reduction elected to defer by employees, which percentage will be determined each year by the Company. In applying this matching percentage, however, only salary reductions up to 6% of compensation are considered. Total match for the Plan years ending September 30, 2023 and 2022, were \$17,185 and \$18,959, respectively.

In order to be eligible for matching contributions, participants must be making 401(k) contributions to the plan and have completed three months of service.

In order to receive an allocation of matching employer contributions, non-management level participants must be employed on the last day of the Plan year.

- (c) A non-elective or discretionary employer contribution is based on the relationship of a participant's compensation to the total compensation of all participants. There were no employer contributions for the plan years ended September 30, 2023 and 2022.

**3. Forfeitures**

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures can be used to pay plan expenses, can be reallocated to current participants, or can be used to reduce future employer contributions. At September 30, 2023 and 2022, forfeited non-vested accounts totaled \$320 and \$1,257, respectively. These accounts will be used to reduce future employer contributions to the Plan. Employer contributions were reduced by \$320 and \$1,257 for the years ended September 30, 2023 and 2022, respectively.

**4. Benefit Payment Options**

Distributions will be in the form of a lump-sum distribution of participants' total account balances, or selection of an alternate form of payment if allowed by the Plan.

**5. Vesting**

Benefits will vest in accordance with the Adoption Agreement. Employer non-elective accounts shall vest at a rate of 20% each year after 2 years of service (20% vested in second year) and 100% vesting at early retirement date, death or disability. Matching accounts shall vest at the rate of 20% each year after 2 years of Service (20% vested in second year) and 100% vesting at early retirement date, death or disability.

Participants are immediately vested in their contributions plus actual earnings thereon.

Vested benefits will normally be distributed to employees or their beneficiaries upon death, disability or retirement. If the employee terminates employment before any of these events, their unpaid vested benefit may be segregated in a special account.

**6. Year of Service and Hours of Service**

Employees will have completed one year of service for vesting purposes if they are credited with 1,000 hours of service during a Plan year, even if they were not employed on the first or last day of the Plan year.

**7. Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance and the maximum number of loans outstanding at any one time is two. The loans are secured by the balance in the participant's account and bear interest. Principal and interest is paid ratably through monthly payroll deductions and must be repaid over a period not extending beyond five years from the date of the loan.

**8. Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings and (c) forfeitures of terminated participants' non-vested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**9. Plan Expenses**

The Plan sponsor absorbs significant costs of the plan administration.

**B. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**B. Summary of Significant Accounting Policies (Concluded)**

***Payment of Benefits***

Benefits are recorded when paid.

***Ineligible Contributions Refundable***

Ineligible contributions refundable include the total amount of ineligible deferrals and earnings on ineligible deferrals due to participants.

***Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

***Level 1 Fair Value Measurements***

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

***Level 2 Fair Value Measurements***

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

***Level 3 Fair Value Measurements***

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**D. Information Prepared and Certified by Custodian (Unaudited)**

The Plan's investments were managed by Capital Bank and Trust Company, the custodian and managing agent of the Plan. The following information included in the accompanying financial statements and supplementary schedule was obtained or derived from information and data that has been prepared and certified as to complete and accurate by the custodian as of September 30, 2023 and 2022:

Investments, at fair value as of September 30, 2023 and 2022, were \$928,851 and \$878,517, respectively.

The Plan's investments (including investments bought, sold, and held during the year) appreciated (depreciated) in value by \$40,116 and \$(123,238) during the plan years ending September 30, 2023 and 2022, respectively.

The Plan's investments earned dividends of \$34,707 and \$35,478 during the plan years ending September 30, 2023 and 2022, respectively. Additionally, interest of \$2,139 and \$922 was earned during the plan years ending September 30, 2023 and 2022, respectively.

**E. Rollovers**

Rollover contributions are permitted from any employee even if not otherwise eligible to be a Participant. In-kind rollovers are not permitted. There were no rollovers for the years ending September 30, 2023 and 2022.

**F. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**G. Tax Status**

The Plan has adopted a volume submitter form of a prototype plan sponsored by CCH Incorporated, DBA Ftwilliam Com. The volume submitter plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the volume submitter plan's qualified tax status stating that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The volume submitter plan opinion letter has been relied upon by the Plan.

The Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. The plan administrator is not aware of any events that have occurred that might adversely affect the Plan's qualified status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**H. Related-Party Transactions and Party in Interest Transactions**

Certain Plan investments are managed by the investment custodian. Therefore, these transactions qualify as party in interest transactions. Investment fees paid to the investment custodian are netted against investment returns.

**I. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**J. Subsequent Events**

For the year ended September 30, 2023, the Company evaluated subsequent events for potential recognition and disclosure through September 30, 2024, the date of financial statement issuance. On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2023 financial statements.
