REPORT OF INDEPENDENT AUDITORS

To the Participants and Trustees of
Ohio Carpenters' Annuity Plan

Opinion

We have audited the financial statements of Ohio Carpenters' Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and April 30, 2024, and the related statement of changes in net assets available for benefits for the two months ended June 30, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Ohio Carpenters' Annuity Plan as of June 30, 2024 and April 30, 2024, and the changes in its net assets available for benefits for the two months ended June 30, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Plan Merger

As discussed in Note 9, the Plan merged into the Central Midwest Regional Council of Carpenters Defined Contribution Pension Plan (Defined Contribution Pension Plan) effective July 1, 2024. In order to be consistent with the Defined Contribution Pension Plan's filings and disclosures, the Plan recognized the transfer of net assets pursuant to the merger as of June 30, 2024. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Responsibilities of Management for the Financial Statements (continued)

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

NOTES TO FINANCIAL STATEMENTS

JUNE 30, 2024 AND APRIL 30, 2024

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements of Ohio Carpenters' Annuity Plan (the Plan) have been prepared using the accrual basis of accounting.

Investments - The investments of the Plan were reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments were reflected on a trade-date basis.

Dividend income was recorded on the ex-dividend date. Interest income was recorded on the accrual basis.

Contributions Receivable - Employer contributions due and unpaid prior to year end were recorded as contributions receivable and included amounts for liquidated damages and underpayments. Employer contributions due as determined by payroll compliance audits were recorded upon settlement with the employer. An allowance for uncollectible accounts was considered unnecessary and is not provided.

Revenue Recognition - Revenue derived from employer contributions was recognized in the period in which covered work was performed, based on the number of hours worked in covered employment and the contribution rate set forth in the collective bargaining agreement. Employers were required to remit contributions monthly. The Plan carried out its purpose in the carpentry industry as described in Note 2 within a jurisdiction primarily located in the state of Ohio.

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Reciprocal Contributions - The Plan was signatory to reciprocity agreements with various other multiemployer retirement plans for its participants who performed work outside the geographic jurisdiction of the regional councils. Participants who were normally employed within the territory of one local union (home local) may be temporarily employed within the territory of another local union (reciprocating local). When a participant of the home local worked in the territory of a reciprocating local, the latter was to make contributions to the former's fringe benefit plans on the participant's behalf. Monies received by the Plan on behalf of persons from outside participating local unions were forwarded to their home local fringe benefit plans. The Plan used the same recognition and measurement criteria for contributions received on behalf of its participants under the terms of reciprocity agreements, as for all other employer contribution revenue. Amounts paid to other plans under the terms of reciprocity agreements were not reflected in the statements of changes in net assets available for benefits, as the amounts received were not revenue earned by the Plan, and the corresponding payments were not an expense of the Plan. The Plan recognized a liability upon receiving reciprocal contributions on behalf of non-participants working within the jurisdiction of the local union, and recognized a decrease in that liability upon remitting those contributions to the appropriate plan. Employer contributions included reciprocal contributions of \$305,498 for the two months ended June 30, 2024 from various other retirement plans under the terms of reciprocity agreements. The Plan remitted a total of \$287,053 in reciprocal contributions to various other retirement plans under the terms of reciprocity agreements for the two months ended June 30, 2024. Included in accounts payable at April 30, 2024 are reciprocal contributions payable of \$394,815.

Service Revenue Reimbursements - The Plan received reimbursements of service revenue fees paid to John Hancock Retirement Plan Services LLC (John Hancock) or its affiliates under contracts with investment option issuers. John Hancock reimbursed the Plan up to \$75,000 per quarter for payment of Plan operating expenses. In addition, John Hancock received revenue from mutual fund service providers for services John Hancock provided to the funds. This revenue was used to offset certain amounts owed to John Hancock for its administrative services to the Plan. Reimbursements received for the two months ended June 30, 2024 totaled \$174,072. Included in net assets available for benefits at April 30, 2024 are unallocated accounts totaling approximately \$1,130,000. Included in net assets transferred due to the merger described in Note 10 were unallocated accounts totaling \$1,060,000. During the year ended April 30, 2024, a total of approximately \$2,600,000 was allocated back to participants. No amounts were allocated back to participants during the two months ended June 30, 2024.

Payment of Benefits - Benefit payments to participants were recorded upon distribution.

Expenses - Certain investment related expenses were included with net appreciation in fair value of investments.

Plan Administration Costs - Through April 30, 2024, any participant with an account balance was charged a \$5 quarterly fee for recordkeeping and administration costs. In addition, a participant was charged an annual fee of \$75 if deemed inactive. Participants were not charged any fees for the two months ended June 30, 2024.

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through December 30, 2024, which is the date the financial statements were available to be issued.

NOTE 2. DESCRIPTION OF THE PLAN

The Plan was established May 1, 1994 as a result of collective bargaining agreements between the Northeast Ohio District Council of Carpenters, the South Central Ohio District Council of Carpenters and the Construction Employers Association of Cleveland to provide retirement benefits for eligible participants. The Plan was primarily funded by employer contributions as specified in the collective bargaining agreements. Participant contributions were not permitted under the Plan. The Plan was a multiemployer defined contribution retirement plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan were not insured by the Pension Benefit Guaranty Corporation.

Each participant's account was credited with the contributions made on their behalf and allocations of the Plan's net earnings or losses and charged with administrative fees. Allocations were based on Plan earnings, account balances, or specific participant transactions, as defined. The benefit to which participants were entitled was the benefit that could be provided from their vested account.

Contributions to the Plan were invested as directed by the participant in one or more of the custom investment options established by the Plan. In the absence of direction, contributions were invested in a default investment fund chosen by the Trustees.

Under the provisions of the Plan, each participant's account became vested after two years of credited service. The Plan defined a year of service as a year during which a participant completed 200 hours or more of service.

Participants who were not yet vested forfeited their account balance as of the date on which a one-year break in service was incurred. A one-year break in service was generally any Plan year during which a participant earned less than 200 hours of service. Forfeitures were generally used to defray the administrative expenses of the Plan. However, participants who became re-employed under the applicable collective bargaining agreement before incurring five consecutive one-year breaks in service had their previously forfeited balance restored. Net forfeitures during the two months ended June 30, 2024 totaled \$3,445.

Upon death, disability, retirement or separation from service for more than 12 consecutive months, participants and their beneficiaries were entitled to receive the vested portion of their account balance subject to the payment provisions of the Plan. Benefits could be paid either in quarterly cash installment payments over a specified period not to exceed 10 years, or in a lump-sum payment.

NOTE 2. DESCRIPTION OF THE PLAN (CONTINUED)

As described in Note 9, the Plan merged into the Central Midwest Regional Council of Carpenters Defined Contribution Pension Plan effective July 1, 2024. To remain consistent with the surviving plan's filings and disclosures, the Plan recognized the transfer of net assets to the surviving plan as of June 30, 2024.

Participants should refer to the summary plan description for more complete information.

NOTE 3. TAX STATUS

The Plan obtained a determination letter dated September 28, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under section 401(a) of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan had been amended since receiving its determination letter. The Plan's administrator and the Plan's legal counsel believe that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

NOTE 4. FUNDING POLICY

The participating employers contributed such amounts as were specified in the collective bargaining agreements, which varied depending on the geographic area as well as type of work performed. The hourly contribution rates for the two months ended June 30, 2024 ranged from \$.25 to \$17.89.

NOTE 5. FAIR VALUE MEASUREMENTS

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of April 30, 2024. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of net assets available for benefits.

NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 Measurements

The fair values of the mutual funds were determined by reference to the funds' underlying assets, which were principally marketable equity and fixed income securities. Shares held in mutual funds were traded on national securities exchanges and were valued at the net asset value on the last business day of each period presented.

Level 2 Measurements

Other investments represented corporate bonds in default that had been substantially written off.

Measurements Using Net Asset Value as a Practical Expedient

The real estate investment fund was valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value was based on the fair values of the underlying investments held by the fund less its liabilities. The practical expedient was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported net asset value.

The real estate investment fund is a direct filing entity (DFE) and files a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions were available on a quarterly basis with a 90 day notice period.

NOTE 6. RELATED ORGANIZATIONS

The Plan shared certain common governance with several related tax-exempt organizations, which included a defined benefit pension plan, a health and welfare plan, a regional council and a service corporation.

Ohio & Vicinity Carpenters' Fringe Benefit Funds, Inc. (the Fringe Benefit Fund) is a service corporation whose purpose is to collect employer contributions on behalf of the Plan and other affiliated entities. Amounts due from the Fringe Benefit Fund at April 30, 2024 of \$1,288,584 represented contributions received by the service corporation but not yet remitted to the Plan at year end.

The Plan shared certain expenses with the related pension plan, health and welfare plan and the service corporation on a pro-rata basis. The Plan was owed \$47,537 from the related pension plan for such expenses at April 30, 2024.

Amounts due from related organizations as of April 30, 2024 are net of an amount owed for an inadvertent deposit of \$21,995 made into the Plan's checking account, which was a reimbursement for a vendor overpayment made by the related health and welfare plan.

NOTE 7. PARTY-IN-INTEREST TRANSACTIONS

John Hancock Retirement Plan Services LLC (John Hancock) and its affiliates were responsible for participant recordkeeping and distributions to Plan participants at the direction of the Board of Trustees. John Hancock maintained custody of a majority of Plan assets. Fees paid to John Hancock represented party-in-interest transactions that were exempt from the prohibited transaction rules of ERISA.

NOTE 8. CONCENTRATION OF PLAN INVESTMENTS

As of April 30, 2024, the Plan held units in the John Hancock Bond Fund with a fair value of \$133,780,199, which represented approximately 33% of net assets available for benefits.

NOTE 9. MERGER AND TRANSFER OF NET ASSETS

Effective July 1, 2024, the Board of Trustees of the Plan and the Board of Trustees of Indiana/Kentucky/Ohio Regional Council of Carpenters Defined Contribution Pension Plan agreed to merge the plans to form the new Central Midwest Regional Council of Carpenters Defined Contribution Pension Plan (Defined Contribution Pension Plan). As of the effective date, accounts of all participants were transferred to the Defined Contribution Pension Plan.
