## Independent Auditors' Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the CB Richard Ellis-Raleigh LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 12, 2024 and December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to June 12, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 12, 2024 and December 31, 2023, and for the period from January 1, 2024 to June 12, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Basis of Accounting***

As described in Notes 1 and 2 to the financial statements, the Plan was terminated on December 30, 2023. As a result, in accordance with accounting principles generally accepted in the United States of America, liquidation basis of accounting has been used in presenting the financial statements.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditors' Responsibilities for the Audit of the Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedule Required by ERISA***

The supplemental schedule, as listed in the accompanying table of contents, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **NOTE 1: DESCRIPTION OF PLAN**

The following description of the CB Richard Ellis-Raleigh LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

### **General**

The Plan is a defined contribution plan covering all eligible employees of CB Richard Ellis-Raleigh LLC (the “Company” or “Plan Sponsor”). The Plan’s trustee is Ascensus Trust Company (the “Trustee”). Ascensus, LLC serves as agent for the Trustee regarding Plan certification and Ascensus, Inc. provides certain recordkeeping and administrative services to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### **Plan Termination**

The Plan Sponsor was acquired on December 31, 2023 and the Plan was terminated on December 30, 2023. Upon Plan termination, the participants became 100% vested in their accounts.

### **Contributions**

No contributions are permitted as of or after the termination date.

### **Participants’ Accounts**

Each participant’s account is allocated with (a) the Company’s contribution, if any, and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### **Vesting**

As described above, upon Plan termination, the participants became 100% vested in their accounts.

## **NOTE 1: DESCRIPTION OF PLAN (concluded)**

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan terms range from one to five years, unless for the purchase of a primary residence, in which case, a reasonable repayment period is determined at the time the loan is made. The loan is secured by the balance in the participant's account and bears a rate of interest equal to the Prime rate plus 2%. Principal and interest are paid ratably through each payroll deduction.

### **Payment of Benefits**

Prior to the final distribution payments made during 2024, payments under the Plan were permitted upon termination of service due to death, disability, or retirement. Under those circumstances a participant was permitted to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Under certain circumstances, a participant was permitted to receive a non-recurring partial payment of his or her account. Hardship distributions and in-service withdrawals were also available.

### **Forfeited Accounts**

Forfeitures represent nonvested matching contributions of participants who have terminated their employment with the Company. As of December 31, 2023, forfeited nonvested accounts totaled \$5,842. As of June 12, 2024, there was no balance remaining for forfeited nonvested accounts. Forfeited balances are used to reduce employer contributions and pay for Plan expenses. During 2024, \$5,925 of forfeitures were used to reduce Plan expenses.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

As described in Note 1, the Plan was terminated effective December 30, 2023. Accordingly, the financial statements are presented on the liquidation basis of accounting. Under the liquidation basis of accounting, all assets and liabilities are recorded at their respective fair market values.

Benefits are recorded when paid.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (concluded)**

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the period from January 1, 2024 to June 12, 2024.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Trustee and recordkeeping fees incurred in connection with the general administration of the Plan that are paid by the Plan are included in administrative expenses. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participants’ accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE 3: INFORMATION PREPARED AND CERTIFIED BY AGENT OF THE TRUSTEE**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants as of June 12, 2024 and December 31, 2023, net appreciation in fair value of investments, interest and dividends on investments, and interest income on notes receivable from participants for the period from January 1, 2024 to June 12, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the agent of the Trustee.

#### **NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. All of the Plan's assets are valued using level 1 measurements.

Following is a description of the valuation methodology used for investments measured at fair value.

### NOTE 4: FAIR VALUE MEASUREMENTS (concluded)

*Money market fund and mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The Plan's investments were liquidated and all Plan assets were fully distributed as of June 12, 2024. The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2023:

### NOTE 5: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in certain funds managed by the Trustee; therefore, transactions related to these funds qualify as party in interest transactions that are allowable under ERISA.

For the period from January 1, 2024 to June 12, 2024, the Plan made direct payments to the Trustee and other third-party service providers for Plan administration and investment advisory services totaling \$22,689. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### NOTE 6: INCOME TAX STATUS

The Plan Sponsor adopted Ascensus, LLC's Prototype Non-standardized Profit Sharing Plan with Cash or Deferred Arrangement ("CODA") as of January 1, 2019. The Plan obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the Prototype Non-standardized Profit Sharing Plan with CODA, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **NOTE 6: INCOME TAX STATUS (concluded)**

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state tax authorities.

### **NOTE 7: DELINQUENT PARTICIPANT CONTRIBUTIONS**

Title I of ERISA requires that all employee contributions be submitted to the Plan as soon as administratively possible, but no later than the 15<sup>th</sup> business day of the month following the month of being withheld from compensation.

In 2022, the Plan Sponsor determined that participants' contributions and loan repayments totaling \$67,385 were remitted outside of the timeframe considered to be as soon as administratively possible. Lost earnings were remitted to the Plan in February 2024.

In 2021, the Plan Sponsor determined that participants' contributions and loan repayments totaling \$18,750 were remitted outside of the timeframe considered to be as soon as administratively possible. Lost earnings were remitted to the Plan in February 2024.

In 2020, the Plan Sponsor determined that participants' contributions and loan repayments totaling \$210,206 were remitted outside of the timeframe considered to be as soon as administratively possible. Lost earnings were remitted to the Plan in February 2024.

In 2019, the Plan Sponsor determined that participants' contributions and loan repayments totaling \$52,441 were remitted outside of the timeframe considered to be as soon as administratively possible. Lost earnings were remitted to the Plan in February 2024.

### **NOTE 8: SUBSEQUENT EVENTS**

The Plan Sponsor has evaluated subsequent events through the report date, the date the financial statements were available to be issued, and determined that no events have occurred that would require adjustment to or disclosure in these financial statements.
