Re: Notice CP283; Request to abate late filing penalty Form 5500; Reasonable cause letter

To whom it may concern:

I am writing to formally request an abatement of the penalties assessed on our account (45-5591586) for the late filing of form 5500SF for tax period December 31, 2023. We understand the importance of complying with filing requirements and we deeply regret the inconvenience caused by this matter.

The reason for our late filing was due to an unintentional clerical error during the transition from an ADP 401K plan to Empower/Trinet 401K plan. In previous years our 401K benefits provider ADP would prepare form 5500 and notify us in June to review and submit it on their portal. We transitioned our 401K benefits provider from ADP to Empower/Trinet effective in March 2024 (ADP balances transferred in May of 2024). The root cause of the clerical error was that we were no longer monitoring for ADP 401K emails after May, assuming that all requirements had been met during the transfer and the myriad forms we filled out during the transfer process.

Unfortunately, we missed a single June e-mail from ADP that our 2023 5500 was ready for submission, and neglected to review and submit the form on the ADP portal. The deadline for submission was October 15, 2024. During an accounting review in November, we discovered the error, and immediately submitted form 5500 via ADP on November, 20, 2024. In December, we received Notice CP283 from the IRS with an \$8,750 late filing penalty. This penalty presents an undue hardship to our small medical device business, especially when a one month delay due to an unintentional clerical error is taken into consideration. We kindly request that you review our account. You will see that we have never been late with any filings or payments, and that this was a one-time error.
