We have performed an audit of the financial statements of Elite Staffing, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 - Description of the Plan**

---

The following description of the Elite Staffing, Inc. 401(k) Profit Sharing Plan ("The Plan") provides only general information. Participants should refer to the Plan's adoption agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan sponsored by Elite Labor Services, LTD d/b/a Elite Staffing, Inc. (the "Company" or "Elite") covering all employees of Elite. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective March 1, 2022, Elite entered into an agreement to participate in an Open Pooled Employer Plan ("Open PEP") administered by Plan Professionals, LLC. Open PEP refers to a type of retirement plan where multiple unrelated employers can participate in a single 401(k) plan.

*Eligibility*

Employees are eligible to participate if they are twenty-one or older and have completed one year of service (with a minimum 1,000 hours worked), with participation entry dates of January 1 and July 1.

*Contributions*

Each year, participants may contribute up to 50 percent of pretax annual compensation, as defined in the Plan, up to \$20,500. Participants over 50 years of age may elect to contribute an additional \$6,500 in accordance with Internal Revenue Service regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Elite may contribute a discretionary percentage of each participant's elective deferral contributions. No Company contribution was made in 2022.

*Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of the Employer contributions and Plan earnings (net of administrative expenses). Allocations are based on the participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are immediately vested in their contributions plus earnings thereon. Participants who leave the Plan because of death, normal retirement, or disability retirement, as defined in the Plan, are considered 100% vested. Company contributions and earnings thereon vest in accordance with provisions of the Plan as follows:

*Forfeited Accounts*

Forfeited accounts may be used to reduce Employer contributions. For the year ended December 31, 2021, no forfeitures were used for employer contributions. As of December 31, 2022 and 2021, forfeited non-vested accounts totaled \$0 for both years.

*Investment Options*

Upon enrollment in the Plan, a participant may direct contributions in a variety of investment choices. Investment choices are more fully described in the Plan's literature. Participants may change their investment options at any time.

*Notes Receivable from Participants*

The Plan does not allow participants to borrow from their accounts.

*Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2021 excess contributions to the applicable participants prior to March 15, 2022, but subsequent to the transfer of plan assets (see Note 8).

*Payment of Benefits*

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or installments. Participants may take in-service payment of benefits on rollover contributions, upon reaching the age of 59-1/2 or financial hardship if certain criteria are met, as defined in the Plan.

**NOTE 2 -Summary of Significant Accounting Policies**

---

*Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with generally accepted accounting principles in the United States of America (GAAP).

*Use of Estimates*

The preparation of the financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from these estimates.

*Payment of Benefits*

Benefits are recorded when paid.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

*Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Elite. Expenses that are paid by Elite are excluded from these financial statements.

**NOTE 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- > quoted prices for similar assets or liabilities in active markets;
- > quoted prices for identical or similar assets or liabilities in inactive markets;
- > inputs other than quoted prices that are observable for the asset or liability;
- > inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Pooled separate accounts* - The fair value of units owned in the pooled separate accounts is based on the Net Asset Value ("NAV") on the last business day of the Plan year. The NAV of the pooled separate accounts is based on the fair value of the underlying investments held by the funds, which are traded on an active market.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - Parties-In-Interest**

Certain of the Plan's investments are managed by the Custodian, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Certain administrative functions of the Plan are performed by officers or employees of Elite. No such officer or employee receives compensation from the Plan.

**NOTE 6 - Tax Status**

The Internal Revenue Service has determined and informed Elite that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, we believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - Plan Termination**

The Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Effective March 1, 2022, the plan was merged into Open PEP, a pooled employer plan, as defined in Section 413(e) of the Internal Revenue Code and Section 3(43) of the Employee Retirement Income Security Act of 1974. On March 8, 2022, all of the plan assets of \$2,273,691 and plan liability of excess contributions payable in the amount of \$99,834 were transferred from Ameritas Life Insurance Co. to Lincoln National Life Insurance Company. The terms of Open PEP are substantially the same as the Plan.
