This 5500sf for has had me digging for days on multiple occasions when getting the notices from the IRS. Finally today i was able to reach the correct agent at my old payroll company that got merged into a new payroll company but they were able to assist me this time in finding this 5500sf form and told me i should have received a 5500sf final form to submit a while back but i did not see this or execute the final/ closing fo 5500sf form. I just received the closing form from them and they told me to copy the same info provided on a new 5500sf form and mark it as shown in the 5500sf they provided me with 01/01/2021- 10/11/2021 dates.

I was unaware of this plan i supposedly signed into in place on 10/07/2020 to start so it was hard to get on the right trail to complete and finalize it. When calling about this 2 years ago i was told since it was under a certain amount it will justt get closed out due to the low amount, but talking to different agents lead to different options on this matter.

I really hope i was able to get the correct information submitted and proceeded to complete this 5500sf final closing and ask if there is forgiveness on any late or penalties that accrued during this time i really have put in a lot of effort and time trying not to neglect this and to address this over the years with a 5500sf i don't remember filing with my digital signature. Either way I want to do whatever needs to be done to conclude this to have my EIN complete and free of any pending situations.
