#### **Note 1. Description of Plan**

The following description of the Southern Rock Restaurants, LLC Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

The Plan began on January 1, 2020 to provide health benefits covering all full-time employees of Southern Rock Restaurants, LLC (the Company), after completion of 30 days of employment, and former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions. Medical benefits are also provided to dependents of these individuals who elect coverage on their behalf. Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2023, Plan assets are no longer held in a VEBA trust. Due to this, the run-out claims were the only activity reported in 2023 and the account was fully liquidated in the beginning of 2024.

#### **Contributions**

Prior to January 1, 2023 the Company made contributions to the Plan as necessary for timely payment of all claims and administrative expenses of the Plan. The Company provided for stop loss insurance over a specified amount as per agreement with the reinsurance carrier. Employee contributions were determined on a fixed fee basis. The amount varied depending on the selection of individual or eligible dependent coverage.

The provision of benefits that are funded from contributions by the employee is not readily available information supplied to the third-party administrator and therefore, such employee contributions are included in employer contributions in the statement of changes in net assets available for benefits.

#### **Benefits**

Prior to January 1, 2023, the Plan provided medical, dental, vision, disability, life insurance, and supplemental benefits to all eligible employees of the Company who met the age and service requirements of the Plan and to their covered dependents. The Plan also provided continuation of certain benefits upon termination of employment through COBRA, as defined in the plan document.

All benefits are self-insured. The Company provided health insurance benefits and pays the administrative fees incurred. The employees paid a portion of their medical coverage based upon the coverage chosen, and also could elect disability, dental, and vision insurance through payroll deferrals. Current health claims are processed by the Plan's third-party claims processor under administrative services only arrangements.

#### **Note 2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

Due to the decision of Plan assets no longer being held in a VEBA trust, management determined that liquidation of the Plan is imminent and the financial statements for 2023 have been prepared using the liquidation basis of accounting. The 2022 financial statements were prepared as a going concern on the accrual basis of accounting.

#### Note 2. **Summary of Significant Accounting Policies**

##### **Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Payment of Benefits**

Premiums paid by the trust are recorded as insurance premium payments in the accompanying statement of changes in net assets available for benefits when paid. Claim payments are recorded when paid by the third-party claims processor.

##### **Stop-loss Insurance**

Prior to January 1, 2023, the Plan had a stop-loss insurance arrangement whereby the stop-loss insurance would cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Company was \$75,000 per covered person for the year ended December 31, 2022. In addition, the Plan had an aggregate stop-loss insurance arrangement whereby the aggregate stop-loss insurance would cover the Plan's obligations if all claims exceed a fixed dollar amount. Premiums for stop-loss insurance, if any, are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. For the year ended December 31, 2023, there were no stop-loss refunds.

##### **Plan Benefit Obligations**

Plan obligations at December 31, for health claims incurred by active participants, but not reported at that date, are estimated by the Plan's management. Such estimated amounts are reported in the accompanying statement of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments. As of December 31, 2023 and 2022 benefit obligations for claims that had been incurred, but not paid, totaled \$0 and \$78,308, respectively. These amounts are paid in the plan year immediately following the period end date noted above. It is the Plan's policy that deductions for claims are recorded when paid.

#### Note 3. **Cash and Investments**

Cash consists of funds deposited in a local depository noninterest-bearing checking account. Balances in this account are currently insured by the Federal Deposit Insurance Corporation up to \$250,000. The account balance did not exceed this insured limit at any time during the years ended December 31, 2023 and 2022. The Plan's assets did not include any assets held for investment or carried at fair value at any time during the year ended December 31, 2023 and 2022.

#### Note 4. **Plan Termination**

As of January 1, 2023, the Company has discontinued contributions to the Plan and the payment of benefits through the plan. For the 2023 plan year, the only payments made by the Plan were for claims incurred prior to January 1, 2023. During 2024, the remaining assets were refunded to the Company for the provision of benefits for or on the behalf of participants for claims incurred after December 31, 2022.

**Note 5. Tax Status**

The Trust is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the Trust and Plan's net income are exempt from federal and state income taxes. The Trustees believe that the Trust and the Plan, as amended, continue to qualify and to operate in accordance with applicable provisions of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6. Party-In-Interest Transactions**

The Plan pays certain administrative fees to the third party administrators and insurance broker based on the number of enrolled participants. These transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules of ERISA.

**Note 7. Risks and Uncertainties**

The Plan's estimated benefit obligations are reported based on certain assumptions, including level of past claims, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Note 8. Subsequent Events**

Management has evaluated subsequent events through October 7, 2024, the date on which the financial statements were available for issuance.
