We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter**

As discussed in Note 1, the Plan was merged with and into Givaudan's 401(k) Retirement Savings Plan. The transfer of assets from the Plan occurred on December 31, 2023.

**Note 1 Description of Plan**

The following description of the Ungerer & Company 401(K) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

During 2020, Ungerer & Company (the “Company”) was acquired by Givaudan Inc., a global leader in fragrances and flavors. In connection with the acquisition, a resolution was made to merge the Plan into the Givaudan’s 401(k) Retirement Savings Plan effective December 31, 2023. The Plan asset transfer amount of \$19,938,505 includes investments and notes receivable from participants of \$19,515,302 and \$423,203, respectively that transferred on December 31, 2023.

**General**

The Company established the Plan to provide employees with a systematic means of savings and investing for the future. Regular full-time and hourly employees of the Company, as defined by the Plan Document, who have attained the age of 21 and completed three months of service are eligible to participate in the Plan. Deferrals begin on the first day of the month subsequent to satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Sponsor is responsible for the oversight of the Plan and determines the appropriateness of investment offerings and monitors the investment performance.

**Employee Contributions**

Subject to annual limitations established by the Internal Revenue Code (“IRC”) each year, participants may contribute up to 75% of pre-tax annual compensation, as defined in the Plan Document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated investment until changed by the participant. The automatic deferral amount increases by 1% of compensation each year, up to maximum of 6% of compensation.

**Employer Contributions**

The Company may make discretionary matching contributions (“Matching Contributions”) at a percentage as determined by management on an annual basis. Matching Contributions are invested in a portfolio of investments as directed by the participant. Contributions are subject to certain IRC limitations. For the years ended 2023 and 2022, the Matching Contribution was equal to 25% of the participant’s contribution up to 6% contributed.

## Note 1 Description of Plan (continued)

### Participants' Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, Company's Matching Contributions, allocations of the Plan's gains or losses, participant forfeitures, and charges of administrative expenses and withdrawals. Allocations are based on participant earnings or account balances as defined in the Plan Document. Refer to Note 2 for information on investment valuation and income recognition on individual participant's account balances. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

### Vesting

Participants are 100% vested at all times in their voluntary contributions and actual earnings thereon. Participants are vested for any employer Matching Contributions as follows:

### Notes Receivable from Participants

Participants may borrow from their account balances with interest charged at a rate equal to the "prime rate" plus 1 percent, adjusted monthly. Loan terms range from 1 to 5 years or up to 25 years for the purchase of a primary residence. The minimum loan is \$1,000 and the maximum loan is the lesser of \$50,000 less the highest outstanding loan balance during the one-year period prior to the new loan application date, or 50 percent of the participant's account balance less any current outstanding loan balance. The loans are secured by the balance in the participants' account. Principal and interest are paid ratably through payroll deductions. Participants may only take out one loan during any twelve-month period and may only have two loans outstanding at any time.

### Investment Options

Participants direct the investment of their contributions and Matching Contributions into various investment options offered by the Plan. Participants may direct their contributions into one or more mutual funds and a common collective trust and may change their investment option at any time.

**Note 1 Description of Plan (continued)**

**Payment of Benefits**

Upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability or death, a participant becomes eligible to receive the current value of the participant's vested account in a lump-sum.

**Forfeitures**

There were no forfeited non-vested accounts as of December 31, 2023. As of December 31, 2022, forfeited non-vested accounts totaled \$10. Forfeitures of employer contributions shall be used at the discretion of the Company, whether to pay Plan expenses or offset future employer contributions. During the year ended December 31, 2023, forfeited balances of \$10,603 were applied toward employer contributions.

**Note 2 Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Note 2 Summary of Significant Accounting Policies (continued)**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions, reducing the participants' notes receivable balance, based upon the provision of the Plan Document.

**Benefit Payments**

Benefit payments are recorded when paid.

**Administrative Expenses**

Certain of the Plan's administrative expenses are paid by the Company and not included in these financial statements. Fees related to the administration of participants' accounts are charged directly to the respective accounts and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

**Note 3 Information Certified by the Plan's Trustee**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the investment information regarding the Plan as of December 31, 2023 and 2022 and for the year ended December 31, 2023, included in the Plan's financial statements, that was prepared or derived from information provided by Reliance Trust Company, the Trustee of the Plan, and furnished to Plan management. Plan management has obtained certifications from the Trustee that such information is complete and accurate.

#### Note 4 Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in methodologies used at December 31, 2023 and 2022.

The following is a description of the valuation methodologies used for assets measured at fair value:

- *Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- *Common Collective Trust* – Valued at the NAV of units of a bank common collective trust (“CCT”). The NAV, as reported by the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2023 and 2022.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6 Tax Status**

The Plan is based on the Non-Standardized Defined Contribution Pre-Approved Plan of ADP Retirement Services, the recordkeeper of the Plan, which received an opinion letter from the Internal Revenue Service ("IRS") dated October 6, 2020 stating that the Prototype Plan was designed in accordance with the provisions of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts. The net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto. The Plan merged into the Givaudan's 401(k) Retirement Savings Plan effective December 31, 2023.

**Note 8 Party-in-Interest Transactions**

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 1, forfeitures of employer contributions may be used to pay expenses of the Plan. Also, as described in Note 2, fees related to the administration of participant accounts are paid from Plan assets. Therefore, payments to such service providers by the Plan qualify as party-in-interest transactions.

**Note 8 Party-in-Interest Transactions (continued)**

ADP serves as record-keeper for the Plan and is therefore considered to be a party-in-interest. Reliance Trust Company serves as trustee for the Plan and is therefore considered to be a party-in-interest.

The Plan makes loans to participants and therefore, these transactions qualify as a party-in-interest.

**Note 9 Subsequent Events**

The Plan's management has evaluated subsequent events through January 6, 2025, the date the financial statements were available to be issued.
