Explanation for Late Filing of the 2023 Form 5500-SF

Scott Albert of the Department of Labor contacted me on January 2, 2025 to inform us that we did not file our Form 5500 for the year 2023. Until then, we did not realize that we needed to file. Gavan & Barker was acquired by Huitt-Zollars in 2023, and we terminated our 401(K) Plan in May 2023. Our service provider (Paychex) did not notify us when they prepared the 5500-SF, so we simply did not know that we needed to file one. Once contacted by Mr. Albert, we promptly obtained our Form 5500 and filed it with the Department of Labor.
