### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the Dayspring Academy 401(K) Retirement Plan & Trust (the “Plan”), as amended, provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all eligible regular employees of Dayspring Academy (the “Plan Sponsor”). All employees are eligible to participate in the Plan at 21 years of age and one year of service for employee deferrals. All employees except hourly employees who have attained age 21 and completed one year of service are eligible to receive employer profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, (“ERISA”), as amended.

**Contributions**

Each year, participants may contribute up to a maximum amount allowed by law. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor may elect to make a discretionary profit-sharing contribution. For the year ended June 30, 2024, the employer will make discretionary profit-sharing contributions to the Plan of approximately \$172,000. Participants direct their voluntary contributions and any employer contributions into various investment options offered by the Plan.

**Participant Accounts**

Each participant’s account is credited with an allocation of (a) the Plan Sponsor’s contribution, (b) plan earnings, and (c) charged with an allocation of investment advisory and management fees. Contribution allocations are based on the participant compensation levels, while earnings allocations are based on participant account balances. The Plan Sponsor currently offers several mutual funds and one fixed selection option account as investment options for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. A participant is vested in the employer discretionary profit sharing contributions based on years of continuous service. Participants become immediately 100% vested in the Plan Sponsor’s contribution portion of their accounts upon death or disability. Participants vest on the following schedule:

**Notes Receivable from Participants**

Participants may borrow from their account balance a minimum of \$1,000 up to the lesser of 50% of their vested account balance under the Plan or \$50,000. The notes are secured by the balance in the participant's account and bear interest at rates ranging from ranging from 5.25% to 10.50%, with terms ranging from one to five years. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of Benefits**

Upon termination of service, retirement, disability, or death, participants may receive a distribution equal to their vested account balance. Distributions may be paid in the form of a single lump-sum payment in cash or if the value of the participants account is greater than \$5,000 in certain monthly, quarterly, semiannual or annual installments.

**Forfeitures**

At June 30, 2024 and 2023, forfeited nonvested accounts totaled approximately \$6,000 and \$1,000, respectively. These accounts will be used to reduce future employer contributions. In 2024, approximately \$6,000, of the employer contributions were reduced from forfeited non-vested accounts.

**NOTE 2      SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with Generally Accepted Accounting Principles ("GAAP") requires management to make estimates that affect the amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Interest income and dividends are recorded when paid. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Date of Management's Review of Subsequent Events**

In accordance with Financial Accounting Standards Board Accounting Standards Codification "FASB ASC" Topic 855, *Subsequent Events*, the Plan evaluated subsequent

events through December 4, 2024, the date the financial statements were available for issue. No subsequent events have been recognized or disclosed.

**NOTE 3 INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

All investment, receipts, disbursements, earnings and other transactions related to the assets held by Nationwide disclosed in the accompanying financial statements and supplemental schedule of assets held at year end, for the year ended June 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Trust Company, the custodian of the Plan.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the year ended June 30, 2024.

*Mutual funds*—Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed interest accounts*—Valued at NAV of shares held by the plan at year end. The NAV, as provided by the trustee, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment earnings for amounts held in individual mutual fund accounts reflect a combination of interest income, dividend income, realized gains and losses and unrealized gains and losses depending on the composition of the underlying investments. Contributions made by the Plan Sponsor shall be applied or invested in accordance with participant directed allocations.

**NOTE 5 INCOME TAX STATUS**

The Plan Sponsor has adopted a volume submitter plan and trust that obtained a favorable determination letter from the Internal Revenue Service dated March 31, 2008. A favorable determination letter qualifies the Plan under Section 401(a) of the Internal Revenue Code (IRC), and the Plan is therefore not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan is subject to routine audits by taxing jurisdictions for the last three years; however, there are currently no audits for any tax periods in progress.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 8 PARTIES IN INTEREST AND RELATED PARTY TRANSACTIONS**

Nationwide Trust Company is the custodian as defined by the Plan, therefore, transactions with this party qualify as party-in-interest transactions of the Plan. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE 9 INCORRECT DEFINITION OF COMPENSATION**

In 2022, it was determined that the Plan was not using the correct definition of compensation when calculating elective deferrals. Plan management has corrected the error and it had an immaterial impact on these financial statements.
