## INDEPENDENT AUDITORS' REPORT

**To the Trustee, Plan Committee and Participants  
Kennesaw Transportation, Inc.  
Employee Stock Ownership Plan**

### **Opinion**

We have audited the financial statements of Kennesaw Transportation, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2023 and 2022, and the changes in its net assets available for benefits for the year ended December 31, 2023, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - PLAN DESCRIPTION**

The following description of Kennesaw Transportation, Inc. (the "Company") Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established by the Company effective as of January 1, 1997 and was restated January 1, 2012. The Plan operates as a non-leveraged employee stock ownership plan, and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code ("IRC") of 1986, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). James Urbach is the Trustee of the Plan.

The Plan purchased Company common shares on February 4, 1998. The purchase was financed by a borrowing by the Plan from the Company. The borrowing was repaid over a period of six years by fully deductible Company contributions to the trust fund. As the Plan made principal payments against the borrowing, all shares were allocated to participants.

Eligibility

The Plan is an employee stock ownership plan covering substantially all non-collectively bargained full-time employees of the Company. Employees become eligible to participate in the Plan retroactively to the first day of the Plan year during the Plan year in which the employee has attained age 20 1/2 and completed a minimum of 1,000 hours of service during a period of twelve consecutive months.

Contributions

The Company makes discretionary contributions as approved by the Trustee and Plan Committee. Employees are eligible to share in allocation of contributions only for each Plan year 1,000 hours of service is completed, provided the employee is still employed by the Company at the end of the Plan year. During 2023, the Company contributed \$155,320 to the Plan.

Participant Accounts

Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock from forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total compensation.

Payment of Benefits

As provided in the Plan agreement, on termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her vested account or substantially equal annual installments over a period of five to ten years.

Under the provisions of the Plan, the Company or Plan is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or the shares are subject to trading limitations. Participant shares will be repurchased at their fair market value based on the appraised fair market value as determined by an independent appraiser.

During 2023, the Plan made benefit payments totaling \$155,367. In connection with these benefit payments, the Plan repurchased and reallocated 17,717 participant shares to remaining eligible participants.

Vesting

A year of service is a Plan year during which a participant has completed twelve consecutive months of employment and been credited with 1,000 hours of service. Plan benefits will be vested based on the following schedule:

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents forfeiture. Forfeitures are allocated among active participants' accounts at the end of each Plan year. During 2023, there was 3,027 shares of Company common stock forfeited and reallocated to participants.

Voting Rights

The Employee Stock Ownership Trust is administered by a committee appointed by the Board of Directors of the Company. The Trustee receives her instructions from the committee, and all Company Common Stock held by the Trust is voted by the Trustee in accordance with instructions from the committee. Each participant shall be entitled to direct the voting of any voting shares of Company Common Stock allocated to his Company Common Stock account with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all the assets of a trade or business.

Administrative Fees

The Plan's administrative expenses are paid by the Plan, or paid by the Company if the Company elects to do so. During 2023, substantially all expenses were paid by the Company.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board ("FASB"). The FASB sets accounting principles generally accepted in the United States of America ("GAAP").

Use of Accounting Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income (Loss) Recognition

The investment of the Plan, discussed further in Note 4, is the Company's Common Stock and is reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the "exit price"). Fair value is determined by an annual independent valuation.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Risks and Uncertainties

The Plan's investment in the Company's Common Stock is exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Put Option

Under federal income tax regulations, the Company's Common Stock that is held by the Plan and its participants is not readily tradable on an established market, or is subject to trading limitations, and includes a put option. The put option is a right to demand that the Company buy any shares of stock, subject to plan restrictions, distributed to participants for which there is no market. The put price is the fair value of the Company's Common Stock as of the most recent valuation date. The Company can pay for the purchase in a lump sum or over a period. The purpose of the put option is to ensure that the participants have the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the Company's Common Stock into investments which are more diversified. In accordance with the Plan document, participants who are at least 55 years of age with more than 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of their account. In the sixth year in which the diversification option is available, a participant may receive a distribution of a cumulative amount up to 50% of their account.

Payment of Benefits

Benefits are recognized when paid.

**NOTE 3 - ADMINISTRATION OF PLAN ASSETS**

The Plan's investment in the Company's Common Stock is held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest and dividend income and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The following tables set forth by level within the fair value hierarchy the Plan investment assets and investment liabilities at fair value as of December 31, 2023 and 2022. As required by GAAP, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, participants will become 100% percent vested in their accounts which then become non-forfeitable and accrue investment earnings until benefits are paid in accordance with the terms of the Plan.

**NOTE 7 - TAX STATUS**

The Company was informed by letter from the Internal Revenue Service ("IRS") on February 23, 1999, that the Plan is qualified and the trust established under the Plan is tax exempt under the appropriate sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter, however, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.
