Scope and Nature of the ERISA Section 103(a)(3)(C)

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedules of delinquent participant contributions and assets (held at end of year) as of or for the year ended December 31, 2023 are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Aqua Lung America 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement or the summary plan description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Aqua Lung (Plan Administrator). The Plan was established on March 1, 2017 as a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all employees of Aqua Lung, (the Company), except for leased employees, employees who are residents of Puerto Rico, and nonresident aliens. Employees may enter the Plan on any day coinciding with or next following the date they meet the eligibility requirements.

The Plan is a spin-off from the American Air Liquide Holdings, Inc. Enhanced Savings Plan.

Contributions: The Plan includes an automatic enrollment provision. Under the provision, eligible employees will automatically have 6% of their compensation withheld as an employee contribution unless the participant elects a different percentage or elects not to participate at all. Auto-enrolled participants will have their deferral rate percentage increased by 1% annually, up to 10% of compensation. Participants may contribute up to 100% of their pre-tax compensation. The maximum employee contribution permitted by the Internal Revenue Service (IRS) was \$22,500 and \$20,500 for calendar years 2023 and 2022, respectively. However, participants who had attained age 50 by year end could also make catch-up contributions up to \$7,500 and \$6,500 for 2023 and 2022, respectively. The Company matches participant contributions. For 2023 and 2022, the Company match was equal to 100% of the first 4% of compensation that a participant contributed to the Plan. Participants may also make rollover contributions to the Plan. Rollover contributions are assets transferred to the Plan from other qualified retirement plans in which the employee participated prior to employment with the employer.

Participant contributions are recorded and remitted to the Trustee each bi-weekly payroll period and recorded in the year withheld from a participant's check. Safe harbor matching contributions for all participants are also remitted to the Trustee each bi-weekly payroll period.

Participant Accounts: Each participant's account is credited with the participant's contributions and rollovers, the Company's matching contribution, plan earnings, and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account subject to the vesting provisions of the Plan.

Vesting: Participants are immediately vested in their deferrals and the Company's safe harbor match contribution plus actual earnings thereon. Vesting in the Company's prior non-elective contribution and regular matching contribution portion of their accounts transferred from the American Air Liquide Holdings, Inc. Enhanced Savings Plan, is based on years of continuous service. A participant is 100 percent vested after six years of service for purposes of the nonelective contribution and five years for purposes of the regular matching contribution. A year of service for vesting purposes requires the completion of 1,000 hours of service within a plan year.

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Vesting (Continued): Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies or (3) terminates employment by reason of permanent disability, the Company prior nonelective contribution becomes 100% vested without regard to years of service.

Payments of Benefits: Upon retirement, death, disability or other termination of service, if a participant's vested account does not exceed \$1,000, distribution shall be made in a lump sum unless the participant requests a direct rollover. If the participant's vested account is greater than \$1,000 but less than \$5,000, a participant may elect to receive a lump sum or direct rollover by submitting a request for payment. If the Company does not receive a request for payment, the participant's account will automatically be rolled over to an Individual Retirement Account (IRA) selected by the Company. If the participant's vested account exceeds \$5,000, the participant may elect to receive a lump sum by submitting a request for payment or may defer receipt of payments according to plan provisions.

Hardship Withdrawals: Participants may withdraw all or a percentage of their account balances attributable to their own employee contributions upon approval of the Plan Administrator and subject to IRS hardship withdrawal rules.

In-Service Withdrawals: Participants who have reached age 59 1/2 may make a cash withdrawal at any time from their own employee contributions and any vested matching contributions.

Administrative Expenses: The Plan is responsible for payment of administrative expenses. However, the Company may also pay the plan expenses directly. Administrative expenses charged to the Plan include charges associated with loan and benefit payment processing and recordkeeping.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts and disclosures at the date of the financial statements and reported amounts during the reporting period. Actual results could differ from the estimated amounts.

Recently Adopted Accounting Standards: The Plan has adopted Accounting Standards Update (ASU) 2016-13, *Financial Instruments - Credit Losses (Topic 326)*, issued by the Financial Accounting Standards Board (FASB), and determined that the impact to the Plan for the year ended December 31, 2023 is immaterial.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments consists of net realized gains or losses and the net unrealized appreciation or depreciation in the fair value of investments.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payments of Benefits: Benefits are recorded when paid.

Subsequent Events Evaluation: The Plan Administrator has evaluated its December 31, 2023 and 2022 financial statements for subsequent events through December 18, 2024, the date of issuance of the financial statements. The Plan Administrator is not aware of any subsequent events that would require recognition or disclosure in the financial statements.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

T. Rowe Price Trust Company (TRP), is the Trustee of the Plan and has certified certain information for the calendar years 2023 and 2022. That information was not audited in accordance with the Plan Administrator's instructions and as permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 4. INVESTMENTS

The Plan provides for various investment options in mutual funds and other securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in those factors in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 5. FAIR VALUE MEASUREMENTS

The fair value measurement topic of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1. Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2. Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

- **Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Common collective trust:** Valued at the net asset value (NAV) of the shares held by the Plan at year end, which is based on the fair value of the underlying investments using information reported by the investment advisor at year end. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6. FORFEITURES

Participants who are not 100% vested will forfeit the nonvested portion of the employer nonelective contributions upon termination of employment. Forfeitures will be used to reduce future employer contributions or to pay plan administrative expenses. Forfeitures of \$0 were used to pay employer contributions during the years ended December 31, 2023 and 2022. The forfeiture account balance was \$0 as of December 31, 2023 and 2022.

NOTE 7. NOTES RECEIVABLE FROM PARTICIPANTS

A participant may borrow, from his or her account, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate similar to those charged for a loan made under similar circumstances by persons in the business of lending money. The repayment term of the loan is not to exceed five years, except for loans used to purchase or improve the participant's primary residence which has a repayment term not to exceed 15 years. Principal and interest is paid through payroll deductions.

NOTE 8. PARTICIPANT WITHDRAWALS AND DISTRIBUTIONS

At December 31, 2023 and 2022, there were no unpaid distributions included in accounts of participants who have elected to withdraw from participation in the Plan.

NOTE 9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

NOTE 10. FEDERAL INCOME TAX STATUS

The Plan adopted a Prototype Profit Sharing Plan, which received a favorable opinion letter dated August 19, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan qualifies and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authority. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 11. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds and common collective trusts provided through T. Rowe Price Trust Company (TRP). TRP is the Recordkeeper and Trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each plan participant's account are net of investment management fees charged by each investment fund under the Plan.

NOTE 12. PROHIBITED TRANSACTIONS

Delinquent Contributions: During the years ended December 31, 2023 and 2022, the Company inadvertently failed to deposit participant deferrals and loan repayments timely. The DOL considers late deposits to be prohibited transactions. These have not been corrected as of the date of these financial statements. The Company is currently calculating the corrective contributions required and will take corrective action to resolve these matters.
