We have performed audits of the financial statements of Greenhill & Co., Inc. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of August 13, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation for the period January 1, 2024 through August 13, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of August 13, 2024 and December 31, 2023, and for the period ended January 1, 2024 through August 13, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

As discussed in Note 1 to the financial statements, the plan sponsor of Greenhill & Co., Inc. 401(k) Profit Sharing Plan elected to terminate the Plan, and management determined liquidation is imminent as of November 28, 2023. As a result, the Plan has used the liquidation basis of accounting in presenting the December 31, 2023 and August 13, 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### *Notes to Financial Statements*

*August 13, 2024 and December 31, 2023*

#### **1. Description of the Plan**

The following description of Greenhill & Co., Inc. (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### **General and Liquidation of Plan Assets**

The Plan was a participant-directed defined contribution plan, as described in Section 401(k) of the Internal Revenue Code and became effective on March 1, 1996. Fidelity Management Trust Company (Fidelity) was retained as trustee and has provided custodian services of the Plan as of August 13, 2024.

Employees were eligible to participate at the beginning of the fourth month after their starting date and attaining the age of 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Eligible employees of the following entities were covered pursuant to the Plan:

Greenhill & Co., LLC

#### **Termination of Plan**

On May 20, 2023, the Company, Mizuho Americas, LLC, a Delaware limited liability company, (“Mizuho Americas”), and Blanc Merger Sub, Inc., a Delaware corporation and wholly owned subsidiary of Mizuho Americas (“Merger Sub”) entered into an Agreement and Plan of Merger (“the Merger Agreement”) pursuant to which the Merger Sub would merge with and into Greenhill (the “Merger”), with Greenhill continuing as the surviving corporation in the Merger and a wholly owned subsidiary of Mizuho Americas. The Merger was unanimously approved by Greenhill’s Board of Directors and was also approved by the Greenhill’s shareholders on August 16, 2023. On November 30, 2023 (“Effective Date of the Merger”), pursuant to the terms of the Merger Agreement, the Merger Sub merged with and into Greenhill, with Greenhill surviving as a wholly owned subsidiary of Mizuho Americas.

The Merger Agreement required that the Company shall provide Mizuho with evidence that the Plan has been terminated prior to the Closing Date. Therefore, effective November 28, 2023, the Plan was terminated where no additional contributions can be made into the Plan. Upon termination, all Participants became fully vested in Non-elective Employer Contributions.

In the first quarter of 2024, Participants were able to rollover their balances from the Plan to the Mizuho Americas 401(k) Plan, rollover to an IRA or Qualified Retirement plan, or take a lump sum distribution. The group rollover from the Greenhill & Co., 401(k) Plan to the Mizuho Americas 401(k) Plan occurred on April 5, 2024. The remaining funds were either (1) rolled over to a retirement account at Millenium Trust Company if the Participant’s balance was greater than \$1,000 or (2) liquidated as a taxable distribution check to the Participant. The Plan fully liquidated on July 26, 2024, and effective August 13, 2024, all assets have been distributed from the Plan. Participants are 100% vested in Non-elective Employer Contributions.

#### **Notes Receivable from Participants**

Participants were permitted to borrow from their accounts prior to the liquidation. The maximum amount of any loan was the lesser of: a) 50% of the participant’s vested account, or b) \$50,000, reduced by the highest outstanding loan balance during the prior twelve month period. Other restrictions that applied in determining the amount that could have been loaned to a participant are also contained in the Plan document.

The interest rate on these loans was determined by the Plan administrator at the prevailing rates charged by persons in the business of lending money for loans which would be made under similar circumstances.

### 1. Description of the Plan (Continued)

The maximum loan repayment term was five years, unless the loan was used to purchase a principal residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan. Loans made to active employees were repaid through after-tax payroll deductions. The loans were collateralized by the balances in the participants' accounts. All loans were in a suspended inanimate state at December 31, 2023.

#### Participant Accounts

Each participant's account was credited with allocations of: (a) the Company's contribution and (b) Plan's earnings and was charged with an allocation of administrative expenses for investments with the trustee. Allocations were based on participant earnings or account balances, as defined.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The Company approved the termination of the Plan effective November 28, 2023. As a result, the Plan has adopted the liquidation basis of accounting for periods after December 31, 2022.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

The Company pays half of all of the investment advisory service expenses of the Plan. Other expenses relating directly to the investments of the funds are paid by the Plan.

### 3. Investment Information Certified By Plan's Custodian (Unaudited)

The following is a summary of the investments and notes receivable from participants regarding the Plan as of August 13, 2024 and December 31, 2023 and for the period January 1, 2024 through August 13, 2024 and year ended December 31, 2023. This information was derived from the Plan's financial statements that were prepared by the Plan's trustee, Fidelity Management Trust Company. The Plan administrator has obtained a certification from the trustee that such information is complete and accurate.

The Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

#### **4. Fair Value Measurements**

The Plan accounts for financial instruments measured at fair value in accordance with accounting guidance for fair value measurements and disclosures which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the pronouncement are described below:

The three levels of the fair value hierarchy under FASB Authoritative Guidance are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

- Mutual funds: Valued at quoted unadjusted market prices in an active market held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.
- Stable value collective trust fund: Composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate the fair value. The practical expedient would not be used if it determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments and the redemption notice period of 12 months is applicable only at the Plan level.

There were no Plan assets as of August 13, 2024.

**5. Related-Party Transactions**

The Plan investments in various funds were managed by Fidelity. Fidelity was the trustee as defined by the Plan and, therefore, these funds qualify as party-in-interest transactions.

Total administrative expenses for the Plan amounted to \$55,712 for the period January 1, 2024 through August 13, 2024. The Company provided certain administrative services at no cost to the Plan.

**6. Tax Status**

The Plan operated under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Fidelity. This prototype plan document has been filed with the appropriate agency. The Plan had not obtained or requested a determination letter. However, the Plan Administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

**7. Risks and Uncertainties**

The Plan's investments are concentrated in funds that invest in marketable equity securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain equity securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

**8. Subsequent Events**

The Plan has evaluated subsequent events through January 7, 2025, the date the financial statements were available for issuance.
