Accordingly, on March 28, 2024, the Plan's net assets were transferred to the successor plan. Our ERISA Section 103(a)(3)(C) audit opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Plan Description

The following description of Controltek 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General and Eligibility

The Plan was established January 1, 1986 and is a defined contribution plan covering all employees of ControlTek, Inc. (the “Company”) who have completed three months of service and are at least twenty-one years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”). A board of trustees is responsible for overseeing the Plan including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. John Hancock Life Insurance Company (“John Hancock” or “Custodian”) is the Plan’s investment custodian and recordkeeper.

Plan Merger

As further discussed in Note 6 to the financial statements, effective March 28, 2024, the Plan merged into the Vexos 401(k) Plan (EIN: 20-4054968, Plan Number 002), as a result of the Company’s acquisition by Vexos, Inc., and the Plan’s net assets and participant accounts were transferred to the Vexos 401(k) Plan accordingly.

Contributions

Participants may contribute up to 100 percent of their annual compensation to the Plan, not to exceed certain dollar amounts as determined by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions are invested in a designated fund until changed by the participant. Undesignated participant contribution rates of less than 6 percent are automatically increased by 1 percent annually, commencing on the first day after their second year of employment, and each plan year thereafter, until reaching the Plan’s maximum deferral rate for automatic increases.

As determined annually by the plan sponsor’s management, the Company may elect to contribute a discretionary matching and/or profit sharing contribution. To be eligible to receive an allocation of any discretionary profit sharing contributions, participants must work at least 1,000 hours during the plan year and be actively employed on the last day of the plan year. For the three-month period ended March 31, 2024, the Company contributed a qualified safe harbor matching contribution equal to 100 percent of participant salary deferrals, up to the first 1 percent of eligible compensation, plus 50 percent of participant salary deferrals between 1 percent and 6 percent of eligible compensation. Participants direct the investment of their contributions, discretionary employer matching and profit sharing contributions into various investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and employer matching contributions, as well as allocations of any employer profit sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant

transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Upon qualifying to enter the Plan, participants are vested immediately in their contributions, discretionary employer matching and profit sharing contributions, plus earnings thereon. Employer qualified safe harbor matching contributions fully vest after two years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000. Loans may not exceed 50 percent of the participant's vested account balance. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Loan terms may not exceed five years except for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon attaining fifty-nine and one-half years of age, death, termination of employment, or incurring certain financial hardships; a participant, or his or her beneficiary, may elect to receive either a lump-sum amount equal to the participant's vested account balance or receive installment payments equal to the participant's vested balance over a period of not more than the participant's assumed life expectancy.

Forfeited Accounts

At March 31, 2024 and December 31, 2023, no forfeited nonvested accounts were held by the Plan. Forfeited nonvested accounts may be used to pay the Plan's expenses or to reduce future employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2024 or December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefits Payments

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events through January 9, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at March 31, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the three-month period ended March 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1. Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. Fair values are provided to the Plan by John Hancock for all of the Plan's assets as follows:

- Registered investment companies: Registered investment company accounts, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Insurance company general accounts: Insurance company general accounts consist of guaranteed interest accounts which are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. The guaranteed interest accounts are not considered to be fully benefit responsive; accordingly, they are presented at fair value in the accompanying financial statements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at March 31, 2024 and December 31, 2023.

5. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the Plan's investment custodian as defined; therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid at the investment fund level rather than by direct payments from the Plan. During the three-month period ended March 31, 2024, the Plan made direct payments to certain vendors totaling \$13,923 for contract administration, recordkeeping, and brokerage fees. The plan sponsor pays directly certain other fees related to the Plan's operations.

6. Plan Termination and Merger

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a plan termination, participants would have become 100 percent vested in the employer contributions portion of their accounts.

During the year ended December 31, 2023, the Company was acquired by Vexos, Inc. Effective March 28, 2024, the Plan merged into the Vexos 401(k) Plan (EIN: 20-4054968, Plan Number 002) and its net assets and participant accounts were transferred accordingly.

7. Plan Tax Status

The Plan has adopted a volume submitter profit sharing plan agreement which the Internal Revenue Service has determined, by a letter dated June 30, 2020, is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter; the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
