Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Elite Cuisine, LLC 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 15, 2024 (in Liquidation) and December 31, 2023 (in Liquidation), and the related statements of changes in net assets available for benefits for the period ended March 15, 2024 (in Liquidation) and the year ended December 31, 2023 (in Liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 15, 2024 and December 31, 2023, and for the period ended March 15, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Board of Directors of Elite Cuisine, LLC, the Plan's sponsor, voted on August 24, 2023, to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the financial statements to the liquidation basis used in presenting the financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1. Description of the Plan

General and Plan Termination

The following description of the Elite Cuisine, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan’s provisions.

The Plan was a defined contribution plan sponsored by Elite Cuisine, LLC (the “Company”) for the benefit of its employees who had at least six months of service, with at least 500 hours worked in that period, and were age 21 or older. Entry dates for the plan were January 1 and July 1 once eligibility requirements were satisfied. Union employees, leased employees, non-resident aliens and independent contractors were not eligible to participate in the Plan. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). John Hancock Life Insurance Company was the custodian of the Plan.

On August 24, 2023, the Plan Sponsor approved the termination of the Plan, and the Plan amendment became effective October 31, 2023. As of this date, no additional employees could become eligible, no further contributions were allowed, and all employees were fully vested in the Plan. The Plan was fully liquidated as of March 15, 2024.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions of up to 75% of their eligible compensation. Employee rollover contributions were also permitted. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Company profit-sharing contributions were discretionary as determined by the Company’s management. Contributions were subject to certain limitations, and were allocated to those participants who had completed 1,000 hours of service and were employed on the last day of the Plan year. The Plan also permitted qualified nonelective employer contributions to be made to eligible participants without regard to the last day of employment or service requirements.

Effective January 1, 2023, the Plan was amended to freeze contributions to the plan. As of this date, no further contributions were allowed.

Participant Investment Account Options

Each participant had the option of directing their contributions into any of the various investment options offered by the Plan and could change the allocation daily.

Participant Accounts

Each participant’s account was credited with the participant’s contribution, the Company’s contributions and Plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Vesting

Participants were immediately vested in their voluntary contributions and qualified nonelective employer contributions plus earnings thereon. Vesting in the Company’s profit sharing contribution portion of their accounts plus earnings thereon was based on years of continuous service. A participant was fully vested after six years of continuous service. The non-vested balance was forfeited upon termination of service. Forfeitures were used to pay Plan expenses or reduce Company contributions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant could elect to receive a single-sum cash payment as soon as administratively feasible.

Forfeited Accounts

At March 15, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$83,550, respectively. These accounts could have been used to reduce future employer contributions and administrative expenses. During 2024, \$18,742 of forfeited nonvested accounts were used to pay plan expenses and \$64,808 were reallocated to active employees.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Quoted market prices, if available, were used to value investments. Pooled separate accounts were valued at estimated fair value as provided by the custodian.

Purchases and sales of securities were recorded on a trade-date basis. Net appreciation in the fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Administrative Expenses

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets

If quoted market prices were not available, then fair values were estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which were market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities were classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs were not available, securities were classified within Level 3 of the hierarchy. There were no Level 1 or Level 3 investments held by the Plan.

Note 6. Tax Status

The Plan operated under a non-standardized pre-approved profit-sharing/money purchase/CODA adoption agreement sponsored by Ascensus LLC. This prototype Plan Document had been filed with the appropriate agency and had obtained a determination letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the financial statement date.
