Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The Bell Pump Service Company, Inc. 401(k) Profit Sharing Plan transferred its net assets into the Marcone Appliance Parts Center 401(k) Profit Sharing Plan and ceased operations as of January 23, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Bell Pump Service Company, Inc. Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Bell Pump Service Company, Inc. Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Bell Pump Service Company, Inc. 401(k) Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective December 31, 1963, and most recently restated January 1, 2016 to comply with several recent legislative actions and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's record keeper and investment custodian is the Principal Life Insurance Company.

Eligibility

The Plan covers all eligible employees of The Bell Pump Service Company, Inc.; Burner Supply Co, Inc.; Clark & Company, Inc.; and The Simons Company, Inc. (collectively referred to as the Company) who elect to participate in the Plan.

1. Employee Elective Contributions – Employees are eligible to participate in employee elective contributions as of January 1st or July 1st immediately following the completion of six months of service, and reaching the age of 18.
2. Employer Safe Harbor Matching Contributions – Employees are eligible to participate in employer safe harbor matching contributions as of January 1st or July 1st immediately following the completion of six months of service, and reaching the age of 18.
3. Employer Discretionary Additional Matching Contributions – Participants are eligible to participate in employer discretionary additional matching contributions as of January 1st or July 1st immediately following the completion of six months of service, and reaching the age of 18.
4. Employer Discretionary Non-Elective Contributions - Participants are eligible to participate in employer discretionary non-elective contributions as of January 1st or July 1st immediately following the completion of six months of service, and reaching the age of 18.

NOTE 1 - DESCRIPTION OF PLAN (continued)

Contributions

Each plan year, participants may make elective deferral contributions, in flat amounts, of pretax annual compensation up to the maximum deferral limits, as defined by the Plan and allowed by law. Additionally, participants who are 50 years of age are permitted to make additional catch-up contributions as defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing pretax rollover distributions from other qualified defined contribution plans and certain individual retirement accounts (IRAs).

The Company makes matching safe harbor contributions of 100% of the participant's elective deferral contributions up to 3% of eligible compensation plus 50% of participant elective deferral contributions that exceed 3% up to 5% of eligible compensation for a maximum of 4% of eligible compensation, as defined by the Plan. Eligible compensation for the first year of participation is only compensation for the portion of the plan year in which the employee is eligible to participate in the plan.

The Company may make a discretionary additional matching contribution as determined by the Board of Directors. The total amount of this discretionary additional matching contribution cannot exceed 4% of eligible compensation. The Company has not made a discretionary additional matching contribution in the Plan year 2024.

The Company may make a discretionary non-elective contribution as determined by the Board of Directors. To participate in the employer discretionary non-elective contribution, the participant must meet service and age eligibility requirements, be employed on the last day of the Plan year or, if not employed on the last day of the year, must have been credited with at least 501 hours of service during the Plan year. Participants who are not actively employed at the end of the Plan year due to death, disability or normal retirement will be eligible to participate in the employer discretionary non-elective contribution regardless of the above conditions. The Company has not made a discretionary non-elective contribution in the Plan year 2024.

All employee and employer contributions are invested in the Plan's investment options in percentages as elected by the participants.

Participant account balances are accounted for as defined by the Plan.

Participant Accounts

Each participant's account is credited with the participant's elective contributions, employer safe harbor and discretionary additional matching contributions and allocations of the Company's discretionary non-elective contribution plus Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participants' earnings, account balances, or specific participant transaction, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in all employee and employer contributions plus actual earnings thereon.

Participants' Investment Options

Upon enrolling in the Plan, a participant may direct participant elective and rollover contributions and the employer safe harbor and discretionary contributions into several available investment funds. Investments funds range from one stable value collective investment trust fund; two collective investment trust funds (CIT's) varying in their assets mixes among stocks bonds and other investments with varying degrees of risk; 6 "targeted" or "aged-based" mutual funds varying in their assets mixes among stock and bond funds; and 7 mutual funds in a combination of bond and equity securities with varying degrees of risk.

Participants may change their investment options daily.

Payment of Benefits

Participants, or beneficiaries in the case of death, are entitled to the value of their vested accounts at such time as they attain normal retirement age or upon termination of service due to death, disability, or termination of either employment.

Hardship distributions are allowed for participants incurring an immediate and heavy financial need under certain limited circumstances, as defined by the Plan. Hardship distributions are strictly regulated by the Internal Revenue Service and all requirements must be met before requesting a hardship distribution. All participant accounts balances are available for hardship distributions. Participants receiving hardship distributions are no longer prohibited from making contributions into the Plan for 6 months.

The Plan allows for in-service distributions for all participant account balances based upon the attainment of age 59-1/2.

Forfeitures

Forfeited non-vested accounts totaled \$-0-, at January 23, 2024 and December 31, 2023.

Subsequent events

In preparing these financial statements, the plan management has evaluated subsequent events through January 9, 2025, the date the financial statements were available to be issued.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the ex-dividend date. A total of \$-0- of long and short term capital gain dividend distributions from mutual funds are included in net appreciation (depreciation) in fair value of investments. In addition, net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates, Economic Dependency, and Concentrations

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

The Plan is economically dependent upon contributions from the Company and Plan participants.

The investments in the Plan are concentrated in Principal Collective Investment Trust Funds, Vanguard Target Retirement, Fidelity Investments Index, T. Rowe Price, and American Funds mutual funds.

Administrative Expenses

Certain expenses for maintaining the Plan are paid directly by participants and are included in administrative expenses of the Plan. Fees related to processing distributions and certain other transactional charges are charged directly to the participant's account. Asset based fees for recordkeeping, compliance testing and form 5500 preparation, trustee services, and investment advisory services are allocated and charged to participant accounts, in accordance with approved service agreements.

Certain expenses, such as prototype Plan updates and document services, employee educational services, and accounting and auditing services, are paid directly by the Company and are excluded from these financial statements.

NOTE 3 - CERTIFIED INVESTMENTS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal Life Insurance Company, the trustee of the Plan, as complete and accurate, except for comparing such information certified by the trustee with information included in the Plan's financial statements and supplemental Schedule H, Line 4i – Schedule of Assets Held for Investment Purposes at End of Year.

- The fair value and physical custody of the collective investment trusts as well as mutual funds of \$-0- and \$20,463,249, in total and by investment option, at January 23, 2024 and December 31, 2023, respectively.
- Net appreciation in the fair value of investments of \$37,053, in total and by investment option, for the period ended January 23, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 23, 2024 and December 31, 2023.

Mutual Funds

The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Investment Trust Funds

The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of a collective investment trust fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The fair values of participation units held in the bank collective investment trust funds (CITs) are based upon the NAV of the underlying assets held by the CITs less their liabilities as noted in the CITs audited financial statements at January 23, 2024 and December 31, 2023.

The inputs or methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table presents by level, within the fair value hierarchy, the plan investment assets at fair value on a recurring basis. As required by generally accepted accounting principles, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan incurred \$4,899 and \$56,898 respectively, for recordkeeping, trustee, investment management and advisory, distribution and other administrative fees to Principal for the period ended January 23, 2024 and December 31, 2023, respectively.

In addition, personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan.

All other Plan expenses associated with the administration of the plan, such and accounting and auditing fees and other administrative expenses were paid by the Company.

The above transactions qualify as party in interest transactions.

NOTE 6 - PLAN TERMINATION

The Bell Pump Service Company was acquired by Munch's Supply, a Marcone company, on November 1, 2022. The Trustees of Bell Pump Service Company, Inc. 401(k) Profit Sharing Plan voted to merge into the Marcone Appliance Parts Center 401(k) Profit Sharing Plan as of January 1, 2024 at which time plan participants became 100% vested in all accounts. The Bell Pump Service Company, Inc. 401(k) Profit Sharing Plan transferred its net assets into the Marcone Appliance Parts Center 401(k) Profit Sharing Plan and ceased operations on January 23, 2024.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in a variety of investments. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Users of these financial statements should be aware that the volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at January 23, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE 8 - TAX STATUS

The Plan is a pre-approved plan created by Principal Life Insurance Company. The Internal Revenue Service has determined and informed Principal Life Insurance Company by an opinion letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the Principal Life Insurance Company opinion letter, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC and no provision for income taxes is necessary.

Generally accepted accounting principles require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan management has analyzed the tax positions taken by the Plan, and has concluded that as of January 23, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's tax returns generally remain open for examination for three years from the date filed.

NOTE 9 – RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H, FORM 5500

These accompanying financial statements are reported on the accrual basis of accounting. In addition, net appreciation in fair value of investments on the financial statements does not include certain other income, but it is reported separately on the financial statement. The form 5500 schedule H includes this income in net appreciation in fair value of investments.

NOTE 10 – SECURE ACT 2.0

In December 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2024 financial statements.
