To Whom It may concern:

My client received a notice dated 9/9/24 from IRS stating that they needed to submit their form 5500 for tax year 2022. We responded to this notice that the company closed in June 2021. There were only 2 employees that had funds in their accounts in the Profit Share Plan when the company closed, and both transferred their funds to their individual IRAs at Raymond James resulting in the Profit Share Plan to be closed. Because the payroll was processed by Paychex, my client thought they had filed the final return for 2021. I wrote a letter explaining this to IRS but received a second letter that my client needed to complete and file a "Final" 5500 Annual Return/Report of Employee Benefit Plan for plan year ending 12/31/22. showing zero end of year assets, zero participants at year end, and mark as "FINAL". Because EFAST@ system only has 5500-SF filings through 12/31/20, I have submitted the "FINAL" for my client in this filing for the plan year ending 12/31/21.

Now that my client has filed all the 5500 SF filings and closed out their account, been timely with prior year filings, and because my client was under the impression that Paychex had handled this final reporting for them and they have not been of help trying to respond to this requirement, we are requesting abatement of penalties and interest for this delinquent filing.
