The Employer is aware of the annual reporting requirements and has established a history of compliance with annual reporting requirements since the inception of the Plan in 1959, including annual reporting requirements under §6058 for all prior years.

The Employer asserts that the late filing was due to reasonable cause and that any penalty proposed to be assessed under Internal Revenue Code §6652(e) should be abated or waived pursuant to Treas. Reg. §301.6652-3(b)(1). The following statement is prepared pursuant to Treas. Reg. §301.6652-3(b)(3) and sets forth the facts supporting reasonable cause for failure to timely file said return.

Best Best & Krieger LLP ("BBK") is the third party administrator for the Plan. On January 31, 2024, BBK filed an Application for Extension of Time To File Certain Employee Plan Returns (Form 5558) on behalf of the Employer for the Plan. BBK is currently undergoing a change in staff that handles the annual filings. As a result of the staff change, and due to a subsequent clerical error, the 5500 return was not timely filed by the extended deadline of April 15, 2024. Upon discovery of said error, the 5500 return was immediately finalized for signature and electronically submitted to the IRS.

Employer asserts that its third party administrator's clerical error led to its failure to timely file the 5500 return and that it was not responsible for the oversight.

Employer asserts that it has acted in a responsible manner and that the oversight by its third party administrator is reasonable under the circumstances and respectfully requests that any penalties proposed to be assessed be waived pursuant to Treas. Reg. §301.6652-3(b)(1) due to reasonable cause. For the reasons set forth above, the taxpayer respectfully requests that any penalties assessed or proposed to be assessed under Internal Revenue Code §6652(e) be abated or waived.
