Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hero Home Services 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 30, 2024, December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the four months ended April 30, 2024, and the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hero Home Services 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 30, 2024, December 31, 2023 and 2022, and for the four months ended April 30, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the Hero Home Services 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan is a defined contribution plan which was established on April 1, 2015 and last amended in January 2020. The Plan covers substantially all employees (other than nonresident aliens and employees covered by a collective bargaining agreement) of Hero Home Services (the Company) who have completed 60 days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In December 2023, the Company was acquired and the Plan was terminated. Upon termination, all participants were immediately fully vested in the benefits provided pursuant to the Plan, and the trustee of the Plan was directed to distribute the assets of the Plan to the eligible participants.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Administration

The Plan is administered by Hero Home Services and advised by a committee whose members are appointed by the Board of Directors of Hero Home Services. The Custodian of the Plan's assets is Principal Life Insurance Company (the Custodian). The Custodian executes transactions based upon direction from the Plan's administrator and the Plan's participants.

Contributions

Each year, participants may contribute, on a pre-tax or post-tax basis, up to 100% of compensation not to exceed the limits of the Internal Revenue Code (IRC), as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their account into various investment options offered by the Plan.

The Plan includes a provision for automatic salary deferrals. Absent an election otherwise, 3% of each eligible participant's compensation is contributed to the plan as an employee deferral.

The Company contributes to the Plan a safe harbor qualified non-elective contribution of 3% of all eligible participants' compensation.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Participant Accounts

Each participant's account is credited with the participant elective deferrals, the safe harbor qualified non-elective contribution and an allocation of Plan earnings and expenses. Allocations of Plan earnings are based on the valuation of the investments (participant-directed) held in each participant's account. Participants' accounts are valued on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have one loan outstanding at any point in time. Loan terms may be up to five years for general purpose loans. The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate of 2% over the Wall Street Journal Prime Rate of interest at the time of the loan. Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document. Interest rates on loans outstanding as of December 31, 2023 ranged from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their contributions and safe harbor nonelective contributions plus actual earnings thereon.

Payment of Benefits

Upon termination of employment, death, disability or reaching normal retirement age (65), participants or their beneficiary(ies), where applicable, may receive the value of the accrued vested benefit in the form of a lump sum payment; or if the balance exceeds \$5,000, may elect to defer the distribution in accordance with Plan guidelines. If the participants' vested account balance is less than \$5,000, the Plan will distribute the participant's vested account balance in a lump-sum payment.

The Plan allows for hardship withdrawals from the employee elective deferral portion, rollover portion, and the vested safe harbor qualified non-elective contribution or portions of the participant's account. The Plan does not allow for other in-service distributions of elective deferrals, employer matching contributions, employer profit sharing contributions (if any) or Plan earnings, unless age 59½ or normal retirement age has been reached. In-service distributions of rollover account balances are allowed at any time.

Benefit payments are recorded upon distribution to participants.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Administrative Expenses

The Plan or Plan Sponsor pays certain administrative expenses on behalf of the Plan. Distribution processing fees are deducted from the benefits paid to participants and are shown as plan expenses.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Reclassifications

Certain reclassifications have been made to the 2022 financial statements to conform to presentation in these financial statements. There have been no changes to net assets available for benefits as a result of the reclassification.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through December 10, 2024, the date the financial statements were available to be issued.

2. Certification of Investments

The Administrator of the Plan appointed Principal Life Insurance Company (Principal) as Custodian of the Plan's assets. Principal has supplied the Plan Administrator with certifications as to the completeness and accuracy of Plan investments aggregating \$0, \$4,357,476 and \$3,127,060 as of April 30, 2024, December 31, 2023 and 2022, respectively, and the related investment income of \$170,964 for the four months ended April 30, 2024, and \$643,775 for the year ended December 31, 2023. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule based on the certifications from Principal.

Under the terms of the Custodial agreement, the Custodian manages investment funds and executes investment transactions on behalf of the Plan. The Custodian has been granted discretionary authority concerning the purchases and sales of the investments of the investment funds.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

3. Fair Value Measurements (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Pooled Separate Accounts: Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although not based upon quoted prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Plan Termination

As discussed in Note 1, Hero Home Services, Inc. was sold effective December 15, 2023. The Plan was terminated and all balances were paid out to employees in April 2024.

5. Plan Tax Status

The prototype plan document utilized by the Plan obtained its latest IRS opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of April 30, 2024, the Plan does not believe that it has taken any tax positions that require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months.

The Plan's informational returns are subject to examination by the appropriate regulatory authorities as of April 30, 2024, and the Plan's federal informational returns generally remain open for a period of three years.

6. Risk and Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Party-in-interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Principal Life Insurance Company is the Custodian of the Plan's assets and manages Plan investment transactions; therefore, the transactions qualify as party-in-interest transactions and are indicated as such on the supplemental Schedule of Assets Held at End of Year. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

The Plan issues loans to participants, which are secured by the participant account balances. These qualify as party-in-interest transactions but are permitted under ERISA regulations. Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.
