## Independent Auditor's Report

To the Board of Trustees  
**The Foresight MEP 401(k) Plan FBO Blackrock Microsystems, LLC**

### **Opinion**

We have audited the accompanying financial statements of **The Foresight MEP 401(k) Plan FBO Blackrock Microsystems, LLC** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2022, and the changes in net assets available for benefits for the year then ended in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion on the 2022 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter – Plan Termination**

As described in Note 1 to the financial statements, the governing body of the Plan approved termination of the Plan. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

### **Emphasis of Matter – Revised Financial Statements**

In our report dated August 13, 2024, we expressed an unmodified opinion on the 2022 financial statements of the Blackrock Microsystems LLC Retirement Trust. The 2022 financial statements of the Plan have been revised to reflect the plan name as **The Foresight MEP 401(k) Plan FBO Blackrock Microsystems, LLC** to align with the plan name as shown in the Plan's Form 5500. Additionally, wording modifications have been made to the Plan Termination and Merger description in Note 1 to the financial statements, the description of the plan in Note 2 to the financial statements, and Management's Evaluation of Subsequent Events in Note 7 to the financial statements.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement

when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

**1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Foresight MEP 401(k) Plan FBO Blackrock Microsystems, LLC's (the "Plan") financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Revenue Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

**Operating Expenses**

The Plan and Plan Sponsor pay a portion of the costs of administering the plan.

**Notes Receivable from Participants**

The notes receivable from participants are valued at their outstanding balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon terms of the Plan document.

### Plan Termination and Merger

The Foresight MEP 401(k) Plan FBO Blackrock Microsystems, LLC was terminated with an effective date of December 31, 2022 at 11:59 pm and its assets were transferred to the 401(k) Simplified Flexible Plan (the “New Plan”) effective January 1, 2023 at 12:00 am. The Plan assets were liquidated December 30, 2022 and entered the New Plan when markets opened in January 2023. In accordance with generally accepted accounting principles, the Plan has changed its basis of accounting used to value plan assets from the ongoing plan basis to the liquidation basis as of December 31, 2022. The valuation of assets and liabilities is at their liquidation value.

As required by ERISA, upon Plan termination all participants were fully vested in their account balances. Termination shall not permit any part of the Plan funds to be used for or diverted to purposes other than the exclusive benefit of the beneficiaries and participants. As part of termination procedures, any unallocated net assets of the Plan were allocated to the individual participants accounts for transfer into the 401(k) Simplified Flexible Plan. Participant accounts were transferred to the New Plan in accordance with applicable laws and regulations. Participants were notified of the termination and merger and provided with information regarding their rights and options under the New Plan.

## 2. DESCRIPTION OF THE PLAN

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is an open multiple employer plan that is sponsored by Foresight Wealth Management and adopted by Blackrock Microsystems, LLC (the “Company”). The open multiple employer plan became effective January 1, 2017. However, the Company adopted the Plan effective June 1, 2020.

### General

The Plan is a defined contribution plan covering all qualified employees of Blackrock Microsystems, LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### Eligibility

Employees of the Company are eligible to participate in the Plan if they are at least 21 years of age and have completed three consecutive months of service for purposes of elective deferrals. Employees are eligible to receive employer matching contributions and non-elective contributions if the employee is at least 21 years of age and has completed three consecutive months of service. Employees are eligible to receive Safe Harbor matching contributions if the employee is at least 21 years of age and has completed three months of service with monthly entry dates.

**Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan document. Contributions are subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company provides a safe-harbor match of 100% of the matched employee contributions that are not in excess of 4% of the Plan compensation.

**Vesting**

Participants are vested immediately in their contributions and rollovers from other plans. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service determined on a calendar year.

**Participant Accounts**

Each participant's account is credited with the (a) participant's contribution, (b) allocations of the Company's contribution, and (c) allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Notes Receivable from Participants**

Participants may borrow from their accounts the lesser of (a) \$50,000 reduced by the highest outstanding loan balance of loans during the one-year period ending on the day before the new loan is made or (b) the greater of (1) or (2), reduced by (3) below: (1) One-half of the Member's Vested Account, (2) \$10,000, (3) Any outstanding loan balance on the date the new loan is made.

The amount of such loan cannot exceed 50% of the amount of the Member's Vested Account reduced by any outstanding loan balance on the date the new loan is made. The minimum amount of any loan is \$1,000 and loans are limited to 1. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes receivable from participants are exempt party-in-interest transactions.

### Benefit Payments

On termination of service, disability, retirement, or death, a participant will receive a lump-sum amount equal to the vested value of his or her account on the distribution date. This amount can be paid directly to an account of the participant's choice or rolled over to an eligible retirement plan. Under certain circumstances, including financial hardship, participants may withdraw their contributions prior to occurrence of the events. The Plan administrator determines financial hardship.

## 3. TAX STATUS

The Plan is set up as a prototype plan, which the Internal Revenue Service has advised qualifies under Section 401(k) of the Internal Revenue Code and is, therefore, exempt from federal income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan's Form 5500 remains open to examination for three years from the date filed.

## 4. INVESTMENTS

### Fair Value Measurements

FASB Accounting Standards Codification (ASC 820), *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Accordingly, when market observable data is not readily available, the Plan's own assumptions are set to reflect those that market participants would be presumed to use in pricing the asset or liability at the measurement date. Financial assets and financial liabilities recorded in the statement of net assets at fair value are categorized based on the reliability of inputs to the valuation techniques as follows:

**Level 1** – Financial assets and financial liabilities whose values are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access. Examples include prices derived from NYSE, NASDAQ, Chicago Board of Trade, and Pink Sheets.

**Level 2** – Financial assets and financial liabilities whose values are based on (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in non-active markets, or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability. Examples include matrix pricing, market corroborated pricing, and inputs such as yield curves and indices.

**Level 3** – Financial assets and financial liabilities whose values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These inputs reflect the Plan’s estimates of the assumptions that market participants would use in valuing the financial asset and financial liabilities. Examples include investment manager pricing for price placements, private equities, hedge funds, etc. The Plan uses prices and inputs that are current as of the measurement date, including during periods of market disruption. In period of market disruption, the ability to observe prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or from Level 2 to Level 3.

**6. NONEXEMPT TRANSACTIONS**

During the years ended December 31, 2022 and 2021, there were unintentional delays by the Plan sponsor in submitting participant contributions to the Plan custodian in the amount of **\$890,004** and \$477,978, respectively. Plan management calculated lost earnings and remitting amounts to participant accounts in May 2023. Subsequent to year end, it was determined that contributions were not withheld and remitted for certain employees' bonuses. The error does not appear to be pervasive; however, Plan management is in the process of determining the appropriate corrections to be made regarding this matter and the appropriate method of correction.

**7. MANAGEMENT'S EVALUATION OF SUBSEQUENT EVENTS**

Management has evaluated subsequent events through the date of the independent auditor's report, which is the date the financial statements were available to be issued. As described in Note 1, the Plan was terminated effective December 31, 2022 and assets transferred out on December 30, 2022. As the plan was terminated, there were no subsequent events that would impact this Plan.
