### 1. Description of Plan

The following brief description of The Better Business Bureau® of Metropolitan New York, Inc. Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***Plan Merger***

On December 1, 2020, the Plan entered into a merger amendment and agreement with the Better Business Bureau® of Metropolitan New York, Inc. 401(k) Plan ("Surviving Plan"). Effective December 11, 2020 ("Merger Effective Date"), substantially all assets of the Plan were legally transferred to the control of the Surviving Plan. All participants under the Plan as of the close of business on the day prior to the Merger Effective Date, who have not already commenced participation in the Surviving Plan, became participants under the Surviving Plan.

#### ***General***

The Plan is a defined-contribution plan that exists for the benefit of the employees of The Better Business Bureau® of Metropolitan New York, Inc. ("BBB" or "Employer"), which is the sponsor of the Plan. The Plan receives contributions from both employees and the Employer. The Plan's investments and activities are directed by BBB's Pension Committee. The custodian of the Plan is Union Bank and the record-keeper is Creative Plan Designs, Ltd.

#### ***Eligibility***

The Plan covers all BBB employees who have met the requirements of: (i) the minimum age of 21 years, (ii) one year of service, or 1,000 hours of service.

#### ***Contributions***

Eligible participants employed as of the last day of the Plan year receive a contribution from BBB to the Plan based on 5% of the participant's compensation, as defined by the Plan, plus 4% of the participant's compensation which is in excess of the Social Security taxable wage base for the Plan year. Each participant may voluntarily contribute to the Plan each year up to 10% of their compensation.

The Employer contributed to the Plan an amount determined by the Board of Directors based upon the year's profits. No Employer contributions were made in 2020 as a result of the Plan merger into the Surviving Plan.

## 1. Description of Plan *(continued)*

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Employer contributions, as well as allocations of Plan earnings. Allocations are based on participant account balances, as directed by the Plan. Participant accounts are charged with benefit payments and allocations of Plan earnings and administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in BBB's contribution portion of participants' accounts plus actual earnings thereon is as follows:

### ***Payment of Benefits***

Upon termination of service, the vested portion of a participant's account balance shall be distributable to the participant (or if deceased, the participant's beneficiary) within 60 days after the next valuation date following the date the participant's employment terminated. BBB contributions to the Plan become fully vested if the participant is employed as of their normal retirement date, death, or total and permanent disability. Once deemed distributable, participants may optionally elect to receive vested account balances in the form of a lump sum, or in any number of annual installments, up to a maximum of fifteen years. Unless a participant has elected one of the aforementioned distribution options, distributions shall be made at the participant's annuity starting date in the form of a life annuity if not married, or in the form of a qualified joint and survivor annuity, or a qualified optional survivor annuity, if married. The Plan does not allow for participants to take out hardship withdrawals.

### ***Forfeitures***

Forfeited nonvested accounts are used to reduce future BBB contributions. There were no forfeitures as of December 11, 2020 and \$3,777 of forfeited nonvested account balances as of December 31, 2019. All available forfeitures during the Plan year were used to reduce the prior year Employer contributions.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Presentation***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### ***Use of Estimates***

Management makes estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurement and Disclosure***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2020 and 2019, all the Plan's investments were categorized as Level 1. At December 11, 2020, substantially all of the Plan's investments were transferred, as a result of the Plan's merger into the Surviving Plan.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. The money market fund is valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open ended mutual fund that is registered with the Securities and Exchange Commission. The fund is required to publish its daily net asset value ("NAV") and to transact at that price and is deemed to be actively traded. The Plan's investments in common stocks, fixed income and treasury bills are valued at the closing price reported on the active market on which the individual securities are traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when earned. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during both the periods then ended.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### *Expenses*

Expenses incurred with the administration of the Plan are paid by the Plan and allocated to participant accounts, as defined by the Plan. Investment related expenses are included in net (depreciation) appreciation in fair value of investments.

#### *Subsequent Events Evaluation by Management*

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is June 24, 2021.

### 3. Income Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Employer by letter dated June 7, 2016, stating that the Plan is qualified under the Internal Revenue Code ("IRC") and therefore the related trust is exempt from taxation. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for any tax periods since 2017; however, there are currently no examinations in progress.

### 4. Related Party Transactions

The Plan's investments are managed by Neuberger Berman and Union Bank is the Plan custodian. Certain administrative functions are performed by BBB officers and employees (who may also be participants in the Plan), at no cost to the Plan. BBB also pays the Plan's recordkeeping, legal, and audit fees and is reimbursed for these expenses by the Plan. However, these transactions are not considered to be prohibited party-in-interest transactions, because they are covered by statutory or administrative exemptions set forth in the Internal Revenue Code ("IRC") and in ERISA.
