1. Description of Plan:

The following description of the Our Home, Inc. (Company) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of the Company who have completed one year of service and are age 18 or older. It is subject to the provisions of ERISA.

Contributions: Each year, participants may contribute pretax annual compensation up to the maximum percentage allowed not to exceed the limits of Code Section, 401(k), 402(g), 401 and 415, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are allowed to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching and profit sharing contributions are made at the discretion of the Company's board of directors. For the years ended June 30, 2024 and 2023, the Company contributed up to 5% and 3% of eligible employee compensation as a discretionary match, respectively. Additional amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain IRS limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants are vested according to the following schedule:

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant will receive a lump-sum equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

2. Summary of Significant Accounting Policies:

Forfeited Accounts: At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$11,406 and \$6, respectively. These accounts are available to pay plan expenses or are allocated to remaining participants. Plan expenses of \$4,339 and \$9,384 were paid with forfeited non-vested accounts for the years ended June 30, 2024 and 2023, respectively.

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Operating Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through December 4, 2024, the date the financial statements were available to be issued.

3. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Related-Party Transactions and Party in Interest Transactions:

Certain Plan investments are managed by Ascensus, Inc. Ascensus, Inc is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Ascensus, Inc. provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between Our Home, Inc and Ascensus, Inc. Ascensus, Inc. receives revenue from mutual fund service providers for services Ascensus, Inc. provides to the funds. This revenue is used to offset certain amounts owed to Ascensus, Inc. for its administrative services to the Plan.

If the revenue received by Ascensus, Inc. from such mutual fund service providers exceeds the amount owed under the MSA, Ascensus, Inc. remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023 there were no excess amounts. The Plan or Plan Sponsor may make payment to Ascensus, Inc. for administrative expenses not covered by revenue sharing.

Our Home, Inc. provides accounting and administrative services to the Plan for which no fees are charged.

5. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

6. Information Prepared and Certified by Trustee:

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Ascensus Trust Company, the trustee of the Plan, has certified the completeness and accuracy of all investments reported in the accompanying Statement of Net Assets Available for Benefits as of June 30, 2024 and 2023, the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of June 30, 2024, and the related investment activity reported in the statements of changes in Net Assets Available for the years ended June 30, 2024 and 2023.

7. Tax Status:

The IRS has determined and informed Ascensus, Inc. by a letter dated June 30, 2020, that the prototype plan and related trust adopted by Our Home, Inc. are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
