## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator and Management of

## Hyperform, Inc. 401(k) Profit Sharing Plan and Trust Notes to Financial Statements

### **Note 1: DESCRIPTION OF THE PLAN**

The following description of Hyperform, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Refer to Plan documents for a more complete description of Plan provisions.

#### ***General***

The Plan is a defined contribution plan covering all employees of Hyperform, Inc. (the “Company”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Directors.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Matrix Trust Company, which invests contributions and Plan earnings, makes investment transactions as directed by the participants and provides certain recordkeeping services. July Business Services acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

#### ***Eligibility***

Prior to September 30, 2021, employees could become a participant of the Plan when they completed one year of service and were age 18 or older. After September 30, 2021, employees may become a participant of the Plan when they have completed six months of service and are age 18 or older. An eligible employee may enter the Plan immediately after all entry requirements have been met.

#### ***Contributions***

Each year, participants may contribute a specified percentage or flat amount of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute Roth deferrals, subject to federal income tax as applicable. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan provides for employer ‘Safe Harbor’ qualified matching contributions. The Company adopted a Safe Harbor provision and makes qualified matching contributions of 100% of salary deferral contributions up to 3% of eligible compensation and 50% of salary deferral contributions for the next 2% of eligible compensation that a participant contributes to the Plan. The Company may make discretionary contributions as defined in the Plan. For the year ended December 31, 2021, the Company contributed \$100,866, as well as qualified non-elective contributions (QNEC) totaling \$99,623 to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

## Hyperform, Inc. 401(k) Profit Sharing Plan and Trust Notes to Financial Statements

### Note 1: DESCRIPTION OF THE PLAN (Continued)

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of (a) Company contributions, and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled to is provided from the participant's vested account.

#### ***Vesting***

Participants are vested immediately in their contributions, Safe Harbor matching contributions, qualified non-elective contributions (QNEC), plus actual earnings thereon. For employer contributions that are not Safe Harbor matching, a participant is fully vested after 6 years of credited service, based on the schedule below, or a participant becomes fully vested at death, total disability, or termination of the Plan. Vesting in the employer contributions plus earnings is based on years of service. A participant is fully vested after 6 years of credited service, based on the following schedule:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 or more years	100%

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have one loan outstanding at a time. The loans are secured by the balance in the participant's accounts and bear an interest rate of 4.25% to 6.25%. Principal and interest is paid ratably through weekly payroll deductions for a period not to exceed five years. A loan may be repaid over a time greater than 5 years if the loan is used to acquire any dwelling used as the principal residence of the participant and the loan is repaid within a reasonable time period.

#### ***Benefit Payments***

On termination of service, attainment of retirement age, disability, or death, benefits may be paid out in lump-sum or installments equal to the participant's vested interest in his or her account.

#### *Forfeitures*

At December 31, 2021 and 2020, there were no forfeited nonvested accounts. If there are any forfeitures, the balances will be used to reduce future employer contributions or pay Plan administration expenses. During fiscal year 2021, there were no amounts forfeited out of employee accounts and therefore no amounts used to pay plan expenses or reduce employer contributions.

#### *Hardship Withdrawals*

Hardship withdrawals are not permitted by the Plan.

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### *Use of Estimates*

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value, but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and the insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2021 and 2020.

#### ***Payment of Benefits***

Distributions to participants are recorded when paid.

#### ***Administrative Expenses***

Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances, unless paid by the Employer. During the year ended December 31, 2021, expenses of \$14,122 were paid by the Plan and allocated to participant accounts.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### ***Subsequent Events***

Management has evaluated subsequent events through the date that the financial statements were available to be issued, July 24, 2024, see Note 8. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

*Interest-bearing Cash:* Valued at the daily closing price.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### Note 5: TAX STATUS

The Company adopted a prototype plan and the IRS has determined and informed the Company by a letter dated March 31, 2014, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by July Business Services. July Business Services is the Trustee and record-keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan for the investment management services were \$14,122.

### Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
