Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed the audit of the accompanying financial statements of Scanline VFX L.A. Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of March 31, 2024, and the related statement of changes in net assets available for benefits for the period from September 1, 2023 through March 31, 2024, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

NOTE 1 DESCRIPTION OF PLAN

The following description of the Scanline VFX L.A. Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that was adopted by Scanline VFX L.A., Inc. (the Company), effective September 8, 2009 and most recently amended on September 1, 2023, and is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code of 1986 (IRC), as amended. The purpose of the Plan is to provide retirement benefits for substantially all employees who have completed one year of service and are age 21 or older. The Company is the Plan's Sponsor and serves as the Plan administrator. The Administrative Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Trustee.

Via Member resolution dated February 16, 2024, and effective March 4, 2024, the Company authorized the transfer to and merger into the Netflix, Inc. 401(k) Plan (the Netflix Plan) a defined contribution Plan. The Plan was frozen effective December 31, 2023 and effective January 1, 2024, the Company is a participating employer in the Netflix Plan and Plan participants are eligible to participate in the Netflix Plan.

Contributions

Participants may elect to contribute up to 100% of their pretax annual compensation not to exceed the maximum deferral limitation, as defined in the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may elect to contribute after-tax contributions to a Roth account as defined by the Plan. Each Plan year, the Company may make qualified non-elective contributions to participants' accounts in order to correct any testing or operational failures. Employer matching contributions were eliminated during the 2021 Plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants vest immediately in their contributions plus actual earnings thereon. Vesting in the Company's prior matching contribution portion of their account plus actual earnings thereon is based on years of continuous service. A participant is 20% vested each year after two years of service and is considered to be 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow against their Plan account balance within Plan guidelines. Loan terms are at the discretion of the borrower but generally cannot exceed five years. The loan amount can be a minimum of \$1,000 but cannot exceed the lesser of (a) one-half of the participant's nonforfeitable interest under the Plan or (b) \$50,000. Interest is charged on the outstanding balance at rates determined by the Plan administrator based on prevailing interest rates. Principal and interest are paid ratably through biweekly payroll deductions. The loans are secured by the vested account balance in the participant's account, and a participant can only have one outstanding loan at any time.

Benefit Payments

If a participant's employment ceases as a result of death or disability, the entire account becomes fully vested and the participant's beneficiaries or the participant is entitled to receive the contents of the account. If participation is terminated for any other reason, the participant is entitled to receive only the vested percentage of the account. Participants or their beneficiaries may elect to receive benefits in a single lump sum. If the value of the participant's account is less than \$5,000, the entire amount will be rolled into an individual retirement account on behalf of the participant or the participant's beneficiaries. Additionally, under certain circumstances of financial hardship or upon attaining the age of 59½, participants are allowed to withdraw funds from the Plan.

Forfeitures

Forfeitures of the employee's nonvested portion of the Company's contributions are used to reduce future Company's contributions or to pay administrative expenses as directed by the Company. At March 31, 2024 and August 31, 2023, there were no forfeited nonvested accounts.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. The majority of administrative expenses incurred by the Plan are absorbed by the Company, except for fees related to the administration of participant loans, which are deducted from the applicable participants' accounts.

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) on investments at fair value.

Basis of Presentation

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). References to the ASC hereafter refer to the Accounting Standards Codification established by the Financial Accounting Standards Board (FASB) as the source of authoritative U.S. GAAP.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

The Plan's investments in the general interest accumulation account are stated at contract value at August 31, 2023, as more fully described in Note 9.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains and/or losses are reported the day after the trade date.

Net realized and unrealized gains (losses) are recorded in the accompanying statement of changes in net assets available for benefits as net appreciation/depreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The process of preparing financial statements in accordance with U.S. GAAP requires the use of estimates and assumptions regarding certain types of assets, liabilities, revenues and gains, and expenses and losses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

Subsequent Events

The Plan has evaluated subsequent events through January 14, 2025, the date the financial statements were available to be issued.

NOTE 3 CONCENTRATIONS, RISKS, AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 INFORMATION PREPARED AND CERTIFIED BY AMERICAN UNITED LIFE INSURANCE COMPANY (AUL)

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at March 31, 2024 and August 31, 2023, and net appreciation/depreciation in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the period ended March 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by American United Life Insurance Company, the trustee of the Plan.

NOTE 5 WITHDRAWN PARTICIPANTS

At March 31, 2024 and August 31, 2023, there were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not been paid.

NOTE 6 TAX STATUS

The Plan is based on the Pre-Approved Non-Standardized Profit Sharing Plan with Campbell Albrecht, the recordkeeper of the Plan, which received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the prototype plan was designed in accordance with the provisions of the IRC. The Plan has not filed for its own determination letter from the IRS. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The related trust, therefore, is not subject to tax under present income tax law.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of March 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Some of the investments in are managed by AUL, the trustee as defined by the Plan, and therefore, these investments qualify as party-in-interest transactions. Notes receivable from participants represent loans to employees; therefore, they also qualify as party-in-interest transactions. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

NOTE 8 FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

NOTE 9 GENERAL INTEREST CONTRACT WITH INSURANCE COMPANY

In 2010, the Plan entered into a general interest contract with American United Life Insurance Company (AUL). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer has determined that the account is liquid and a cash equivalent.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At March 31, 2024 and August 31, 2023, the contract value of the guaranteed investment contract totaled \$- and \$445,071, respectively.

The crediting interest rate is based on a formula agreed upon with the issuer, which the issuer declares from time to time, at a rate at least equal to the greater of (1) any contractual minimum guarantee provided by the contract or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (NAIC) standard nonforfeiture law.

NOTE 9 GENERAL INTEREST CONTRACT WITH INSURANCE COMPANY (CONTINUED)

The minimum rate is determined in accordance with a formula, and cannot be less than 1.00% or more than 3.00% in any event. AUL determines whether the application of the formula will change the minimum guaranteed rate each year, and any change is effective the following January 1 for that calendar year.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and to settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

During 2024, as a result of the Plan's merger disclosed in Note 1, certain liquidation events limited the Plan's ability to transact at contract value with the contract and with the participants, thus the Company funded the difference as part of the merger transaction and made the impacted participants whole.

NOTE 10 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the short plan year ended March 31, 2024, to satisfy certain non-discrimination tests there was an employer qualified nonelective contribution totaling \$7,450 receivable to the Plan. As a result of the Plan merger that occurred on March 4, 2024, the Plan financial statements further reflect the transaction as a transfer payable. The presentation of the net assets available for benefits per the financial statements for the period ended March 31, 2024 nets to zero, and the net impact reconciles to the changes in net assets available per the Plan's Form 5500.

NOTE 11 PLAN MERGER

Via Member resolution dated February 16, 2024, and effective March 4, 2024, the Company authorized the transfer to and merger into the Netflix, Inc. 401(k) Plan (the Netflix Plan) a defined contribution Plan. The Plan was frozen effective December 31, 2023 and effective January 1, 2024, the Company is a participating employer in the Netflix Plan and Plan participants are eligible to participate in the Netflix Plan. Accordingly, all assets have been transferred to the Netflix Plan as of March 31, 2024.



