As discussed in Note 1 to the financial statements, effective April 3, 2024, the management of OrthoWest, P.C., the Plan Sponsor, approved a resolution to merge the Plan into the Nebraska Orthopaedic Hospital Retirement Savings Plan and the combined plan was re-named the OrthoNebraska 401(k) Plan. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

1. Plan Description

The following brief description of the OrthoWest, P.C. 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provided retirement benefits for the employees of OrthoWest, P.C. (the Company).

Effective April 3, 2024, the Company approved a resolution to merge the Plan into the Nebraska Orthopaedic Hospital Retirement Savings Plan and the combined plan was re-named the OrthoNebraska 401(k) Plan (the OrthoNebraska Plan). Empower Trust Company, LLC (Empower) is the custodian of the OrthoNebraska Plan. The merger into the OrthoNebraska Plan initiated a "blackout" period which initiated on April 3, 2024 and went through April 29, 2024. During the blackout period, funds could not be applied to the employee selected funds or withdrawn from the Plan or the OrthoNebraska Plan until Empower had time to accurately complete the merger. Participants began making payroll contributions to the OrthoNebraska Plan in April 2024. Finally, Plan assets totaling \$53,532,054 were transferred into the OrthoNebraska Plan in April 2024.

Employees were eligible to make salary deferral contributions and to receive safe harbor matching contributions upon hire date. Employees were eligible to receive discretionary matching contributions after one year of service and upon completion of 1,000 hours of service in a Plan year. Employees were eligible to receive annual discretionary profit-sharing contributions if they had one year of service, had completed 1,000 hours of service during the specific Plan year and were employed on the last day of the Plan year.

Contributions

Participants could make pre-tax and designated after-tax Roth salary deferral contributions up to 75% of their annual eligible compensation as defined by the Plan, up to the maximum dollar limit allowable by law. Participants who were hired after January 1, 2019 were automatically enrolled with an initial 5% salary deferral contribution. At any time, a participant could elect not to contribute or could increase or decrease his or her deferral rate as allowed under Plan provisions. Participants could also contribute amounts representing distributions from other qualified plans. The Plan was a "safe harbor 401(k) plan," whereby the Company was required to make safe harbor matching contributions equal to 100% of each participant's elective deferral up to 3% of eligible compensation, plus 50% of the next 2% of eligible compensation. The Company could also make discretionary matching and profit-sharing contributions. Participants who were eligible to make deferral contributions and who would attain age 50 before the close of the calendar year were eligible to make catch-up contributions. Contributions were subject to certain limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution and an allocation of a) the Company's safe harbor matching contributions, b) the Company's discretionary matching and profit-sharing contributions, and c) Plan earnings and losses. The Company's safe harbor matching contributions and discretionary matching contributions were allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit-sharing contributions were allocated based on the eligible compensation of participants. Plan earnings or losses were allocated on the basis of actual results of the investments selected by each participant. Investments were maintained in individual member accounts managed by Empower.

Vesting

Participants were vested immediately in their participant contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions credited to participants' accounts was based on years of continuous service. A participant was 20% vested after two years of credited service, and vesting increased 20% per year until a participant was 100% vested after six years of credited service.

Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at rates set at 1% over the prime rate published in the Wall Street Journal on the first business day of the month before the loan was originated. Principal and interest was paid through payroll deductions and terms of payments could vary from 12 months to 60 months.

Payment of Benefits

Upon death, termination, retirement, or disability, the participants or beneficiary could elect to receive lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan required that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant did not elect otherwise. Distributions under \$1,000 were paid out to the participant in the event the participant did not elect a payout option. Participants could also receive hardship and in-service distributions, as permitted in the Plan document. Benefits were recorded when paid.

Forfeitures

Upon a participants' termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested were forfeited. The forfeited portion of any participant's account could be used to reduce Company contributions or to pay reasonable Plan expenses. As of April 30, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$33,781, respectively. During the period from January 1, 2024 to April 30, 2024, forfeitures of \$7,045 and \$0 were used to reduce safe harbor matching contributions and to pay Plan expenses, respectively. During the year ended December 31, 2023, forfeitures of \$14,576 and \$514 were used to reduce safe harbor matching contributions and to pay Plan expenses, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to buy or sell an investment in an orderly transaction between market participants at the measurement date. The Company determined the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes were reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Other reasonable expenses of administration, including investment related expenses and recordkeeping expenses, were paid from assets of the Plan and were included in administrative expenses.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through January 14, 2025, noting no items requiring disclosure.

3. Information Certified by Empower

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower, except for comparing such information certified by the custodian to information included in the Plan's financial statements.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurement and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of April 30, 2024 and December 31, 2023.

Money Market and Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trusts: Valued at NAV based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement and Disclosures*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that these funds meet those requirements. Were the Plan to initiate a full redemption of the applicable collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-Directed Brokerage Account: Valued at the NAV of its underlying investments. These accounts hold mutual funds and common stocks that have publicly quoted pricing inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan investments as of April 30, 2024.

5. Tax Status

The Plan was qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and was exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan was designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator had analyzed the tax positions taken by the Plan and had concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

6. Related Party Transactions

Certain Plan assets were investments in a self-directed brokerage account managed by Empower. Empower was the custodian of the Plan; therefore, these transactions qualified as party-in-interest transactions.
