Notes to Financial Statements

Note 1: Description of Plan

The following description of the Healthcare Resource Group, Inc. Employee Stock Ownership Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The plan was terminated effective February 28, 2022 and liquidated and closed as of March 31, 2024.

General

Healthcare Resource Group, Inc. (the "Company") established the Healthcare Resource Group, Inc. Employee Stock Ownership Plan and Trust effective January 1, 2005. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by an Employee Benefits Administration Committee, which is approved by the Plan's Board of Directors.

Eligibility

Eligible employees include all regular full-time employees of the Plan, who are not covered under a collective bargaining agreement, who are not nonresident aliens, and who work 1,000 or more hours annually. Employees are eligible to participate in the plan following the completion of one year of service.

Contributions

The Company contributes a discretionary percentage of eligible compensation to each eligible participant. The discretionary contribution is approved annually by the board of directors. During the period ended March 31, 2024, the Company made no discretionary contributions as the Plan was terminated effective February 28, 2022. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the trustees and from the account holding forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation relative to total eligible compensation. Net earnings and losses from the Plan's investments, except common stock of the Company, are allocated to each participant's account based on the ratio that participant's account bears to the total of all participants' account balances, as of the beginning of the Plan year. Net earnings and losses from the investment in common stock of the Company, including unrealized appreciation and depreciation in fair value, are allocated to each participant's account based on the actual number of shares of common stock allocated thereto.

Employer Stock Voting Rights, Put & Diversification

Under Federal Income tax regulations, employer stock is held by the Plan and participants and is not readily tradeable on an established market must include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase, with interest, over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

The Trustees of the Plan will vote all Company stock held as a part of the Plan assets, provided that the participants or beneficiaries will be entitled to direct the Trustee as to the manner in which voting rights on shares of Company stock which are allocated to their account are to be exercised (a) with respect to any corporate matter which involves the voting of such shares with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction, and (b) with respect to all corporate matters if, at the time of the vote thereon, the Company stock is a "registration-type" class of securities. If the participant or beneficiary does not timely exercise their right to vote Company stock, the Trustee will vote such Company stock.

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of their investment in Company stock into investments which are more diversified. Participants who are at least 55 may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to their account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution.

Vesting

Plan contributions vest according to the following schedule:

A participant's account shall fully vest upon death, disability, or attainment of age 62. Effective February 28, 2022, the Plan was terminated and began liquidation of participant account balances. Participants became 100% vested in their Plan contributions.

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period, not exceeding five years, as determined by the Company. Upon a participant's termination date, the participant or their beneficiary will be entitled to receive payment from the participant's ESOP account, based on the value of the participants vested percentage. The value of a participant's ESOP account will be based on the value in their account as of the end of the Plan year prior to the date of payment. Upon termination of service, a participant will receive a lump-sum distribution of their account balance, without the participant's consent, if their vested balance does not exceed \$5,000. Such distributions are generally made in the year following the fifth year of separation from the Company.

Forfeitures

Company common stock allocations and Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. During 2024, no forfeitures were reallocated to remaining participants' accounts. There were no balances in forfeited, nonvested accounts at March 31, 2024 and December 31, 2023.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

As discussed in Note 1, the Plan was terminated effective February 28, 2022. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the Plan changed its basis of accounting from the ongoing basis to the liquidation basis. The change to the liquidation basis had no material impact on the accompanying financial statements.

Cash Equivalents

The Plan considers all highly liquid investments with original maturities of three months or less, including money market fund investments, to be cash equivalents.

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value.

Purchases and sales of securities are recorded on a trade-date basis. The net change in fair value of the Company's common stock consists of both the realized gains or losses and unrealized appreciation and depreciation of the Company common stock.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company pays the administrative expenses of the Plan.

Subsequent Events

The Plan has evaluated subsequent events through January 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Tax Status

The IRS has determined and informed the Plan by a letter dated September 8, 2015, the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The plan administrator is not aware of any significant uncertain tax positions taken by the Plan. In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions however, there are currently no audits for any tax periods in progress.

Note 4: Investments in Company Stock

There were no nonparticipant-directed investments as of March 31, 2024 and December 31, 2023, as the Plan was terminated effective February 28, 2022.

Note 5: Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments held at March 31, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the period ended March 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by GreatBanc Trust Company, Trustee of the Plan .

Note 6: Related-Party Transactions and Party-in-Interest Transactions

The Plan's assets are held by the Plan Trustees. The Plan Trustees have designated Principal Trust Company as the custodian of all contributions. GreatBanc is a party in interest and held funds to the period ended March 31, 2024.

Company contributions are held and managed by the custodian, who invests cash received, interest and dividend income and makes distributions to participants.

Note 7: Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Plan Termination

Effective February 28, 2022, the Plan was terminated and began liquidation of participant account balances. Participants have become 100% vested in their Plan contributions. On March 7, 2024, the Plan distributed 100% of all funds.

Note 9: Concentration of Credit Risk

The Company maintains cash in a money market account at one financial institution. The balance, at times, may exceed federally insured limits. The Company exceeded the insured limit by approximately \$0 at March 31, 2024 and \$14,235,049 at December 31, 2023.
