NOTES TO FINANCIAL STATEMENTS

AS OF APRIL 5, 2021 AND DECEMBER 31, 2020 AND FOR THE PERIOD JANUARY 1, 2021 THROUGH APRIL 5, 2021 AND YEAR ENDED DECEMBER 31, 2020

1. DESCRIPTION OF PLAN

The following description of the Gilcrest-Jewett Lumber Company Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General—The Plan is a defined contribution 401(k) and profit sharing plan covering substantially all full-time employees of Gilcrest Jewett Lumber Company (the "Company") who have attained the age of 21 and have completed one year of service with at least 1,000 hours of service by the end of such period. The Company controls and manages the operation and administration of the Plan. The insurance company of the Plan is Standard Insurance Company ("The Standard"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As of the close of business on December 31, 2020, the Company was acquired by US LBM Holdings, LLC, a leading distributor of specialty building materials in the United States. The Company operates as a wholly-owned subsidiary of US LBM Holdings, LLC and continues as the Plan sponsor for the Plan.

Effective April 5, 2021, the Plan was merged with the US LBM Holdings, LLC 401(K) Plan. All net assets and participant account balances were transferred into the US LBM Holdings, LLC 401 (K) Plan. The US LBM Holdings, LLC 401(K) Plan custodian and recordkeeper is Transamerica. Consistent with the Plan's merger arrangement, participant contributions into the US LBM Holdings, LLC 401(K) Plan began with the pay period ended April 16, 2021.

Contributions—Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, (iii) discretionary contributions made by the Company, and (iv) participant rollovers from another plan. Each year, participants may contribute up to 100% of their annual wages to the Plan, subject to certain Internal Revenue Code (IRC) limitations. The Company contributes 50% of the first 4% of wages that a participant contributes. In addition, the Company may declare additional discretionary contributions from its current or accumulated earnings. The Company declared an additional discretionary contribution in 2020 of \$213,362. No additional discretionary contribution was declared in 2021.

Participant Accounts—Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's matching contributions, an allocation of the Company's discretionary contributions and Plan earnings, and charged with withdrawals, an allocation of Plan losses, and administrative expenses. Allocations are based upon participant wages or account balances, as defined by

the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants direct the investment of their contributions and employer contributions into any combination of the investment alternatives offered by the Plan in multiples of one percent. Plan participants may transfer funds from one investment fund to another. Transfers are effective the day made or the next business day.

Vesting—Participants are immediately vested in their contributions and earnings (losses) thereon. Participants vest in employer contributions and actual earnings (losses) thereon at the rate of 20% after completion of two years of service and 20% for each year of service thereafter. Participants become fully vested after six years of service. All participants' original entry date and accrued vesting carried over when the Plan merged into the US LBM Holdings, LLC 401(K) Plan.

Participant Loans—The Plan does not allow loans to participants.

Payment of Benefits—Upon a participant's termination from the Plan, the participant may elect to receive either a lump sum payment equal to the vested value of his or her account, or installment payments over various periods as elected by the participant. The nonvested amounts are forfeited by the terminated participant.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Forfeited Accounts—At April 5, 2021 and December 31, 2020, forfeited nonvested accounts totaled \$- and \$24,285, respectively. These accounts were used to reduce future employer contributions. Forfeited amounts used to reduce employer contributions during the period January 1, 2021 through April 5, 2021 and the year ended December 31, 2020, amounted to \$24,567 and \$5,943, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan utilizes various investment instruments, including pooled separate accounts and a guaranteed investment contract (GIC). Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value except for the fully benefit-responsive GIC which is reported at contract value which approximates fair value. Units of separate accounts are stated at fair value, as determined by the issuer of the separate accounts based on the fair market value of the underlying investments. The Plan utilizes the net asset value (NAV) as provided by the issuer to value each investment. Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 8).

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as investments held during the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Asset Valuation Techniques—Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at April 5, 2021 and December 31, 2020.

Pooled Separate Accounts—Investments in separate accounts are valued at the NAV of units of the underlying fund. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the underlying assets, the insurance company reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. As the practical expedient is utilized, these funds are not included in the fair value leveling table.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan as provided in the Plan document.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at April 5, 2021 and December 31, 2020.

Excess Contributions Payable—The Plan is required to return contributions received during the Plan year in excess of the IRC limits. At April 5, 2021 and December 31, 2020, there were no amounts payable to participants.

CARES Act—On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security (CARES) Act was passed by Congress. The CARES Act provided immediate and temporary relief for retirement plan sponsors and participants with respect to employer contributions

and distributions. Plan management evaluated the relief provisions available to Plan participants under the CARES Act and implemented the following provisions:

Coronavirus-related distribution—Participants may take a coronavirus-related distribution of up to \$100,000 from their retirement plan without a 10% early withdrawal penalty. Eligible distributions can be taken up to December 31, 2020. Coronavirus-related distributions may be repaid within three years.

Required minimum distributions (RMDs)—RMDs were temporarily suspended for 2020.

Subsequent Events—Subsequent events related to the financial statements have been evaluated through February 22, 2023, which is the date the financial statements were available to be issued. Other than those events discussed in Note 1 and Note 6, the Plan has determined that there are no events that required adjustment to, or disclosure in, these financial statements.

3. INFORMATION CERTIFIED BY THE INSURANCE COMPANY

The following is a summary of the unaudited information regarding the Plan as of and for the period January 1, 2021 through April 5, 2021 and as of and for the year ended December 31, 2020, included in the Plan’s financial statements, that was prepared by or derived from information prepared by The Standard, the insurance company, and furnished to the plan administrator. The plan administrator has obtained certifications from the insurance company that such information is complete and accurate.

4. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Substantially all Plan investments are shares of several pooled separate accounts and a guaranteed investment contract managed by The Standard. The Standard is the insurance company as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each of these funds.

5. PLAN TERMINATION

The Company has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

6. FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by The Standard. The Standard received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2014, which states that the prototype plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Subsequent to April 5, 2021, a one-time Qualified Non-Elective Contribution ("QNEC") in the amount of \$62,211 was made to participants of the Plan due to identified missed deferral opportunities in connection with the Plan's merger into the US LBM Holdings, LLC 401(K) Plan. The QNEC was deposited into affected participants' accounts in the US LBM Holdings, LLC 401(K) Plan on February 6, 2023.

7. NET ASSET VALUE PER SHARE

The following tables set forth a summary of the Plan's investments whose fair value is estimated using the NAV per share as of April 5, 2021 and December 31, 2020.

* Pooled separate accounts have underlying equity, fixed income, real estate, and cash equivalent investments that seek to replicate the movements of an index of a specific financial market. The fair values of the pooled separate accounts have been estimated using the NAV of the investment.

8. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan held a traditional investment contract. This contract met the fully benefit-responsive investment contract criteria and therefore is reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. As of December 31, 2020, the contract value for the investment contract held by the Plan was \$2,352,798. No such contracts were held by the Plan as of April 5, 2021.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than four percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. If the Plan sponsor views the occurrence of any of these events as probable as of the measurement date, details about market value adjustments or other withdrawal restrictions can be obtained through the Plan's account manager.

As of December 31, 2020, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. The Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, Plan disqualification, and failure to adopt the Plan in a reasonable period of time. Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.
