I am writing to you on behalf of Jeffrey L. Burtch, Chapter 7 Trustee for the Bankruptcy Estate of Sunworks, Inc. (the “Debtor”).

I am attaching this letter to the 2023 or 2024 (as the case may be) Forms 5500 for the ASAP, Inc. 401(k) Profit Sharing Plan (the “Plan”). This letter is in place of an Independent Qualified Public Accountant’s (“IQPA Report”) and its purpose is to explain why there is no IQPA Report attached to the 2023 Form 5500 and why none will be attached to the 2024 Form 5500.

On February 5, 2024, the Plan Sponsor filed a petition for protection under Chapter 7 of the United States Bankruptcy Code and Jeffrey L. Burtch was appointed as the Chapter 7 Trustee (“Chapter 7 Trustee”). All of the Debtor’s employees were terminated on or before February 5, 2024.

As you likely know, since a 401(k) plan is not an asset of the Chapter 7 Estate, Estate assets cannot be used to pay the expenses of administering the plan. Thus, the only source for the payment of plan expenses are the plan’s assets. Nonetheless, the Chapter 7 Trustee is working with the Plan’s recordkeeper, Farmer & Betts and the custodian John Hancock to perform the final non-discrimination testing for 2024, ensure that all employee contributions have been paid to the Plan and to wrap up the Plan.

As the attached 2023 Form 5500 shows, there was \$5,923,757 in the Plan as of December 31, 2023. There were 807 participants in the Plan as of January 1, 2023 (401 with account balances). Thus, an audit is otherwise required for 2023. There will also be an audit

otherwise required for 2024 because on January 1, 2024, there were approximately 401 participants with account balances in the Plan as of 12/31/2023.

Thus, two audits would be required as part of the Plan's wrap up. There is \$5,923,757 in the Plan. The Plan audits cost \$30,000 - \$50,000 per year. The cost of audits for 2023 and 2024 represents approximately 1.7% of the Plan's assets or approximately \$250 for each participant in the Plan. Given the substantial cost of the audits, the Chapter 7 Trustee and the fact that the Plan was properly administered continuously pre- and post-bankruptcy by Nexus and John Hancock, the Chapter 7 Trustee believes that foregoing the 2023 and 2024 IQPA Reports would be in the best interest of the Plan participants.

The Chapter 7 Trustee undertook to ensure that the Plan was administered properly and all participants will received all of the benefits to which they were entitled. The Chapter 7 Trustee determined that all employee deferrals were timely contributed to the Plan, required nondiscrimination testing was completed. All benefits will either distributed as directed by the participants or rolled over into cash out IRAs after a diligent search for the participants who do not respond to the distribution notices.

Accordingly, we request that the attached 2023 or 2024 (as the case may be) Form 5500 for the Plan be accepted as filed without the IQPA Report.
