***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Emphasis of Matters – Transfer of Assets***

As further discussed in Note 1 to the financial statements, during 2023, Collaborative Care Holdings, LLC, a subsidiary of UnitedHealth Group, acquired the Plan sponsor Crystal Run Healthcare Physicians LLP. Due to this acquisition, the Plan was amended and frozen effective December 31, 2023.

On February 25, 2024, a plan merger agreement was signed and the Plan transferred the majority of its assets into the OptumCare 401(k) Retirement Plan and the UnitedHealth Group 401(k) Savings Plan on February 28, 2024. The remaining assets were transferred on April 17, 2024. Therefore, the Plan ceased to exist as of this date.

Our opinion is not modified with respect to the aforementioned matters.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ## 1. Plan Description

The following description of the Crystal Run Healthcare Physicians LLP Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the summary Plan description or the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan, as defined under section 401(k) of the Internal Revenue Code ("IRC"), covering certain employees of Crystal Run Healthcare Physicians LLP (the "Organization") and its participating affiliates (together, the "Employer") who have one year of eligible service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

During 2023, Collaborative Care Holdings, LLC, a subsidiary of UnitedHealth Group, acquired the Plan sponsor Crystal Run Healthcare Physicians LLP. Due to this acquisition, the Plan was amended and frozen effective December 31, 2023. After this date, the Employer and Participants may not contribute to the Plan, except for the 2023 employer matching contribution, and otherwise Eligible Employees may not become Participants. All existing account balances will become fully vested as of the effective date of the freeze.

On February 25, 2024, a plan merger agreement was signed and the Plan transferred \$186,822,023 of its assets into the OptumCare 401(k) Retirement Plan and \$5,189,152 of its assets to the UnitedHealth Group 401(k) Savings Plan on February 28, 2024. The remaining assets of \$22,770 were transferred to the OptumCare 401(k) Retirement Plan on April 17, 2024. Therefore, the Plan ceased to exist as of this date.

### **Contributions**

Prior to the Plan being frozen, participants could elect to have a percentage or specified dollar amount deducted from their compensation as defined by the Plan. Participant contributions could be deducted in "pretax" dollars for the 401(k) and "post-tax" dollars for the Roth 401(k). Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. A participant could elect to increase, decrease or suspend deductions according to procedures established by the Organization. There was an annual limit as to the amount that could be deducted from compensation that was determined by the IRC. Participants could also contribute amounts representing distributions from other qualified plans.

Prior to the Plan being frozen, the Plan contained an automatic enrollment provision and an automatic escalator provision. Employees were automatically enrolled in the Plan once they became eligible to participate in the Plan at a rate of 3% of employee compensation, as defined by the Plan. The automatic escalator provision increased employee deferrals at the rate of 1% on an annual basis up to a maximum 10% deferral rate. Employees had the ability to opt out of both the automatic enrollment and the automatic escalator provisions.

Prior to the Plan being frozen, the Organization could make an employer matching contribution or employer non-elective contribution at its discretion.

**1. Plan Description (*continued*)**

***Participant Accounts***

Each participant's account was credited with the participant's contribution and allocations of the Organization's contribution and Plan earnings, and charged with an allocation of administrative expenses, if applicable. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Prior to the Plan being frozen, vesting in the Employer contribution portion of their account was based on years of continuous service. A participant was 100% vested after six years of continuous service in annual increments of 20%.

***Forfeitures***

If a participant terminated their employment with the Employer, the non-vested contributions plus allocated earnings thereon could be used to reduce aggregate future Employer contributions and administrative expenses or could be allocated to all Plan participants. At April 17, 2024 and December 31, 2023, the forfeited nonvested accounts totaled \$0 and \$14,683. For the period from January 1, 2024 to April 17, 2024, employer contributions and certain administrative expenses were reduced by \$14,631 and \$379, respectively, from forfeiture accounts.

***Plan Revenue Credit Account***

The Plan and trustee entered into a service based pricing arrangement whereby a portion of the revenue earned by the trustee is passed through to the Plan for payment of permitted Plan expenses. The Plan Revenue Credit Account is an account within the Plan, similar in design to forfeiture accounts. The Plan Revenue Credit Account balance was \$0 and \$17,915 at April 17, 2024 and December 31, 2023. During 2024, \$38,874 of administrative expenses were reduced by the Plan Credit Account and there were no employer contributions reduced from the Plan Revenue Credit Account. During 2024, \$17,407 was included as part of the transfer to the OptumCare 401(k) Retirement Plan to reduce future OptumCare 401(k) Retirement Plan expenses.

***Notes Receivable from Participants***

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the participant's vested account balance and bore interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Loan repayments were made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan were used to purchase the participant's principal residence, in which case the term are not to exceed 25 years.

**1. Plan Description (*continued*)**

***Withdrawals and Benefit Payments***

On termination of service due to death, disability or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a specified period of time, not to exceed life expectancy or partial payments. The Plan made involuntary cash outs of account balances of terminated vested participants of \$1,000 or less. In addition, eligible rollover distributions of account balances greater than \$1,000 but not greater than \$5,000 were subject to the automatic rollover requirements.

Upon reaching age 59½, participants could elect distributions from their accounts without any tax penalty in accordance with the IRC. Under the terms of the Plan, a participant could make a withdrawal for reasons of economic hardship.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

***Investment Valuation and Income Recognition***

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price and are deemed actively traded. The common/collective trust is valued at the NAV, as provided by the trustee of the fund, which is used as a practical expedient based on the fund's underlying investments. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the NAV per share as a practical expedient are not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition (continued)***

The cash reserve account is a fund that seeks to maintain its NAV at \$1.00 per share by investing in a broad range of money market instruments.

Purchases and sales of investments are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

***Expenses***

Certain administrative expenses of the Plan are paid by the Plan. The Organization pays all costs associated with general consulting and financial statement preparation. Investment related expenses are included in net appreciation in fair value of investments.

***Benefit Payments***

Benefits are recorded when paid.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is December 30, 2024.

**5. Common/Collective Trust**

The Reliance Trust Company Stable Value Fund (the "Fund") was formed for the purpose of allowing plan sponsors of defined contribution plans qualified under Sections 401(a) and 501(a) of the IRC to invest in the MetLife Group Annuity Contract 25053 and MetLife Group Annuity Contract 3700. Effective beginning February 23, 2023, the Fund also invests in MetLife Group Annuity Contract 37001. For the period ended April 17, 2024, the Fund was invested in the MetLife Group Annuity Contract 251757. These contracts were issued by Metropolitan Life Insurance Company. The primary investment objective of the Fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments.

Units of the Fund are valued daily. Unit purchases and redemptions are transacted at the NAV determined as of the close of business each day. The NAV per unit is computed by dividing the total net assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values.

At December 31, 2023, the Fund represented approximately 8% of the Plan's net assets available for benefits. At December 31, 2023 common collective trusts could be redeemed daily with no notice period and the Fund had no unfunded commitments.

**6. Party-in-Interest Transactions**

Certain Plan investments are managed by State Street Bank & Trust Co. State Street Bank & Trust Co. is the trustee and Transamerica Retirement Solutions, LLC is the record keeper as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

**7. Tax Status**

On June 30, 2020, the Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan that indicated the Plan, as then designed, was in compliance with applicable requirements of the IRC. The plan sponsor timely adopted the prototype plan. The plan sponsor believes that the Plan, as amended, is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.
