Opinion

We have audited the financial statements of Sapp Bros., Inc. Voluntary Employee Beneficiary Association Trust Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits in liquidation (cash basis) and of plan's benefit obligations in liquidation as of March 31, 2024 and 2023, and the related statements of changes in net assets available for benefits in liquidation (cash basis) and of changes in plan's benefit obligations in liquidation for the years then ended, and the related notes to the financial statements (collectively, the financial statements).

Basis for Opinion

In accordance with the cash basis of accounting, the plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements

Note 1—Summary of Significant Accounting Policies

A summary of significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

History

The Sapp Bros., Inc. Voluntary Employee Beneficiary Association Trust Plan (the Plan) was formed under an agreement effective April 1, 1990 by Sapp Bros., Inc. (the Corporation), the employer. The current plan was restated as of April 1, 2020, to incorporate all prior amendments, and is intended to comply with all applicable requirements of the Patient Protection and Affordable Care Act, ERISA, and other federal regulations. Management feels that the restated plan requirements have a minimal effect on the financial statements.

Cash Basis of Accounting

The Plan's accounts are maintained on the cash basis of accounting. Consequently, the statement of changes in net assets available for benefits in liquidation reflects only cash received and disbursed. Therefore, receivables and payables and accrued income and expenses which may be material in amount, are not reflected in the accompanying statement of net assets available for benefits in liquidation and changes in net assets available for benefits in liquidation. The statements are not intended to present the net assets available for benefits in liquidation or changes in net assets available for benefits in liquidation in conformity with generally accepted accounting principles.

Estimates

The presentation of financial statements in conformity with the cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2—Plan Description

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides health, dental and death benefits covering substantially all employees of the Corporation and its subsidiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Plan provides health and dental benefits including hospital, surgical, major medical and prescription drug expenses covering employees of the Corporation working greater than 30 hours per week and employed for at least 60 days. The Plan also provides health benefits to qualified dependents. For employees, or dependents of employees, coverage may be continued after termination of coverage according to rules established under the Consolidated Omnibus Budget Reconciliation Act of 1985, as amended. The Plan provides death benefits to all eligible employees. Death benefits are not provided to qualified dependents.

Note 2—Plan Description (Continued)

The Medicare Prescription Drug Improvement and Modernization Act of 2003 has no effect on the Plan. The changes in plan's benefit obligations in liquidation have not been adjusted for an amount associated with the subsidy as the plan is not directly entitled to such. The Corporation is not able to make a determination if the plan's benefits are actually equivalent to Medicare Part D.1.

Plan Benefit Obligations

Plan benefit obligations in liquidation at March 31 for health and dental claims incurred by active participants but not reported at that date are based on actual amounts reported subsequent to the plan year end. Management estimates that there are no other material claims outstanding.

Contributions

The Plan agreement provides that the Corporation make periodic contributions to the Plan to provide benefits for employees. The employer's contribution rate is determined annually, based on individual member units, by the Plan's administrator. Certain employee contributions are allowed under provisions of the plan and are determined periodically by the Corporation. The employee contributions are made through payroll withholdings. In addition, the Corporation has entered into a contract with an insurance carrier for an excess loss insurance policy. Through March 31, 2024, the deductible is \$200,000 per covered person for the plan year, and the re-insurer is obligated for amounts in excess of the \$200,000 with an unlimited maximum specific benefit per lifetime.

Administrative Expenses

Administrative expenses include fees paid to the third-party administrator for claims processing services.

Plan Amendments

Effective April 1, 2022, amendments were added which clarify certain definitions and increase various benefits to participants in order to comply with criteria of the Affordable Care Act. Management believes that the Plan as amended is operating in accordance with the Affordable Care Act.

Termination

On April 1, 2023, the Corporation determined the Sapp Bros., Inc. Voluntary Employee Beneficiary Association Trust Plan would be terminated. Management used all previous contributions held within the Voluntary Employee Beneficiary Association (VEBA) Trust account for plan benefits arising from claims occurring before such determination and provided similar coverage until all contributions were exhausted. As of January 26, 2024, the VEBA trust account was \$0 and was closed. Plan benefits for the remainder of the plan year were funded from the general assets of the Corporation.

Effective April 1, 2024 all benefits provided by the Sapp Bros., Inc. Voluntary Employee Beneficiary Association Trust Plan were spun off into the Sapp Bros., Inc. Health and Welfare Plan. The Sapp Bros., Inc. Health and Welfare Plan will be funded from the general assets of the Corporation.

Notes to Financial Statements

Note 3—Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code as a tax exempt organization. The Plan obtained its latest determination letter on April 15, 1992, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been restated and amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe the Plan is qualified and the related Trust is tax-exempt. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan's Forms 990, Return of Organization Exempt from Income Tax for the years ended March 31, 2022 through 2024 are subject to examination by the Internal Revenue Service, generally for three years after they were filed.

Note 4—Concentration of Credit Risk

The Plan had cash deposits at a financial institution in excess of the amount insured by the Federal Deposit Insurance Corporation (FDIC) of \$0 and \$3,962,334 as of March 31, 2024 and 2023, respectively.

Note 5—Claims Recoveries

Medical claims are net of stop-loss and other recoveries of \$58,595 and \$599,528 for the years ended March 31, 2024 and 2023, respectively.

Note 6—Subsequent Events

Management has evaluated subsequent events through January 15, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. Except for the previous termination disclosure in Note 2, there were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.
