Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the SPM Marketing & Communications 401(K) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 28, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits for the period ended March 28, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. (1) Description of plan

The following description of the SPM Marketing & Communications 401(K) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of SPM Marketing & Communications, LLC (the "Plan Sponsor") and the participating employers (collectively the "Employers"). The Plan covers substantially all employees who are age twenty-one or older and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2023, the Dreamscape Marketing, LLC 401(k) Plan and General Learning Communications 401(k) Retirement Plan merged into the Plan, and net assets in the amount of \$1,118,658 and \$3,273,364, respectively, were transferred into the Plan.

Effective November 9, 2023, the Plan Sponsor was acquired by Unlock Health, and in connection therewith, the Plan merged into the Unlock Health 401(k) Plan ("Unlock Plan"). Effective January 1, 2024, the Plan was closed to new participants and no additional contributions were allowed. On March 28, 2024, all account balances and Plan assets were transferred to the Unlock Plan.

(b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). The Plan also allows participants to contribute after-tax dollars to the Plan using a Roth 401(k) feature. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions are permitted up to 100% of compensation, subject to certain IRC limits.

Employees are automatically enrolled in the Plan with deferrals of 6% of compensation unless the employee makes a different affirmative election upon enrollment.

The Plan Sponsor makes safe harbor nonelective contributions to the Plan equal to 100% of the amount of the eligible participant's elective deferrals (including catch-up contributions) up to the first 3% of plan compensation each year.

The Plan also provides that the Plan Sponsor may contribute each year an additional nonelective employer contribution as authorized by the Plan Sponsor to participants. However, an additional nonelective employer contribution is not required and was not made during 2023.

Plan Sponsor contributions may not exceed the maximum amount allowed for federal income tax purposes.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings (losses), and administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Participants are immediately vested in their elective salary deferral contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's safe harbor and additional nonelective employer contributions, plus actual earnings or losses thereon, is based on years of continuous service. Participants vest 50% each year of credited service until fully vested after two years of credited service.

(e) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant may elect to receive a lump sum, partial withdrawal, installment, or a combination thereof, equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum, partial withdrawal, installment distribution, or a combination thereof. If the participant's account is less than \$1,000, the total vested balance is distributed in a lump-sum in accordance with the plan document.

(f) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures are used at the Plan's discretion to either offset plan administrative expenses or to reduce the Plan Sponsor's contributions to the Plan. Forfeited nonvested accounts totaled \$2,909 at December 31, 2023. Plan Sponsor contributions were reduced by \$3,821 from forfeited nonvested accounts during 2023.

(g) Notes receivable from participants

The Plan does not permit loans. As a result of the mergers described in Note 1(a), certain participants' loan balances were transferred into the Plan. These loans are secured by the balance in the participants' accounts and bear interest at a fixed rate. Principal and interest are paid ratably through payroll deductions.

(h) Hardship withdrawals

The Plan permits distributions in the event of a financial hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½, unless certain exceptions apply.

(i) Administrative expenses

Certain expenses of maintaining the Plan can be paid directly by the Plan Sponsor, and if paid, are excluded from these financial statements. Fees related to the processing of benefit payments and the administration of notes receivable from participants are included in administrative expenses and charged directly to the applicable participant's account. Investment related expenses are included in net appreciation in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by Fidelity Management Trust Company ("Fidelity"). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan's management has evaluated events and transactions that occurred between March 28, 2024 and January 15, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants presented and disclosed in the accompanying financial statements and supplemental schedule, including the fair value of investments and notes receivable from participants held at December 31, 2023, net appreciation in the fair value of investments, interest and dividend income, and interest on notes receivable from participants for the period ended March 28, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity.

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets in the fair value hierarchy tables. There have been no changes in the methodology used at December 31, 2023.

- (i) *Mutual funds and money market fund*: Valued at net asset value of shares held by the Plan at year end in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Income tax status

The Plan Sponsor adopted a pre-approved profit sharing plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC and has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and is, therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 28, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related party and party-in-interest transactions

Certain mutual funds and a money market fund as of December 31, 2023 were managed by Fidelity and, therefore, transactions with these investments qualify as party-in-interest transactions. As described in Note 1, the Plan paid expenses to various service providers which qualify as party-in-interest transactions. The Plan also held notes receivable from participants which also qualifies as party-in-interest transactions.
