## INDEPENDENT AUDITORS' REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C)**

We have performed an audit of the financial statements of Verys, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of April 1, 2022 (liquidation basis) and December 31, 2021 (liquidation basis), and the related statement of changes in net assets available for benefits for the period January 1, 2022 through April 1, 2022 (liquidation basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of April 1, 2022 and December 31, 2021, and for the period January 1, 2022 through April 1, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Verys, LLC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discuss in Note 1 to the financial statements, by virtue of the Plan sponsor's sale, a decision was made on December 15, 2021 to terminate the Plan. As a result, Verys, LLC 401(k) Profit Sharing Plan changed its basis of accounting from the going-concern basis of accounting to the liquidation basis of accounting used in presenting the 2021 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Verys, LLC 401(k) Profit Sharing Plan ability to continue as a going concern for one year from this report date.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are

considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Verys, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan became effective January 1, 2015 and has been amended as of November 1, 2019 (the “Effective Date”). The Plan was intended to be a qualified retirement plan under the Internal Revenue Code (“IRC”).

***GENERAL***

The Plan was a defined contribution plan established under Section 401(k) of the Internal Revenue Code. The Plan covered substantially all full-time employees of Verys, LLC (the “Plan Sponsor”) who are not covered by collective bargaining agreements or non-resident aliens. Participants enter the Plan immediately upon hire reaching the age of 21 and at the employment with the Company. The trustee was responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. The custodian and record keeper of the Plan is John Hancock Life Insurance Company (“Custodian”). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and Section 401(a) of the IRC.

***Plan Termination***

During the year ended December 31, 2021, the Plan Sponsor was purchased by West Monroe Partners and a determination was made on December 15, 2021 to terminate the Plan. The Plan Sponsor exercised its right to discontinue its contributions and terminate the Plan effective December 31, 2021. Plan participants were given an opportunity to either transfer their assets into the West Monroe Partners 401(k) Plan, rollover their assets into a Traditional IRA, or take a cash distribution. As of April 1, 2022, all the Plan assets were distributed out of the Plan.

***ELIGIBILITY***

Under the terms of the Plan prior to the date of the termination, all eligible employees may elect to participate in the Plan as of the first day of the month immediately following their date of hire.

***CONTRIBUTIONS***

***Participants***

Prior to the date of the termination, participants may contribute up to 100% of their annual compensation, as defined by the Plan. §401(k) of the Internal Revenue Code (the “Code”) and the Plan limit the amount certain highly compensated individuals may contribute, based on amounts contributed by lower compensated individuals. All participants were limited to a maximum contribution of \$20,500 in 2020 by §402(g) of the Code. In addition, individuals age 50 or over by the end of the plan year were allowed to make additional contributions, in excess of the standard limits, of up to \$6,500 in 2020. If any participant’s elective deferrals for the year exceed the maximum allowable for that year, the excess amount were repaid by the trustee to the participant as taxable compensation.

***Employer***

Employer contributions, subject to certain Internal Revenue Service limitations, were made at the sole discretion of the Plan Sponsor. Prior to the date of the termination, the Plan Sponsor may also make a discretionary profit-sharing contribution in an amount to be determined by the Board of Directors. Employees must complete one year of service requirement during the Plan year and be employed as of the last day of the Plan year to be eligible to receive nonelective contributions that may be made during a Plan year. There were no profit sharing contributions for the period January 1, 2022 through April 1, 2022.

All participant and employer contributions made on a participant’s behalf were deposited in the trust and allocated among the investment funds in accordance with the participant’s investment elections. Prior to the plan termination, a participant may elect to transfer investments from any investment fund to any other investment fund on a daily basis.

***Rollovers***

With the consent of the Plan administrator, participants were permitted to deposit distributions received from other qualified plans (“rollovers”) without incurring federal or state income taxes and penalties. There were no rollover contributions for the period January 1, 2022 through April 1, 2022.

***PARTICIPANT ACCOUNTS***

Each participant's account was credited with the participant's contribution and an allocation of (i) employer contributions, if any, (ii) Plan earnings and (iii) administrative expenses. All allocations are based on participant earnings or account balances to various investment options offered by the Plan. Administrative expenses that were paid by the Plan were charged to the participants' accounts on a pro-rata basis. Administrative expenses that are attributable to a participant were charged to the participant's account. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

***VESTING***

Participants were 100% vested, upon hire date, in their elective salary deferrals, rollovers, employer matching contributions and any related investment earnings, gains and losses. Participants became fully vested in Plan Sponsor's profit sharing contributions and all related investment earnings, gains, and losses upon retirement or in the event of death or disability while employed by Verys, LLC.

***FORFEITURES***

Upon termination of employment, the non-vested portion of the participant's account balance was forfeited at the end of the plan year. Forfeited accounts were used to pay any administrative expenses or reduce employer contributions. At April 1, 2022 and December 31, 2021, there was no forfeited non-vested balance. For the period January 1, 2022 through April 1, 2022, there were no forfeitures allocated to offset the employer contribution.

***PAYMENT OF BENEFITS***

Prior to plan termination, the Plan provided for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship, or termination of employment. In-service distributions were also available to those participants who were age 59 ½ or older. Participants who qualify for retirement benefits and withdrawals would receive their benefits as a lump sum in cash. The benefit to which a participant was entitled was the benefit that can be provided solely from the participant's vested account balance. Participants who separate from service and had vested account balances of \$5,000 or less were subject to an administrative lump sum distribution.

***CARES ACT***

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was enacted, which included provisions, which among others, provide temporary relief for those retirement plan participants affected by the coronavirus disease (COVID-19). On March 27, 2020, the plan administrator authorized the trustees to adopt the provisions of the CARES Act, impacting the default provisions of the Plan. The following key CARES Act provisions have been adopted by the Plan, which are available to participants impacted by COVID-19:

- (1) COVID-19 related hardship distributions up to \$100,000 that are subject to income tax withholding at 10%, which are payable over a three-year period from the date the funds were received and not subject to the 10% early withdrawal penalty,
- (2) COVID-19 related loan withdrawals up to \$100,000, but no more than 100% of the vested account balance with deferred loan payments for twelve months, and
- (3) required minimum distributions are no longer required to be distributed.

As of April 1, 2022, the Plan had not been formally amended, as a formal amendment was not required until the plan year ended December 31, 2025 and did not intend to do so prior to plan termination discussed at Note 1.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***BASIS OF ACCOUNTING***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***USE OF ESTIMATES***

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results may differ from those estimates.

***RISKS AND UNCERTAINTIES***

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as variable interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the value of investments securities would occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

***INVESTMENT VALUATION AND INCOME RECOGNITION***

As a result of the Plan termination described in Note 1, the Plan held no investments as of April 1, 2022. As of December 31, 2021, investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

***PAYMENTS OF BENEFITS***

Benefits were recorded when paid.

***ADMINISTRATIVE EXPENSES***

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor. Expenses paid by the Plan Sponsor were not included in these financial statements. Investment related expenses were netted against net depreciation of fair value of investments.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

Certain information related to investments disclosed in the accompanying financial statements, including investments held at April 1, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends for the period January 1, 2022 through April 1, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company U.S.A., the custodian of the Plan.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 1, 2022 and December 31, 2021.

***POOLED SEPARATE ACCOUNTS***

Pooled separate accounts were valued at the daily net asset value (“NAV”) of units of the pooled separate accounts. The NAV, as provided by the custodian, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient was not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

***FAIR VALUE OF INVESTMENTS IN ENTITIES THAT USE NAV***

As a result of the Plan termination described in Note 1, the Plan had no investments as of April 1, 2022.

**NOTE 5 - RELATED PARTY TRANSACTIONS**

Plan investments were managed by John Hancock Life Insurance Company, the custodian of the Plan. Transactions relating to these investments qualified as party-in-interest transactions. Fees incurred by the Plan for investment management services were included in net appreciation in fair value of investments, as they were paid through revenue sharing, rather than direct payment. The Plan Sponsor paid directly any other fees related to the Plan’s operations.

**NOTE 6 - INCOME TAX STATUS**

The Company adopted the provisions of a volume submitter 401(k) Plan that received an opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the volume submitter 401(k) Plan was designed in accordance with applicable sections of the IRC qualifying under Section 401(a). Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan administrator and the trustee do not intend to amend the Plan prior to plan termination discussed at note 1.

Accounting principles generally accepted in the United States of American require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.
