INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
Cantex, Inc. Employee Benefit Plan

Opinion

We have audited the accompanying financial statements of Cantex, Inc. Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of benefit obligations and net assets available for benefits – modified cash basis as of March 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the benefit obligations and net assets available for benefits – modified cash basis of Cantex, Inc. Employee Benefit Plan as of March 31, 2024 and 2023 and the changes in benefit obligations and net assets available for benefits – modified cash basis for the years ended in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Cantex, Inc. Employee Benefit Plan (Plan) provides only general information. Participants and others should refer to the plan document and respective summary plan description for a more complete description of the plan provisions.

General - The Plan provides health, dental and vision benefits to employees, and their dependents, of Cantex, Inc. (Plan sponsor) who participate. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is self-funded for most claims; however, the Plan sponsor maintains a stop loss insurance policy. This policy reimburses the Plan once claims exceed \$300,000 per person. The cost of this policy is borne by the Plan sponsor. For the Plan year ended in 2024 and 2023, the Sponsor paid \$643,665 and \$642,257, respectively.

Contributions - Contributions are made by the Plan's sponsor and employee participants at rates determined by the trustees for the benefits desired. Contributions are also received by retired and inactive employees under the COBRA provisions of Federal law. The Plan sponsor contributes the amount necessary, in excess of the participants' contributions, to timely fund all claims as they are presented for payment.

NOTE 2 - ACCOUNTING POLICIES

These financial statements have been prepared using the modified cash basis of accounting. The modified cash basis of accounting means that contributions and other revenues are recognized when received and claims and other expenses are recognized when paid. Amounts incurred but not paid at year-end are reflected as benefit obligations payable.

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3 - CONCENTRATIONS OF CREDIT RISK

The Plan maintains its cash balances in one financial institution. The balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. Accordingly, as of March 31, 2024 and 2023, the uninsured cash balance was \$0.

NOTE 4 - TAX STATUS

The trust is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code as exempt from income taxes. The Plan has obtained a favorable tax determination letter from the IRS and the trustees believe that the plan continues to qualify and to operate as designed.

The Plan does not believe there are currently any tax positions which have a reasonable possibility of change from taxing authorities. The Plan is subject to routine audits by taxing jurisdictions (DOL and IRS); however, there are currently no audits for any tax periods in progress. Accrued interest and penalties associated with uncertain tax positions, if any, are recognized as part of administrative expenses. There were no taxes or accrued interest or penalties related to the income tax position of the Plan as of March 31, 2024. The plan administrator believes the Plan is no longer subject to examinations for years prior to 2020.

NOTE 5 - PLAN TERMINATION

Although the Plan sponsor expects the Plan to be continued indefinitely, it reserves the right to terminate the Plan at any time by action of the Board. If such termination occurs, it will be done in accordance with rules and regulations as promulgated under the Employee Retirement Income Security Act of 1974, as amended.

NOTE 6 - BENEFIT OBLIGATIONS

The Plan's benefit obligations were based upon estimates developed by the Plan sponsor, with assistance from the third-party administrator.

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 was passed into law and effects Plans providing prescription drug benefits to retirees. The Plan does not offer postretirement benefits to retirees and therefore is not affected by these provisions.

NOTE 7 - PARTY IN INTEREST

The Plan receives contributions from the Plan sponsor as discussed in Note 1. All funds contributed were used to maintain the Plan and provide benefits for participants in the Plan in accordance with the provisions of the Plan Documents.

NOTE 8 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The financial statements were prepared using the modified cash basis of accounting. However, the Plan utilizes the cash method of reporting for their 5500 filing. Accordingly, the effects of benefit obligations are not included on the Form 5500.

NOTE 9 - PLAN AMENDMENTS AND SUBSEQUENT EVENTS

Subsequent events were evaluated through January 15, 2025, which is the date the financial statements were available to be issued.
