Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AKAM Living Services, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the AKAM Living Services, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of AKAM Living Services, Inc., AKAM Associates, Inc., and AKAM On-Site, Inc., (collectively, the Company, Employer or Plan Sponsor) who have attained the age of 21 years and have completed three months of service. The Plan was established on March 1, 1996, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and has been amended as required by law.

Contributions: Contributions are subject to certain Internal Revenue Service (IRS) limitations. Each year, participants may contribute up to 90% of annual compensation on a pre-tax basis and/or an after-tax (Roth) basis, as defined by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions, which are amounts representing distributions from other qualified benefit plans.

The Company may make discretionary matching contributions and/or non-elective discretionary profit-sharing contributions to eligible employees under the terms of the Plan. Participants are eligible for the matching contribution after three months of service. The amount of discretionary matching contributions, if any, will be determined each Plan year and announced to all participants. During the year ended December 31, 2023, the Company made discretionary matching contributions of 10% of the first 100% of eligible participant contributions. There were no non-elective discretionary profit-sharing contributions made during the year ended December 31, 2023.

Participant accounts: Each participant's account is credited with the participants contribution, an allocation of the Company's discretionary matching contributions and/or non-elective discretionary profit-sharing contributions and the Plan's earnings thereon and are charged with benefit payments and an allocation of the Plan's losses and specific administrative expenses. Allocation of Plan earnings and losses are based on participants' account balances while contributions are credited based upon elective deferrals and compensation, as defined. Transaction fees are charged directly to the accounts of the participants who incur those fees. Discretionary matching contributions are allocated proportionately to participant elective contributions for all eligible participants at the end of the year. Additional non-elective discretionary profit-sharing contributions are allocated based on the ratio of the participant's compensation to the total compensation of all eligible participants for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options: A participant may direct the investment of their contributions and their allocation of the Company's discretionary matching contributions and/or non-elective discretionary profit-sharing contributions into any of the mutual fund investments and/or money market funds offered by the Plan. Participants may change their investment options at their decision.

Excess contribution payable: As of December 31, 2023 and 2022, a liability of \$55,531 and \$0, respectively, is recorded for amounts to be refunded by the Plan to participants for contributions made in excess of amounts allowed by the IRS.

Rollovers: With the approval of the Company, participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollovers) provided that the receipt of such amounts does not adversely affect the qualified tax status of the Plan. Participants are fully vested in these amounts.

Note 1. Description of the Plan (Continued)

Vesting: Participants' contributions, rollovers and earnings thereon are immediately fully vested. Company discretionary matching and non-elective contributions are subject to a vesting schedule, based on years of continuous service, as follows:

Years of Service	Vested
Up to 2 years	0%
After 2 years	20%
After 3 years	40%
After 4 years	60%
After 5 years	80%
After 6 years	100%

Forfeitures: Forfeited nonvested accounts may first be used to pay Plan expenses and then used to reduce Employer contributions. Forfeitures are created when participants terminate employment before becoming entitled to their full benefit under the vesting provisions of the Plan. For the year ended December 31, 2023, the Plan received forfeitures amounting to \$34,303 and of that, forfeitures of \$27,842 were used to offset employer contributions. The ending nonvested forfeiture balances as of December 31, 2023 and 2022, were \$31,125 and \$24,664, respectively.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan is generally five years. The notes bear interest at commensurate with the Prime rate plus one percentage point at the date of each note. Principal and interest are paid ratably through regular payroll deductions. Upon termination of service or termination of the Plan, the loan becomes due and payable unless directly rolled over to another employer's Plan. Interest rates ranged from 3.25% to 9.50% as of December 31, 2023 and 2022, which were commensurable with local prevailing rates as determined by the Plan Administrator.

Payment of benefits: Upon termination of service for any reason, a participant may elect to receive either a lump-sum amount or rollover payment equal to the vested value of his or her account or have the amount remain invested in the account if the balance is greater than \$5,000. Vested benefits in amounts less than \$5,000 may be distributed in a lump-sum amount without the participant's election.

Participants may request withdrawals of elective deferrals, rollover contributions and vested Company contributions under certain circumstances as defined in the Plan document.

Participants may also elect to roll over their vested account balance to another qualified retirement plan or an individual retirement account (IRA).

Administrative expenses: The Company absorbs a significant part of the administrative costs for the Plan, including professional fees for accounting, auditing and the Plan administration, contract charges and servicing fees. Administrative fees paid by the Company are excluded from these financial statements.

Participant-requested transactions such as distribution fees and participant loan fees are paid by the participants of the Plan. Investment fees charged to the Plan for investments in the various mutual funds are netted against the net appreciation (depreciation) in the fair value of investments on the statement of changes in net assets available for benefits.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of investments, which includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded in these financial statements.

Payment of benefits: Benefits are recorded when paid.

Income taxes: U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2020.

Note 3. Information Certified by Reliance Trust Company

The following is a summary of the Plan's asset information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statement and supplemental schedule, that was prepared by or derived from information provided by Reliance Trust Company (Trustee) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule related to the following assets:

The Trustee also certified to the completeness and accuracy of \$1,271,591 of net appreciation in fair value of investments, \$263,263 of interest and dividends related to the aforementioned investments, and \$14,731 of interest income on notes receivable from participants for the year ended December 31, 2023.

Note 4. Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820, Fair Value Measurements are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023 and 2022.

Mutual funds and money market fund: Mutual funds and money market fund are valued at quoted net asset value (NAV) of shares held by the Plan. These securities are categorized as Level 1 as they are actively traded and no valuation adjustments apply.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-in-Interest Transactions

Certain investments of the Plan are shares of mutual funds and money market funds managed by the Trustee and, therefore, these transactions qualify as party-in-interest transactions. The Plan also issues loans to participants, which are secured by the balances in the participant's account and constitute party-in-interest transactions. The Company paid most administrative expenses of the Plan.

During the 2020, 2021 and 2022 plan years, the Plan Sponsor inadvertently failed to deposit \$88,020, \$2,400 and \$800, respectively, of participant contributions within the required time frame as stated by the DOL's regulations. The Plan Sponsor intends to deposit lost earnings to correct this failure as soon as possible. The Plan Sponsor will file Form 5330 and pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Plan Sponsor's assets and not from the assets of the Plan.

Note 6. Income Tax Status

The Plan uses a preapproved plan document. The preapproved plan received its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The preapproved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the preapproved plan document received its opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.
