INDEPENDENT AUDITORS' REPORT

To the Board of Directors and Management of
Hitachi Astemo Rock Spring, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hitachi Astemo Rock Spring, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended March 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2024 and 2023, and for the year ended March 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

1. DESCRIPTION OF PLAN

The following description of the Hitachi Astemo Rock Spring, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of Hitachi Astemo Rock Spring, Inc. (the Plan Sponsor or the Company). The Plan covers substantially all employees, except nonresident aliens, reclassified employees, as defined, and residents of Puerto Rico, who have completed two months of service (participants). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Plan is administered by the Company. Empower Retirement is the recordkeeper for the Plan. Empower Annuity Insurance Company of America (EAIC) is the custodian of the Plan assets.

Effective March 31, 2024, the assets of the Plan were merged into the Hitachi Employee 401(k) Retirement Plan. All Plan provisions disclosed below relate to activity prior to the merge of the Plan.

Contributions

Each year, eligible participants may contribute pretax deferrals up to 100% of their eligible compensation, as defined in the Plan not to exceed the amount allowed for income tax purposes. Participants may also rollover contributions from other qualified defined benefit or defined contribution plans. Catch-up contributions are permitted under the Plan and are subject to employer match.

The Plan provides that the Plan Sponsor will make discretionary matching contributions. For the 2024 plan year, the Company elected match was an amount equal to 50% of each participant's contributions up to 6% of each participant's compensation.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts

Each participant's account is credited or charged with the participant's contribution and allocations of Plan Sponsor contributions, investment earnings and losses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Effective August 1, 2019, all Plan Sponsor matching contributions are immediately vested. Participants with a termination date prior to August 1, 2019, are subject to a vesting

schedule which provides 20% vesting for each year of service, as defined.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at fixed rates which are commensurate with local prevailing rates. Loans are repayable over a period of up to five years, unless the proceeds are used to purchase a principal residence, in which case a period in excess of five years is available. Principal and interest are collected ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement (age 62) or separation from service, a participant or their beneficiary may receive their vested balance in either a single lump-sum distribution, a direct rollover into a qualified retirement plan or individual retirement account, monthly installments or defer receiving payments until age 72. Terminated participants with a vested balance of \$1,000 or less that have not elected payment will be cashed out. In-service distributions are available upon reaching age 59½, for financial hardships as defined by the Plan, and from rollovers or after-tax accounts.

Forfeitures

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. At March 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- and \$12,103, respectively. Such forfeitures reduce the Plan Sponsor's contributions or expenses to the Plan. In 2024, Plan expenses of \$1,705 were reduced from forfeited nonvested accounts.

Administrative Expenses

The Company pays substantially all administrative costs of the Plan, except for recordkeeping fees, investment advisory fees and various fees associated with these activities, which are paid by the participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the fixed annuity account, which is stated at contract value. Contract value is the relevant measure for the portion of net assets

available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the custodians of the funds. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred.

No allowance for credit losses has been recorded as of March 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

3. FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at March 31, 2024 or 2023.

Pooled Separate Accounts (PSA): The Plan entered into a group annuity contract with Talcott Resolution Life Insurance Company (TRLIC), formerly named Hartford Life Insurance Company, in which the Plan investments in the Hartford separate sub rider agreement with TRLIC in which certain investments are offered. These investments are PSAs that are valued based upon net asset value (NAV) as provided by the custodian of the funds. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of March 31, 2023.

4. INFORMATION CERTIFIED BY PLAN CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements, including investments held as of March 31, 2023, and net appreciation in fair value of investments and interest income for the year ended March 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian of the Plan.

5. GROUP ANNUITY INVESTMENT CONTRACT WITH EAIC (FORMERLY TRLIC)

The Plan is funded with a group annuity contract originally issued by TRLIC; however, as described in Note 1, this product has been assigned to EAIC. The contract offers a fixed investment option through EAIC. As described in Note 2, the contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts since this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value for the fixed option represents amounts contributed or transferred to the fixed option less any withdrawals or transfers out, plus all accrued interest. The fixed option

earns interest at the higher of the rate guaranteed under the contract or the current rates established and declared in advance by EAIC. Interest rates for new contributions are declared prior to the beginning of a calendar quarter and are applicable to all contributions received in that quarter until the end of the calendar year following the current year. The fixed option is backed by EAIC's general account. There are no reserves against the contract value for credit risk of the contract issuer as of March 31, 2024 and 2023.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory requirements.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. INCOME TAX STATUS

The Plan adopted a prototype plan document sponsored by Empower Retirement, LLC. The prototype plan document received an opinion letter from the Internal Revenue Service (IRS), dated November 14, 2022, which states that the prototype document satisfies the applicable provisions of the IRC. The prototype plan document has been amended since receiving the opinion letter. However, Empower Retirement, LLC and the Company believe that the prototype plan document is currently designed and operated in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that most likely would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the custodian of the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each account. Fees paid to Empower Retirement for participant requested transactions are included

as administrative expenses on the statement of changes in net assets available for benefits.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.
