## INDEPENDENT AUDITOR'S REPORT

Administrative Committee  
Culy Contracting, LLC Retirement Savings Plan

### Scope and Nature of the *ERISA Section 103(a)(3)(C)* Audit

We have performed audits of the accompanying financial statements of Culy Contracting, LLC Retirement Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974 (ERISA)*, as permitted by *ERISA Section 103(a)(3)(C)*. The financial statements comprise the statement of net assets available for benefits as of March 22, 2024 and December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the periods then ended (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Culy Contracting, LLC Retirement Savings Plan's financial statements performed in accordance with *ERISA Section 103(a)(3)(C)* pursuant to 29 *CFR 2520.103-8* of the *Department of Labor's Rules and Regulations for Reporting and Disclosure* under *ERISA*. As permitted by *ERISA Section 103(a)(3)(C)*, our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 *CFR 2520.103-5* of the *Department of Labor's Rules and Regulations for Reporting and Disclosure* under *ERISA* (qualified institution).

Management has obtained certifications from a qualified institution as of March 22, 2024 and December 31, 2023, and for the periods then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of *ERISA Section 103(a)(3)(C)*.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Culy Contracting, LLC Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our *ERISA Section 103(a)(3)(C)* audit opinion.

### **Emphasis of Matter – Basis of Accounting**

As described in Note 3 to the financial statements, the governing body of Culy Contracting, LLC Retirement Savings Plan approved a plan of liquidation on December 7, 2023, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis to the liquidation basis used in presenting the 2023 and 2024 financial statements. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the *ERISA Section 103(a)(3)(C)* audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Culy Contracting, LLC Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the *ERISA Section 103(a)(3)(C)* audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Culy Contracting, LLC Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an *ERISA Section 103(a)(3)(C)* audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. DESCRIPTION OF PLAN**

The following description of Culy Contracting, LLC Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General* – The Plan is a defined contribution plan covering all non-union employees of Culy Contracting, LLC who have met eligibility requirements. The Plan became effective on March 30, 2012. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*. Effective December 7, 2023, the Plan was amended and restated in conjunction with the plan of termination.

*Eligibility* – Employees become eligible to participate when they complete one hour of service. Employees become eligible to receive profit-sharing contributions when they complete one year (1,000 hours) of service. The employee must be employed on the last day of the year to receive the profit-sharing contribution.

*Employee Contributions* – Participants may elect to reduce their compensation by a specific amount, subject to the dollar limitation established annually by the Internal Revenue Service. These contributions may be deferred on a pre-tax basis or an after-tax Roth basis. Participants direct the investment of their contributions, as well as all Company contributions, into various investment options offered by the Plan. Effective December 7, 2023, the plan was frozen and no further contributions were permitted into the plan.

*Profit-Sharing Contributions* – The Company may make a discretionary profit-sharing contribution to the Plan allocated to each participant's account. In 2023, the Company elected to contribute one dollar for each hour worked by the participant through the December 7, 2023, date of termination. In 2024, the Company did not contribute to the Plan due to the termination.

*Participant Accounts* – Each participant's account is credited with the participant's contribution, the Company's profit-sharing contribution, and an allocation of the Plan earnings and expenses. Allocations are based on participant contributions, hours worked, earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* – Participants are fully vested in their contributions, profit-sharing contributions, and earnings thereon.

*Participant Loans* – The Plan does not allow for participant loans.

*Benefit Distributions* – Benefits generally are distributed upon the participant's termination, normal retirement, disability retirement, or death. Benefits will be paid in a single lump-sum payment equal to the participant's individual vested account. In 2024 all participant accounts were distributed as part of the plan of liquidation.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Estimates* – The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan’s Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

*Basis of Accounting* – The financial statements of the Plan are prepared using the liquidation basis of accounting for the year ended December 31, 2023 and for the period ended March 22, 2024.

*Investment Valuation and Income Recognition* – The pooled separate accounts are valued at net asset value per share, or its equivalent of the funds, which are based on the fair value of the funds’ underlying assets. This method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. See Note 9 for a discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Net investment income includes the Plan’s gains and losses on investments bought and sold as well as held during the period.

*Payment of Benefits* – Benefits are recorded when paid.

**3. PLAN TERMINATION**

The management of Culy Contracting, LLC, the Plan’s sponsor, voted on December 7, 2023, to terminate the Plan effective December 7, 2023. Plan management considered the liquidation of the Plan to be imminent upon the decision to terminate the Plan. Final distributions were determined based on all participants being 100% vested, and were made in 2024. In accordance with Generally Accepted Accounting Principles, the Plan has changed its basis of accounting used to value plan assets from the ongoing plan basis to the liquidation basis for the year ended December 31, 2023 and for the period ended March 22, 2024.

Plan liquidation was completed in March 2024.

**4. INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. Accordingly, the trust’s net investment income is exempt from income taxes. The Plan’s Sponsor believes the Plan continues to qualify and operate as designated.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities.

**4. INCOME TAX STATUS (continued)**

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 22, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. INFORMATION CERTIFIED BY TRUSTEE**

All amounts reported for invested assets and related investment income or loss, and appreciation or depreciation in the accompanying financial statements are based on information certified by the trustee, John Hancock Life Insurance Company, as being complete and accurate.

**6. ADMINISTRATION EXPENSES**

The expense of administering the Plan shall be paid either by the Company or by the Plan. For the period ended March 22, 2024 and for the year ended December 31, 2023, the Plan incurred expenses of \$10,390 and \$5,705, respectively, for trustee and administrative fees. The Company also incurred expenses related to the administration of the Plan. Certain administrative functions are performed by employees of the Company. No employees receive compensation from the Plan.

**7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets are in investment funds managed by John Hancock Life Insurance Company or its affiliates. John Hancock Life Insurance Company is a custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions as defined under *ERISA* Guidelines.

**8. RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near-term and that such changes would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 inputs were not available. There were no Plan assets requiring the use of Level 1, 2, or 3 inputs for the periods presented.

The following is a brief description of the nature and significant investment strategies of the major categories of pooled separate accounts:

*Stable Value / Conservative Fund* – The pooled separate accounts in this category seeks to preserve capital and provide book value liquidity on a daily basis for plan permitted, participant-directed withdrawals while maintaining a competitive rate of interest.

*Equity Funds* – The pooled separate accounts in this category primarily invest in equity securities capital appreciation and dividend income.

*Target Date Funds* – The pooled separate accounts in this category seek a high total return through its target retirement date, with greater focus on income beyond the target date.

*Global/International Funds* – The pooled separate accounts in this category seek long-term growth by investing in common stocks of non-U.S. companies.

*Fixed Income / Income Funds* – The pooled separate accounts in this category seek to maximize total return consisting of current income and capital appreciation.

*Growth Funds* – The pooled separate accounts in this category seek to achieve long term growth.

*Aggressive Growth Funds* – The pooled separate accounts in this category seek to achieve larger long-term growth with small and mid-cap investments.
