Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of schedule H, line 4i - schedule of assets (held at end of year) as of June 30, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1. PLAN DESCRIPTION

The following is a brief description of the Plan which provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General: The Plan is a 401(k) defined contribution plan available to employees of Trillium Health, Inc. (the Company) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act, ERISA. The Plan is funded by participant and employer contributions and covers all eligible employees of the Company.

Administration: The Company sponsors the Plan and is responsible for the general administration of the Plan and carrying out its provisions. Reliance Trust Company is the trustee of the Plan's assets. Automatic Data Processing (ADP) Retirement Services is the third-party administrator of the Plan. The Trillium Health, Inc. Retirement Plan Committee is responsible for oversight of the Plan.

Eligibility: The Plan covers all employees, except leased employees, union employees, per diem employees, intern or temporary employees, and any employee who is a resident of Puerto Rico. Employees are eligible to participate in the Plan once they have attained age 21 and upon one month of hire.

Employees may participate in the employer discretionary profit-sharing contribution if they are employed and have completed at least 1,000 hours of service on the last day of the Plan year. All employees are eligible for employer contributions (both safe harbor and matching) once the eligibility requirements above are met.

Contributions: Participants may make voluntary pre-tax contributions and roth contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations under the terms of the Plan and the Internal Revenue Code (IRC). Effective January 1, 2024, participants may make elective Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants have the option to change their voluntary deferral or discontinue deferrals at any time.

The Company may make a discretionary profit-sharing contribution which is allocated equally among all eligible participants. There were no discretionary profit-sharing contributions to the Plan for the years ended June 30, 2024 and 2023. The Company makes non-elective matching contributions at a rate equal to 25% of participant elective contributions up to 4% of the employee's eligible compensation. Non-elective matching contributions amounted to \$144,342 for the year ended June 30, 2024 (\$135,923 – 2023). The Company also makes a safe harbor contribution amount equal to 3% of the employee's eligible compensation. Safe harbor contributions amounted to \$532,089 for the year ended June 30, 2024 (\$497,985 – 2023).

Participants direct the investment of their contributions and all Company contributions and related earnings (losses) thereon into various investment options offered by the Plan.

Participant Accounts: Each participant's account is credited with the participant's contribution as well as allocations of the Company's contributions and Plan earnings (losses). Participant's accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately fully vested in participant, non-elective matching, and safe harbor contributions. Participants become vested in the discretionary profit-sharing contributions based on years of service, which is defined by the Plan document as the participant completing 1,000 hours of service each Plan year, in accordance with the following schedule:

NOTE 1. PLAN DESCRIPTION (CONTINUED)

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account. Loans are payable over a period not to exceed five years, except when used to acquire a principal residence, in which case loans may be paid over a longer repayment period. The loans bear interest at the prime rate plus 1% and are fixed at the time of the loan. Principal and interest are paid ratably through payroll deductions over the term of the loan.

Contributions Payable: The Plan has an amount payable to Parkway Pediatrics 401(k) Plan in the amount of \$27,695 for the year ended June 30, 2024 due to a rollover contribution. There was no contribution payable for the year ended June 30, 2023.

Payment of Benefits: At separation and retirement, participants may withdraw their vested balances. A participant who attains age 62 becomes 100% vested and may withdraw any portion of their balance upon retirement. The Plan provides for early retirement at age 55 and completion of five years of service. If employment terminates for any reason other than death, disability or retirement, participants are only entitled to their vested balance. Hardship withdrawals from the Plan are permitted from a participant's account. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Vested balances in excess of \$5,000 may be paid out in a single lump sum or partial payment, at the option of the participant. Effective January 1, 2024, the vested balance increased to \$7,000. Any vested balances less than \$5,000 from July 1, 2023, through December 31, 2023 and less than \$7,000 from January 1, 2024 through June 30, 2024 are automatically distributed in a single lump sum. Effective January 1, 2024, if a participant does not elect a distribution for vested balances less than \$7,000, the distribution is automatically transferred to an IRA account. Additionally, payments may be made in installments, but only for purposes of minimum required distributions, over a period of not more than the participant's assumed life expectancy.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor, trustee and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023.

Benefits Payments: Benefits are recorded when paid.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments in the accompanying statements of changes in net assets available for benefits.

Reclassifications: Certain amounts in the 2023 financial statements have been reclassified to conform with the 2024 presentation.

Subsequent Events: The Plan has been evaluated for subsequent events through November 19, 2024, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from or corroborated by observable market data correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Shares of Registered Investment Companies: Shares of registered investment companies are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Common Collective Trust Fund: Valued at the NAV of units based on the quoted prices of the underlying investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan's interest in these funds are based on information reported by the Trustee using the audited financial statements of the funds at year end.

NOTE 4. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by the Reliance Trust Company, the Plan trustee, ADP, the Plan's third-party administrator, and Sage Ruddy & Company, Inc., the Plan's investment advisor. As such, transactions between these parties and the Plan qualify as party-in-interest transactions.

NOTE 5. PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. In the event of a partial termination, only those who are affected by such partial termination shall be fully vested. All distributions would be made in accordance with any applicable requirements of ERISA and the IRC.

NOTE 6. TAX STATUS

Effective July 1, 2017, the Plan adopted a volume submitter plan sponsored by ADP. The volume submitter plan has received an opinion letter, dated October 6, 2020, from the Internal Revenue Service (IRS) as to the prototype Plan's qualified status. The prototype Plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in process.

NOTE 7. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

NOTE 8. FINANCIAL CERTIFICATION

The following unaudited financial information regarding the Plan's assets at June 30, 2024 and 2023, as well as income and transactions for the years then ended, has been derived from information provided by Reliance Trust Company, the trustee of the Plan. The incorporation of this financial information in the accompanying financial statements is based solely on their certifications, and the information relating to assets as well as transactions has not been audited by independent accountants. In addition, the Plan's trustee has certified the unaudited financial data contained in the supplemental schedule at June 30, 2024.
