Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Wellman Industries, Inc. Hourly Employees' Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of November 20, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the eleven months ended November 20, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

General - The following description of the Wellman Industries, Inc. Hourly Employees' Pension Plan (the Plan) provides general information about the Plan's provisions. Alpek Polyester Mississippi, Inc. (formerly known as DAK Americas Mississippi Inc.) (the Company) is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor and on file with the Department of Labor. The Company's Employee Benefits Committee (the Committee) is responsible for the general administration of the Plan. Principal Trust Company (the Trustee) is the trustee of the Plan.

Frozen Plan - Plan is a collectively bargained pension plan provided for the former hourly union employees at the Company's former Johnsonville, SC Plant. This location was sold to an unrelated party in October 2008 resulting in a partial plan termination. All affected participants who were not already fully vested at that time became fully vested. In addition, since benefits were based on the hours the participant worked for the Company, once the sale was completed no one could accrue any additional benefits so the Plan was effectively frozen.

Termination of the Plan – On October 13, 2021, the Company expressed its intention to terminate the Plan effective December 31, 2021. The Company notified all participants of its intention by providing each with a Notice of Intent to Terminate (NOIT) and Notice of Plan Benefits (NOPB). As of June 24, 2022, the required governmental filings were submitted to both the Internal Revenue Service (IRS) and Pension Benefit Guaranty Corporation (PBGC), and the Company had a pending determination letter request. On July 5, 2023, the Company received a favorable determination letter from the IRS on its termination of the Plan. On September 7, 2023, the Plan purchased a Single Premium Annuity that included all participants from Western Southern Life Assurance Company. The Plan was terminated on November 20, 2023.

Funding – The Company's funding policy is to make the necessary contributions to meet minimum funding requirements, as determined by the Plan's independent actuary. The Plan has met applicable ERISA minimum funding requirements for the plan year ended December 31, 2023 and 2022. No participant contributions are allowed under the plan provisions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Presentation – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investments – Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Risks and Uncertainties – The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit. Because of the level of risk associated with certain

investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

Benefit Payments – Benefit payments to participants are recorded upon distribution.

Administrative Expenses – Administrative expenses associated with the Plan are paid by the Plan unless paid by the Company at its discretion.

3. FAIR VALUE MEASUREMENTS

Fair value is defined under ASC 820 as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). To measure fair value, a hierarchy has been established that requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs. As such, the hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy in ASC 820 are described below:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

Following is a description of the valuation techniques and inputs used for each major class of assets and liabilities measured at fair value.

Pooled separate accounts – The Plan invests in certain pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV of units, as determined by The Principal Life Insurance Company, the custodian, as the estimated fair value. Because quoted prices in active markets determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. RELATED PARTIES

Certain of the Plan's assets are invested in funds managed by the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

6. TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated June 27, 2017, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that those changes could materially affect the amounts reported in the statements of net assets available for benefits.

8. SUBSEQUENT EVENTS

The plan administrator has evaluated subsequent events through October 15, 2024, the date the financial statements were available to be issued.
