To the Plan Administrator, Participants and Beneficiaries of the
Digineer, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Digineer, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE A - DESCRIPTION OF THE PLAN

The following description of Digneer, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

[1] General:

The Plan is a defined contribution plan adopted by Digneer, Inc. and Digneer Consulting, LLC, a participating employer (collectively, the "Company" or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Insurance Company/recordkeeper of the plan is Equitable Life Insurance Company and its affiliates (collectively, "Equitable").

[2] Eligibility:

There is no age requirement for employees to become eligible to participate in the Plan. Employees are eligible to make salary deferral contributions to the Plan the first of the month on or after their date of hire. Effective January 1, 2022, plan document was amended to allow part-time employees (including temporary or seasonal employees) whose normal work schedule is less than 1,000 hours per year, to become eligible to participate in the Plan post completion of one year of service. Collectively bargained employees and non-resident aliens are excluded from participation in the Plan.

[3] Contributions:

Participants may elect to make pre-tax salary deferral contributions, not to exceed annual limitations specified in the Plan or amounts allowable under Section 415 of the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans or from traditional Individual Retirement Accounts (rollovers). Participants may also make after-tax Roth 401(k) deferral contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary contributions as determined annually by the Plan Sponsor. During the year ended December 31, 2023, the Company made discretionary contributions, net of forfeiture amount of \$28,698, to the Plan amounting to \$233,211.

The Plan includes an auto-enrolment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

[4] Participant accounts:

Each participant's account is credited with the participant's contribution and the Company's contributions, as well as allocations of plan earnings (losses). Discretionary contributions are allocated in the same proportion that each participant's eligible compensation bears to the total eligible compensation of all participants. Participant accounts are charged with plan losses and an allocation of administrative expenses that are paid by the Plan. Plan earnings and losses are allocated based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - PLAN DESCRIPTION (CONTINUED)

[5] Vesting:

Participants are always 100% vested in their pre-tax salary reduction contributions, Roth contributions, rollover contributions, and related earnings. Participants vest 25% each year beginning after one year of service in their employer-derived contributions and related earnings. Upon termination of employment, any nonvested amount of employer-derived contributions is forfeited.

[6] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$500 and up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The number of loans outstanding is limited to one and no more than one loan is allowed in any 12-month period. The loans are secured by the vested balance in the participant's account. Loan terms range up to five years with longer loan terms available for the purchase of a primary residence not to exceed ten years. The loan interest rate is set at prime plus 1% (prime rate was 8.50% and 7.50% as at December 31, 2023 and 2022, respectively). Interest rates on outstanding loans as at December 31, 2023 range from 4.25% to 9.50%. Principal and interest, due in various amounts through October 2028, are paid rateably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

[7] Normal retirement:

Normal retirement age is 65. Participants vest 100% in their account balances at age 65, although actual payment of benefits may generally not begin until the participant is entitled to a distribution under terms of the Plan.

[8] Payment of benefits:

A participant or a participant's beneficiary is entitled to 100% of the account balance in the event of permanent disability, death, or at retirement. In addition, participants may obtain hardship withdrawals, as defined by the Plan, and in-service withdrawals any time after reaching age 59½. The Plan requires minimum required distribution at age 70½ or age 72 if the participant was born after June 30, 1949. Vested benefits of \$5,000 or less may be distributed in a single lump-sum as soon as practicable after the event occurs that entitles a participant to a distribution or rolled over into an IRA or to another qualified plan. If not distributed, the participant's vested benefit will be automatically rolled over to an IRA selected by the Plan administrator. Vested benefits that exceed \$5,000 may be distributed in a single lump-sum payment, partial lump sum, instalment payments, or left in the Plan.

[9] Forfeitures:

At December 31, 2023 and 2022, forfeited nonvested accounts totalled \$11,711 and \$27,013, respectively. These accounts may be used by the Company to pay plan expenses or to reduce future employer contributions. The Company used approximately \$29,000 in forfeitures to pay employer contributions during 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

[2] Use of estimates:

The preparation of the financial statements, in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

[3] Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and Insurance Company. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses related to sales of investments are recorded on a trade-date basis, and unrealized gains and losses are recorded based on the fair value as of the end of the plan year. Net realized/unrealized appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Payment of benefits:

Benefits paid to participants are recorded when paid.

[5] Expenses:

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net realized/unrealized appreciation in value of investments presented in the accompanying statement of changes in net assets available for benefits.

[6] Subsequent events:

The Plan has evaluated subsequent events through January 15, 2025, the date at which the financial statements were available to be issued.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Equitable, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants in the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, the statement of changes in net assets available for benefits for the year ended December 31, 2023 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2023.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; or
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Pooled separate accounts: Pooled separate account investment options are separate accounts that invest directly in one underlying mutual fund. Pooled separate accounts are offered and managed by Equitable. Pooled separate accounts are valued using the unit value calculated based on the net asset value ("NAV") as a practical expedient, of the underlying pool of securities that are mutual funds. The NAV is not a publicly-quoted price in an active market.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Guaranteed interest option (GIO): The GIO is a general account of Equitable. The Plan's ability to receive amounts due is dependent on Equitable's ability to meet its financial obligations and could be affected by future economic and regulatory developments. The value in the GIO at any time will equal the plan contributions and transfers to that option, plus interest, minus withdrawals and transfers out of the option and administrative charges. The fair value is the amount the Plan participants and Plan Sponsors would receive currently if they were to withdraw or transfer funds within the Plan and is valued using the discounted cash flow method with interest compounded daily. The minimum annual interest rate is 1%. The effective rate was 1.75% and 2.00% on December 31, 2023 and 2022, respectively. Certain withdrawals and transfers may be delayed under contract provisions. A surrender charge may apply to withdrawals from unmaturing guaranteed interest accounts.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Equitable. Equitable is the Plan Insurance Company and, therefore, transactions related to these investments qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan for the investment management services and recordkeeping services to Equitable were \$51,303 during the year ended December 31, 2023.

NOTE F - TAX STATUS

The Company adopted a non-standardized plan sponsored by Equitable. Equitable obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt.

NOTE F - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2023 may not necessarily be indicative of amounts that could be realized in a current market exchange.
