### ***Opinion***

## **Note 1. Description of Plan**

The following description of the A-1 Global Holdings ESOP Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### ***General***

A-1 Global Holdings, Inc. (the “Company”) established the Plan effective as of January 1, 2023. The Plan operates as an employee stock ownership plan (“ESOP”) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the “Code”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan purchased Company common shares using the proceeds of borrowings from the Company, and holds the stock in the A-1 Global Holdings ESOP Plan and Trust (“The Trust”) established under the Plan. The borrowing is to be repaid by fully deductible Company contributions to the Trust. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the Code.

The borrowing is collateralized by the unallocated shares of stock. The Company has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

1. The accounts of employees with rights in allocated stock (“Allocated”), and
2. Stock not yet allocated to employees (“Unallocated”).

### ***Eligibility***

Employees of the Company are generally eligible to participate in the Plan after one year of service provided, they worked at least 1,000 hours during such Plan year and have attained the age of 18. Participants who do not meet the eligibility requirements or are not employed on the last working day of the year are generally not eligible for an allocation of the Company contributions for such year unless employment is terminated on account of retirement, death, or disability in such year.

### ***Participant Accounts***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited as of the last day of each plan year with an allocation of shares released by the trustee from the unallocated account and forfeitures of terminated participants’ non-vested account. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive a share allocation. Share allocations are based on the number of units earned by each participant during the year relative to the total units to all participants. All eligible employees receive three units for every \$1,000 of eligible compensation and thirteen units for each year of service.

### ***Contributions***

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan’s dividends, if any, and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. The Company also makes contributions of shares to the Plan. Employee contributions are not permitted.

***Vesting***

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. An eligible participant is 20% vested after two years of credited service; vesting increases 20% each year for each of the next four years until 100% vesting is achieved after six years of credited service.

***Payment of Benefits***

No distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), becomes permanently disabled, or otherwise terminates employment with the Company. Distributions are made in cash or in shares of Company stock that must be immediately repurchased by the Company for cash.

Distributions to terminated participants will commence no later than the last day of the Plan year following the Plan year in which the event occurs while employed by the Company and shall be completely distributed within five years. If the vested account balance is \$5,000 or less, the participant will receive a mandatory single lump payment. If the vested account balance exceeds \$5,000, the participant may elect to be paid out either in a single lump-sum payment or in installments over a period of not more than the participants assumed life expectancy.

***Voting Rights***

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account under certain specified circumstances and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

***Plan Termination***

The Company reserves the right to terminate or amend the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the interest of each participant in the Trust will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Plan Administrator shall direct the trustee to pay all liabilities and expenses of the Trust and to sell shares of financed stock held in the loan suspense account, if any, to the extent it determines such sale to be necessary in order to repay the loan.

***Put Option***

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants that is not readily tradable on an established market, or is subject to trading limitations, is required to include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure the participants have the ability to ultimately obtain cash.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth Plan Year, the participant may diversify up to 50%.

***Forfeitures***

Company contributions and Plan forfeitures are allocated to each participant's account based upon the relation to the participant's compensation to total compensation for the Plan year. Non-vested shares are not considered to be forfeited by the participant until after a 5-year break in service. After the break in service requirement is met, the non-vested shares shall be allocated to remaining eligible participants. During the year ended December 31, 2023, the Company did not allocate or reinstate shares to remaining eligible participants.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the payment date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Subsequent Events***

The Plan has evaluated subsequent events through January 6, 2025, the date the financial statements were available to be issued.

**Note 4. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan’s assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

**Common Stock**

The fair value of the Company common stock is determined by an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts.

During the year ended December 31, 2023, the Plan’s investment in Company common stock appreciated in value by \$3,613,000. Level 3 assets measured at fair value on recurring basis for the year ended December 31, 2023 included contributions of the Company’s common stock and cash for \$1,424,833.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Administration of Plan Assets**

The Plan's assets, which consist of Company common shares, are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and make distributions to participants. The trustee also administers the payment of interest and principal of the loan, if any, which is reimbursed to the trustee through contribution as determined by the Company.

**Note 6. Loan Payable**

In 2023, the Plan purchased 1,850,000 Company common shares for \$13,000,000. The Plan financed this purchase through a note agreement with the Company. The initial loan agreement provides for the loan to be repaid over 15 years. The loan bears interest at the rate of 3.86%. The loan balance was \$13,000,000 at December 31, 2023. The first payment was made on March 27, 2024.

**Note 7. Tax Status**

The Internal Revenue Service ("IRS") has informed the Company by letter dated September 15, 2023 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Related Party Transactions**

The Plan invests in Company common stock which is a related party and party-in-interest transaction.

**Note 9. Risks and Uncertainties**

The Plan invests in shares of the Company's common stock. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.


