We have performed audits of the accompanying financial statements of Marquette University High School 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Marquette University High School 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Marquette University High School 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

General

The Plan is a defined contribution plan sponsored by Marquette University High School (the "Sponsor"). Teachers Insurance and Annuity Association of America ("TIAA-CREF") is the Plan custodian and holds the Plan's investment assets and executes investment transactions.

Eligibility

Eligible employees include all regular full-time employees and all part-time employees scheduled to reach 1,000 hours within the Plan year.

Employees over the age of 21 are eligible to receive Sponsor matching contributions. There is no age requirement for employees to participate in the Plan.

Contributions

Participants may contribute a portion of their pretax annual compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers").

The Sponsor makes a matching contribution equal to the following: for faculty, the Sponsor matches 4% more than the participant's contribution, up to a maximum of 8% of compensation; for administrators and staff, the Sponsor matches 3% more than the participant's contributions, up to a maximum of 7% of compensation. The Sponsor may also make discretionary profit sharing contributions. The Sponsor has made no discretionary profit sharing contributions for 2024.

Participants direct the investment of their contribution and their Sponsor contribution into various options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Sponsor's matching contributions, the Sponsor's discretionary profit sharing contributions, if any, and allocations of Plan net earnings (losses) thereon, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are fully and immediately vested in all contributions, plus actual earnings (losses) thereon.

Plan Loans

The Plan agreement permits TIAA-CREF to issue loans directly to participants. These loans are direct loans between the participant and TIAA-CREF and are excluded from the accompanying financial statements. Participants may borrow from TIAA-CREF a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of the vested portion of their fund account. Loans must be repaid to TIAA-CREF by the participant in accordance with the repayment terms of the agreement. In the event of default, foreclosure on the participant's account balance will not occur until a distributable event occurs in the Plan, as defined. The amount of such outstanding loans was \$9,003 and \$22,793 at August 31, 2024 and 2023, respectively.

Notes Receivable From Participants

During plan year 2021, the Plan began issuing participant loans which are considered Plan assets and included in the accompanying financial statements. Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the vested portion of their fund account. Notes to participants are treated as a separate investment of the participant and all principal and interest payments on note balances are credited to the participant account from which the note was made. Notes are secured by the balance in the participant's account and bear interest between 4.25% and 9.50% at August 31, 2024. Principal and interest are paid directly by the participant in accordance with the repayment terms of the agreement.

Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination. A participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in an annuity, lump-sum, or in annual installments if the account balance is greater than \$1,000 under certain conditions. The Plan provides that distributions of amounts of \$1,000 or less are paid as lump-sums. Under certain circumstances, participants may qualify to receive a hardship distribution (less applicable income taxes and penalties) from their account balance. Upon reaching 59-1/2 years of age, a participant may receive an in-service distribution prior to separation from service.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. The administrative expenses as of August 31, 2024 was \$4,237.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of August 31, 2024. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through January 17, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3 defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Fair values of accumulation units held by the Plan in the pooled separate accounts are based on each account's daily net asset value ("NAV"), which is considered by Plan management to be the best approximation of fair value. These investments are registered with the U.S. Securities and Exchange Commission under the Investment Company Act of 1940 as an open-end management investment company. The pooled separate accounts invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives. The fair value of the underlying securities, which is based on quoted prices of similar assets, is used to determine the NAV of the pooled separate account which is not publicly quoted.

Annuity contract: The annuity contract is not available for sale or transfer. Accordingly, fair value is not observable and the issuer of the annuity contract, Teachers Insurance and Annuity Association of America (TIAA), values the investments based on accumulated cash contributions, interest credited to the contract, transfers, and withdrawals.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Tax Status

The Internal Revenue Service has determined and informed the Sponsor by a letter that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA.

Note 6: Party-in-Interest

Certain plan investments are managed by TIAA-CREF, the Plan custodian. These transactions qualify as party-in-interest transactions. These transactions are not considered prohibited transactions under ERISA regulations. Fees incurred and paid by the Plan for the investment management services during the plan year ended August 31, 2024 are offset against earnings.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Information Prepared and Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at August 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended August 31, 2024, was obtained or derived from information certified as complete and accurate by TIAA-CREF, custodian of the Plan.
