## INDEPENDENT AUDITOR'S REPORT

To The Plan Committee  
Markstein Beverage Retirement Savings Plan  
Sacramento, California

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Markstein Beverage Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (*in liquidation*) as of July 31, 2024 and 2023, and the related statements of change in net assets available for benefits (*in liquidation*) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended July 31, 2024 and 2023 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter***

As further discussed in Note 1 to the financial statements, the governing body of the Plan approved the termination of the plan on July 7, 2023, and management determined liquidation is imminent. As a result, the Plan is presented on a liquidation basis of accounting for both the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore there is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedules Required by ERISA***

The supplemental schedules of delinquent participant contributions and assets held at end of year as of and for the year ended July 31, 2024, are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO FINANCIAL STATEMENTS

July 31, 2024 and 2023

#### NOTE 1: DESCRIPTION OF PLAN

The following description of the Markstein Beverage Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan was established effective August 1, 1987, to provide retirement benefits for employees of the Plan Sponsor. The Plan Sponsor consists of a controlled group of employers with common ownership. The controlled group of employers consists of: Markstein Beverage Co. of Sacramento, Markstein Beverage Co., and Delta King LLC. The Plan is administered by a committee appointed by the Plan Sponsor. Fidelity Management Trust Company is the Plan custodian as well as the trustee of the Plan. The Plan is designed to comply with section 401(k) of the Internal Revenue Code (the “Code”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined contribution plan covering employees of the Plan Sponsor that have attained the age of twenty-one (21) years and completed three months of service, except those covered by a collective bargaining agreement. As disclosed under “Plan Termination”, the Plan was amended to provide that no new participants will be admitted to the Plan as of July 7, 2023.

Effective April 14, 2023, the Plan was amended to remove the requirement that participants must be employed on the last day of the Plan year and have 1,000 hours of service during the Plan year to be eligible for employer discretionary contributions. The Plan was also amended on this date to provide that participants are 100% vested in employer discretionary contributions and employer non-discretionary matching contributions.

##### **Plan Termination**

The governing body of the Plan elected to terminate the Plan effective July 7, 2023 (“Termination Date”). As a result, the governing body of the Plan made the following directives in connection with the termination of the Plan:

- To provide that all employees are terminated as of the Termination Date;
- To provide that no new participants are to be admitted to the Plan as of the Termination Date;
- To discontinue employer contributions to the Plan as of the Termination Date;
- To provide that participants are 100% vested in their account balances as of the Termination Date;
- To disallow any future participant loans as of the Termination Date.

The Plan Sponsor approved to distribute all of the benefits under the Plan to the plan participants, the beneficiaries of any deceased participants, and any participant’s alternative payee pursuant to a qualified domestic relations order, as soon as administratively feasible after October 2, 2023.

##### **Plan Year**

The Plan year begins August 1 and ends July 31.

##### **Contributions to the Plan**

The Plan allows for the following types of contributions:

##### **Employee Salary Deferral 401(k) Contributions**

The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Code. Employees are automatically enrolled into the Plan upon eligibility. The automatic enrollment contribution percentage is 3%; however, employees may voluntarily contribute up to 60% of their eligible compensation, subject to various nondiscrimination tests and limitations prescribed by the Code, and they may choose to opt out of the automatic enrollment. Participants may make after-tax Roth elective salary deferral contributions. As disclosed under “Plan Termination”, effective July 7, 2023, employee salary deferral 401(k) contributions will no longer be made to the Plan.

NOTE 1: **DESCRIPTION OF PLAN (Continued)**

**Contributions to the Plan (Continued)**

*Employer Non-Discretionary Matching Contributions*

The Plan Sponsor makes a non-discretionary matching employer contribution of 50% for each employee deferral, up to the first 6% of eligible compensation. As disclosed under “Plan Termination”, effective July 7, 2023, employer non-discretionary matching contributions will no longer be made to the Plan.

*Employer Discretionary Contributions*

The Plan Sponsor may elect to make a discretionary non-elective employer contribution which is allocated to participant accounts according to respective allocation groups. Any amounts allocated to an allocation group are allocated as a uniform percentage of eligible compensation. Participants are eligible for discretionary contributions after completing one year of service and must be employed on the last day of the Plan year and have 1,000 hours of service during the Plan year. The Plan Sponsor elected to not make a discretionary non-elective employer contribution in 2024 but elected to make a contribution in 2023.

As disclosed under “Plan Termination”, effective July 7, 2023, employer discretionary contributions will no longer be made to the Plan.

*Employee Rollover Contributions from Another Qualified Plan*

Participants may make rollover contributions from another qualified plan. As disclosed under “Plan Termination”, effective July 7, 2023, all participants are terminated and therefore the Plan will no longer allow rollover contributions to be made to the Plan.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, rollover contributions, employer contributions and an allocation of Plan earnings and certain Plan expenses, as defined by the Plan document. The yield (interest, dividends, and net realized and unrealized gains and losses) on investments is allocated to each participant’s account based on each participant’s pro rata share of the total investments in the particular fund. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant’s vested account.

**Forfeitures**

Forfeitures may be used to pay reasonable Plan expenses and reduce the amount of employer discretionary contributions for the Plan year in which the forfeiture occurs. Forfeitures of \$0 and \$325,000 were used to reduce employer contributions received in 2024 and 2023, respectively. Forfeitures of \$9,832 and \$0 were used to pay Plan expenses in 2024 and 2023, respectively. At July 31, 2024 and 2023, forfeiture ending balances included in Plan net assets were \$0 and \$9,832, respectively.

**Allocations**

The Plan provides various investment fund options and allows participants to self-direct their contributions and investments. Investment earnings and losses are allocated to participants’ accounts based on the earnings or losses of the investments selected.

**NOTE 1: DESCRIPTION OF PLAN (Continued)**

**Vesting**

Participants are immediately vested in their voluntary contributions. All employer contributions are subject to a graded vesting schedule as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

For vesting purposes, a year of service is equivalent to 1,000 hours of service during the Plan year.

As disclosed under “Plan Termination”, effective July 7, 2023, participants are 100% vested in all employer contributions.

**Retirement**

Normal retirement age under the Plan is age 65.

**Notes Receivable from Participants**

The Plan allows participants to borrow against their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50%, of their vested account balance, reduced by any outstanding loan balance. The loans are secured by the balance in the participant’s account and bear interest charged at a commercially reasonable rate as determined by the Plan’s administrator. Principal and interest are paid ratably, and loan periods range from one to five years, except for loans made for the purchase of a principal residence, which may permit a longer repayment term.

As disclosed under “Plan Termination”, effective July 7, 2023, participant loans from the Plan are disallowed.

**Payment of Benefits**

Payment of benefits may be made at the following times under the Plan: 1) normal retirement; 2) termination of employment of the participant; 3) death of the participant; 4) upon demonstration of financial hardship; 5) attainment of age 59 ½; or 6) disability of the participant.

Benefit payments are made in installment or lump sum payments.

**Administrative Expenses**

Fees and expenses incurred in the administration of the Plan, to the extent not paid by the Plan Sponsor, are charged to, and paid from the Plan’s assets. Expenses related to specific participant transactions are charged to the respective participant’s account.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan’s financial statements for the years ended July 31, 2024, and 2023 are presented using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) as a result of the Plan Termination. The adoption of the liquidation basis of accounting did not have a material impact on the Plan’s financial statements.

*NOTE 2:* **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Investment Valuation and Income Recognition**

Investments are stated at fair value based on quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Increases in the share values of investments are reflected in each participant's self-directed account. Investments are valued daily.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of July 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Taxes**

The Plan adopted a volume submitter plan which obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable under Section 401 of the Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of July 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by taxing authorities; however, there are currently no examinations for any tax periods in progress.

**Estimates and Assumptions**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 5: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 5: FAIR VALUE MEASUREMENTS (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at July 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Account:* Underlying short-term investments with quoted prices in active markets to preserve the value of the investment at \$1.00 per share.

*Common Collective Trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee of the fund, is based on the fair value of the underlying mutual fund investment held by the collective trust. Collective trust investments include a stable value fund that is composed primarily of fully benefit-responsive investment contracts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Brokerage Accounts:* Valued at the daily closing price as reported by the underlying investments. Brokerage accounts consist primarily of mutual funds and common stocks.

**NOTE 6: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 7: PLAN TERMINATION**

The Plan Sponsor may terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their account balances. The Plan was terminated effective July 7, 2023.

**NOTE 8: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments include shares of individual brokerage accounts, mutual funds, and a money market account managed by Fidelity Management Trust Company (Fidelity). Fidelity is the trustee as defined by the Plan and, therefore, these investments qualify as party-in-interest transactions. Fees paid by the Plan for investment management and advisory services are recorded in net appreciation (depreciation) in fair value of investments. Fees for certain administrative expenses are paid to Fidelity, the record keeper and third-party administrator of the Plan. Notes receivable from participants are considered party-in-interest transactions. These investments and transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 9: PROHIBITED TRANSACTION**

During the Plan year ended July 31, 2022, the Plan Sponsor failed to remit \$732 of participant contributions to the Plan in a timely manner as defined by ERISA.

**NOTE 10: SUBSEQUENT EVENTS**

Plan management evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through January 21, 2025, the date the financial statements were available to be issued. Plan management has determined there are no events that have occurred that should be disclosed.
