All distributions were completed by December 31, 2021.

1. Description of Plan

The following description of the Liberty Power Corp, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Reference to the Plan document should be made for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan allowing all employees of Liberty Power Corp., LLC (the “Employer”) that elected to participate. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination

On May 28, 2021, as discussed in Note 1 to the accompanying financial statements, Liberty Power Corp, approved an agreement to terminate the Plan. In accordance with accounting principles generally accepted in the United States of America, effective May 28, 2021, the Plan changed its basis of accounting to the liquidation basis. All distributions were completed by December 31, 2021.

Contributions

Contributions to the Plan were made by the participants and the Employer. Participants were able to defer up to the applicable Internal Revenue Service (“IRS”) limit, which included Pre-Tax Elective Deferrals and Roth Elective Deferrals. Additionally, participants were able to rollover or transfer to the Plan any portion or all of the property received from another qualified employee benefit trust (rollover contribution).

In addition, the Employer made fully-vested safe harbor matching contributions and/or discretionary contributions, at the option of the Employer’s Board of Directors. For the 2021 and 2020 Plan years, the Employer made safe harbor matching contributions of approximately \$96,000 and \$330,000, respectively, which matched 100% of each participant’s salary deferrals that did not exceed 4% of participant’s eligible compensation.

Participant Accounts and Vesting

Each participant’s account in the Plan was credited with the participant’s contribution, an allocation of any Employer contribution and the Plan’s earnings. Allocations of earnings were based on participants’ account balances, as defined. Employer matching contributions were allocated proportionately to participant elective contributions for all eligible participants. Any additional discretionary Employer contributions were allocated based on the ratio of the participant’s compensation to the total compensation of all eligible participants for the Plan year. The benefit to which a participant was entitled is the benefit that can be provided from the participant’s vested account. Forfeitures were used to reduce future Employer contributions to, and/or expenses of, the Plan. There were no forfeitures in 2021 and 2020.

All participants were immediately vested in their accrued benefits derived from their elective contributions and Employer safe harbor contributions plus earnings thereon. Vesting in the additional discretionary Employer contribution (Employer matching and profit sharing contributions) was based on years of service.

Payment of Benefits

Upon termination of service, depending on circumstances, participants received payment with respect to a participant's vested account balance as a lump sum distribution of the entire vested account balance, single sum distribution of a portion of the participant's vested account balance, installments for a specified term, installments for required minimum distributions only, or annuity payments over a period not to exceed a participant's lifetime.

In certain hardship situations, as described in the Plan Agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship.

Notes Receivable from Participants

A participant was able to borrow a minimum of \$500 from their fund accounts up to a maximum equal to the lesser of: (a) \$50,000 or (b) 50% of the participant's vested account balance. Participants could only have one loan outstanding at any point in time. Interest on the notes receivable from participants was based on comparable market rates. Loans and interest were repaid ratably through payroll deductions. Interest rates ranged from 4.25% to 6.50% as of December 31, 2021 and 2020, which were commensurable with local prevailing rates as determined by the Plan Administrator. Notes receivables from participants amounted to approximately \$0 and \$112,000 at December 31, 2021 and 2020, respectively.

Investment Options

Participants directed employee contributions and any Employer safe harbor contributions into any of several investment options including money market, equity, and fixed income mutual fund investments. Participants could change their investment options at their discretion.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates, including those regarding fair value, and assumptions that affect the reported amounts and disclosure of contingent liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

Investment Management Fees and Operating Expenses

Investment management fees and operating expenses charged to the Plan for investments in the various funds were deducted from income earned and were reflected as a component of net appreciation in fair value of investments.

Administrative Expenses

The Plan agreement allowed for all administrative expenses to be paid by either the Employer or the Plan. For the year ended December 31, 2021 and 2020 administrative expenses were \$10,117 and \$2,713, respectively, which were paid by the Plan.

Tax Status

The Plan adopted its latest Prototype Non-Standardized Profit Sharing Plan with a cash or deferral arrangement developed by ADP, LLC., effective July 16, 2014, which obtained a favorable IRS determination letter on July 16, 2014 in which the IRS stated that the form of the underlying prototype plan was acceptable under provisions of the Internal Revenue Code (“Code”) and that any employer adopting this form of the Plan will be considered to have a plan qualified under the Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2021 and 2020, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2018.

Subsequent Events

The Plan has evaluated subsequent events from the date of the Statements of Net Assets Available for Benefits (liquidation basis) through October 13, 2022, which is the date the financial statements were available to be issued.

3. Risk and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks.

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2 Inputs other than quoted prices include within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

Registered investment companies: Valued at quoted market prices in active markets.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Party-in-Interest Transactions

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Notes receivable from participants are also considered party-in-interest transactions.
