## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Vanguard Charitable Endowment Program Money Purchase Pension Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

In preparing the financial statements, Plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Vanguard Charitable Endowment Program Money Purchase Pension Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Plan management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the 2024 Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Vanguard Charitable Endowment Program Money Purchase Pension Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **2024 Supplemental Schedule Required by ERISA**

The supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of June 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of Plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that Plan management determined meets the requirements of ERISA Section 103(a)(3)(C).

We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting Review Services Committee of the American Institute of Certified Public Accountants. Accordingly, we do not express an opinion, a conclusion, or provide any assurance on the 2023 financial statement.

## Notes to Financial Statements

### As of June 30, 2024 and 2023 and for the Year Ended June 30, 2024

---

#### 1. Description of Plan

The following description of the Vanguard Charitable Endowment Program Money Purchase Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution, money purchase pension plan qualified under section 401(a) of the Internal Revenue Code of 1986, as amended (the “Code”) and is, therefore, exempt from federal income taxes under the provisions of section 501(a) of the Code. The Plan covers all eligible employees of Vanguard Charitable Endowment Program (the “Plan Sponsor”), except leased employees. Eligible employees must be 21 years of age and complete one year of eligible service to participate in the Plan. Upon meeting the eligibility requirements of the Plan, participants are able to enter the Plan on the first day of each month. The Plan has satisfied the minimum funding requirements of ERISA. The Plan was established July 1, 1999 and was most recently amended July 1, 2021. Ascensus Trust Company (“Ascensus”) is the trustee and The Vanguard Group (“Vanguard”) is the recordkeeper.

##### **Contributions**

Each pay period, the Plan Sponsor will contribute 15% of eligible compensation to each participant’s account. Participants direct the investment of all contributions into various investment options offered by the Plan.

##### **Participant Accounts**

Each participant's account is credited with the Plan Sponsor contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of certain administration expenses that are paid by the Plan, except for participant directed fees, which are charged directly to the respective participant’s account. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Vesting of the Plan Sponsor contributions occurs at a rate of 20% each year beginning after 2 years of eligible service. Participants become fully vested after six years of service or upon death or disability.

##### **Forfeitures**

As of June 30, 2024 and 2023, forfeited non-vested accounts totaled \$85,566 and \$55,742, respectively. Forfeitures are used to pay administrative expenses or reduce Plan Sponsor contributions. During the year ended June 30, 2024, \$18 of forfeitures were used to pay administrative expenses and \$0 of forfeitures were used to offset Plan Sponsor contributions.

##### **Payment of Benefits**

Upon termination of service, death, disability, or normal retirement (age 62), a participant may elect to receive a lump sum up to the value of the participant’s vested interest in his or her account; a participant who has reached normal retirement age but has not terminated service is also entitled to a distribution. Partial payments may be selected; participants are also permitted to apply their payment to purchase an annuity contract. If a participant’s vested account balance is less than \$1,000 upon termination, a distribution of the participant’s account may be made automatically in a single lump-sum cash distribution. If a participant and their spouse choose the survivor annuity for a distribution, the portion of the qualified joint and survivor annuity is 50% of the amount paid to the participant before their death.

#### 2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Contributions**

Contributions from the Plan Sponsor are recorded in the year in which the participant's compensation is earned.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measure date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee, recordkeepers/custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

All reasonable administrative expenses, including trustee, custodial and third-party administration fees necessary to operate and administer the Plan are paid by the Plan. Expenses of maintaining the Plan that are paid directly by the Plan Sponsor are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature elected by that participant, and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

**Subsequent Events**

Management evaluated subsequent events for the Plan through January 21, 2025, the date the financial statements were available to be issued.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audit of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, LLC, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value as reported in the statement of net assets available for benefits as of June 30, 2024.
- Investment activity, including net appreciation in fair value of investments and dividends and interest income, as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024.
- The information for the mutual funds (registered investment companies) listed in the schedule of assets (held at end of year) as of June 30, 2024, as shown in the ERISA-required supplemental schedule.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodologies used as of June 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future returns. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Plan Sponsor contributions for which they were not already vested and the trustee would distribute account balances as permitted by the Plan document.

**6. Tax Status**

The Plan was amended and restated on July 1, 2021 by adopting a pre-approved plan designed by Ascensus, LLC. The Internal Revenue Service (“IRS”) issued an opinion letter, dated June 30, 2020, stating that the pre-approved plan document was designed in accordance with applicable Internal Revenue Code (“IRC”) requirements as of that date. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to June 30, 2021.

**7. Related-Party and Party-In-Interest Transactions**

Transactions involving Ascensus Trust Company, trustee and recordkeeper of the Plan, are considered party-in-interest transactions. Additionally, Vanguard provides, through an outsourcing agreement with Ascensus, LLC, recordkeeping services and the Plan invests in registered investment companies managed by Vanguard. For the year ended June 30, 2024, the Plan paid fees of \$13,675. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA

**8. Risks and Uncertainties**

The Plan provides for various investment options to its participants. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
