Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Conformis, Inc. 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of the Plan

The following description of the Conformis, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General, Plan Merger and Termination

The Plan was a defined contribution plan with a cash deferral arrangement established in January 2004 and most recently restated on October 1, 2019. The Plan covered all employees, except union, interns, residents of Puerto Rico and leased employees, who have attained the age of 18 (“Participants”). Employees of ConforMIS, Inc. (the “Employer”) became eligible to participate on the first day of the month following the date of hire. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Substantially all investments are participant-directed.

On August 31, 2023, the Shareholders of The Plan Sponsor voted to approve the acquisition by Restor3d. The Plan was amended on December 18, 2023 to freeze or close the Plan to new participants as well as the accrual of future benefits effective December 31, 2023. On January 4, 2024, plan management notified John Hancock that the Plan was being moved to Insperty Retirement Services and the Insperty 401(k) Plan and accordingly, on March 31, 2024, all plan assets were transferred to the Insperty 401(k) Plan. As a result of the merger, this Plan was terminated.

Participant Contributions

Participants were able to elect to defer up to 100% of their pre-tax compensation, subject to dollar limits set by federal law. The Plan had an auto enroll feature at an initial 5% deferral rate. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Participant Rollovers”).

Employer Contributions

Discretionary Matching Contributions

Employer matching contributions to the Plan were discretionary and determined each Plan year. For the period ended March 31, 2024, there were no Employer matching contributions.

Non-Elective Contributions

The Employer, at its sole discretion, was able to make non-elective contributions to the Plan subject to certain limitations. All eligible participants were able to receive non-elective contributions, whether or not they were employed on the last day of the Plan year. Allocations of the non-elective contribution were made among eligible participants based on the ratio that each participant’s eligible compensation bears to the total eligible compensation of all eligible participants. There were no non-elective contributions made during the period ended March 31, 2024.

Note 1 - Description of the Plan (Continued)

Participant Accounts

Each participant's account was credited with the participant's contribution and an allocation of (a) the Employer contributions, (b) Plan earnings (losses) and (c) administrative expenses. Allocations were based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the Participant's vested account balances.

Vesting

Participants were always fully vested in their voluntary contributions and rollover accounts plus actual earnings (losses) thereon. For terminations prior to January 1, 2018, a participant began vesting in the Employer matching and non-elective contributions after 1 year of service and became 100% vested after 5 years of service. For terminations beginning on or after January 1, 2018, the Plan's vesting schedule was amended to vest participants at an increased rate beginning after 1 year of service and became 100% vested after 3 years of service. A participant also became fully vested upon reaching normal retirement age or due to death or disability.

Payment of Benefits

In-service withdrawals from a participant's rollover account were permitted at any time. Participants could withdraw all or part of their elective deferrals account upon reaching age 59½. Hardship withdrawals were permitted from a participant's vested accounts. The amount of hardship distribution cannot exceed the amount needed to meet immediate financial hardship. Upon termination of service, retirement, death or disability, a participant could elect to receive either a lump-sum payment or annual installment payments equal to the vested account balance. If a participant's vested account was less than \$5,000, the Plan administrator automatically distributed the account balance to the Participant.

Notes Receivable from Participants

Participants could borrow a minimum of \$500 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may have only one loan outstanding at a time. Loan terms were up to five years, or longer if for the participant's principal residence. The loans were secured by the balance in the Participant's account and bear interest at a reasonable rate of interest to be determined by the Plan administrator. Principal and interest were paid ratably through payroll deductions.

Plan Administration

The Employer was the Plan administrator and had the authority to appoint persons or entities to carry out the operation of the Plan. The Plan's trustees, as defined by the Plan document, were an officer of the Employer and Matrix Trust Company.

Forfeitures

A participant who left the employ of the Employer forfeited any non-vested balance at the end of the earlier of five consecutive one-year breaks in service or the distribution of the Participant's entire vested account. Forfeited balances were used to reduce Employer contributions or pay Plan expenses. Total unapplied forfeitures were \$113,558 as of December 31, 2024. The unused forfeiture balance was transferred to the new Plan. Total unapplied forfeitures were \$0 as of March 31, 2024.

Administrative Expenses

The Plan expenses were paid either by the Plan or the Employer. Expenses that were paid directly by the Employer were excluded from these financial statements. Individual participant accounts were charged directly for notes receivable from participants' recordkeeping and benefit disbursement processing fees, if applicable, and terminated participants paid an annual maintenance fee. In addition, certain investment related expenses were included in net appreciation in fair value of investments.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustees/custodians.

Purchases and sales of securities were recorded on a trade-date basis. Interest and dividend income was recorded on the accrual basis and dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Unit Values

Individual participant accounts for the common/collective trusts were maintained on a unit value basis. Participants did not have beneficial ownership in the specific underlying securities or other assets in the accounts but did have an interest therein represented by units which are valued daily. The accounts earned dividends and interest which were automatically reinvested in additional units. Generally, contributions to and withdrawals from each account were converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts were charged or credited with the number of units properly attributable to each participant.

Benefits Paid

Benefits were recorded when paid.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2023.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could vary from the estimates that were used.

Subsequent Events

The Employer has evaluated subsequent events through January 15, 2025, the date that the financial statements were available to be issued. Other than the Plan merger reflected in Note 1, there were no other significant matters that were identified for disclosure during this evaluation.

Note 3 - Information Certified by the Custodian

Plan investments were held by John Hancock Trust Company, LLC. The fair value of all investments and notes receivable from participants as of December 31, 2023 and all investment and notes receivable from participant transactions for the period January 1, 2024 through March 31, 2024, including interest and dividend income and net appreciation in fair values, were certified as complete and accurate by John Hancock Trust Company, LLC.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements. The Plan offered investment choices to allow participants to create a diversified portfolio of assets based on the Participant's risk tolerance. Participants were able to direct their contributions as well as Employer contributions to any of several investment options.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units in Common/Collective Trust Funds

Valued at the NAV of units of a common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 6 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Market risks included global events such as international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities through the date of merger and as of December 31, 2023 would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments were managed by John Hancock Trust Company, LLC ("John Hancock"). John Hancock was the custodian of the Plan, and therefore, those transactions qualified as party-in-interest transactions. Those transactions were exempt from the prohibited transaction rules, as defined by ERISA. There were \$25,290 of fees paid to John Hancock and other service providers for the period ended March 31, 2024. Notes receivable from participants also qualified as exempt party-in-interest transactions.

Note 8 - Tax Status

The Plan adopted the Volume Submitter Profit Sharing Plan with CODA and obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"). The Plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the Code and continued to qualify under Section 401(a) and the related trust continued to be tax-exempt. Therefore, no provision for income taxes was included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
