Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of North Park University Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of April 1, 2023 and June 30, 2022, the related statement of changes in net assets available for benefits for the period ended April 1, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of April 1, 2023 and 2022, and for the period ended April 1, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

1. DESCRIPTION OF THE PLAN:

The following brief description of the North Park University Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Document for a more complete description of the Plan's provisions.

GENERAL

The Plan is a 403(b) retirement plan established January 16, 1976, covering all eligible employees of North Park University (the University). Other than students, all full-time employees are eligible to make voluntary deferrals to the Plan for the first two years of service. Upon reaching two consecutive years of service, eligible employees are automatically enrolled in the Plan. The University counts prior years of full-time service at a prior employer if that employer was allowed by law to have a 403(b) retirement plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 10, 2023, the Plan merged into the Illinois Independent Colleges and Universities Multiple Employer Plan (FIICU MEP), a joint retirement plan. The assets of the Plan merged into the MEP on April 1, 2023. The MEP is partnering with TIAA as record keeper. The cost of the plan and administrative duties will be shared among the schools in the Plan.

CONTRIBUTIONS

Eligible participants may make voluntary deferral contributions to the Plan upon hire. After two consecutive years, eligible participants are required to make mandatory deferrals and receive employer contributions based on a years-of-service threshold. The schedule for mandatory participant deferrals and employer contributions is as follows for the year ended April 1, 2023:

<u>Years of service</u>	<u>Participant</u>	<u>Employer</u>
Less than 2 years	0%	0%
2 years but less than 7 years	5%	5%
7 years but less than 12 years	2.5%	7.5%
12 years or more	0%	10%

Participants who have attained age 50 and/or have 15 years of service before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations prescribed by law. Participants direct the investment of all contributions into various investment options offered by the Plan.

1. DESCRIPTION OF THE PLAN, continued:

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the University's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are vested immediately in all contributions and earnings thereon.

PLAN LOANS

Participants may borrow from TIAA a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans, totaling \$49,382 and \$94,516 as of April 1, 2023 and June 30, 2022, respectively, are secured by the balance in the participant's account and bear interest at rates from 4.23% to 5.73%. The loans are not considered assets of the Plan and therefore are not included on the statements of net assets available for benefits.

PARTICIPANT LOANS

Effective July 1, 2020, participants may borrow from their participant accounts. The notes are secured by the balance in the participant's account and bear interest at a rate of 4.25-9.00%. The outstanding participant loan balances totaled \$110,187 and \$128,140 as of April 1, 2023 and June 30, 2022, respectively. Participant loans are reported as notes receivable from participants on the statement of net assets available for benefits.

PAYMENT OF BENEFITS

Upon termination of service, disability, or attaining age 59 1/2, participants with vested account balances greater than \$1,000 generally receive payments in the form of a lump sum or purchase of annuity contracts. Hardship disbursements may be taken from a participant's elective deferrals only. Other forms of payment are available, providing that the participant, and spouse if married, waive the annuity form of payment. Terminated participants with vested account balances of \$1,000 or less will receive a single lump-sum payment.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded based on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

3. INFORMATION CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTIONS:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements was obtained from data that has been prepared and certified as complete and accurate by TIAA and CREF, the qualified institution of the Plan. TIAA, FSB is the custodian of Plan assets invested in mutual fund shares and has authorized TIAA to certify investments held by TIAA, FSB.

4. FAIR VALUE MEASUREMENTS, continued:

Non benefit responsive fixed annuity contracts are reported at contract value, which represents fair value. The contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Mutual funds are primarily valued using market quotations or prices obtained from independent pricing sources. Variable annuity contracts are funded through a separate account that invests in mutual funds. The underlying investments are primarily valued using market quotations or prices obtained from independent pricing sources. The fair value of the pooled separate account units are principally derived using market quotations or prices obtained from independent pricing sources.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANIES:

The Plan has benefit-responsive guaranteed investment contracts with TIAA and AIG Retirement Services (AIG). TIAA and AIG maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by TIAA and AIG represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at April 1, 2023 and June 30, 2022, was \$0 and \$3,221,047, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity date.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. TAX STATUS:

The Plan has adopted a volume submitter plan document sponsored by TIAA. The volume submitter plan document has obtained an opinion letter from the Internal Revenue Service (IRS) dated August 8, 2017, which states that the volume submitter document satisfies the applicable provisions of the Internal Revenue Code. The Plan has not received a determination letter from the IRS; however the Plan administrator and the Plan's counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through January 22, 2025, which represents the date of the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
