Independent Auditor's Report

To the Plan Administrator and Participants
of the OSIsoft, LLC Section 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the OSIsoft, LLC Section 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of May 1, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 to May 1, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 1, 2024 and December 31, 2023, and for the period January 1, 2024 to May 1, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance

with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation



and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Plan Merger

As further discussed in Note 1, effective May 1, 2024, the Plan was merged into the AVEVA Inc. 401(k) Plan (“AVEVA Plan”) and all plan assets were transferred to the AVEVA Plan in accordance with the provisions of ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the OSISOFT, LLC Section 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

In 2021, OSISOFT, LLC ("the Company" or "Plan Administrator") was acquired by AVEVA Group plc. Effective May 1, 2024, the Plan was merged into the AVEVA Inc. 401(k) Plan ("AVEVA Plan") and total plan assets of \$252,112,149 were transferred from this plan to the AVEVA Plan in accordance with the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

General - The Plan is a defined contribution plan that was established on December 1, 1984 by the Company covering all eligible employees of the Company as defined in the Plan agreement. Certain classes of employees as defined in the Plan agreement are excluded from plan participation. The Plan is subject to the provisions of ERISA.

A Plan Committee ("the Committee") managed the operation and administration of the Plan, including the appropriateness of the Plan's investment offerings and investment performance. The Company contracted with Fidelity Management Trust Company ("Fidelity") to act as trustee, custodian, and record-keeper to process and maintain the records of participant data.

The provisions of SECURE 2.0 Act of 2022 continue the themes and reforms that began with the 2019 SECURE Act. Certain provisions of both Acts have been implemented by the Plan. Effective January 1, 2024, the Plan was amended to exclude the value of restricted stock, qualified or non-qualified stock options granted and amounts paid to an employee to reduce student loan repayment obligations from eligible compensation in the Plan. Participants should refer to plan documents for specific changes made to the Plan.

Contributions - Each year, participants could contribute an amount of eligible pre-tax annual compensation and voluntary after-tax contribution as defined in the Plan agreement, not to exceed the maximum statutory amount or 75% of eligible compensation. The Plan allowed for automatic enrollment for eligible employees as defined in plan documents with a deferral rate of 6% which was increased by 1% each year, unless the employee elected differently. The Plan allowed for ROTH deferral contributions. Participants who are age 50 or older could elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. Participants could also contribute amounts representing distributions from other qualified eligible plans.

The Plan allowed for an employer discretionary matching contribution subject to certain eligibility requirements. For the period January 1, 2024 to May 1, 2024 and the year ended December 31, 2023, the Company matched 100% of a participant's deferrals up to 6% of the participant's eligible compensation. The total discretionary matching contribution for the period January 1, 2024 to May 1, 2024 was \$2,558,706. The total discretionary matching contribution for 2023 was \$7,448,033, of which \$485,958 was a receivable as of December 31, 2023 and was paid in 2024. The Plan also allowed for an employer discretionary non-elective contribution subject to certain eligibility requirements; none was made for the period January 1, 2024 to May 1, 2024.

Participant Accounts - Each participant's account was credited with the participant's contribution, the Company's discretionary matching contribution, an allocation of the discretionary non-elective contribution (if any), plan earnings and losses, and plan expenses as applicable to the Plan. Allocations of the discretionary non-elective employer contribution were based on participant compensation. Allocations of plan earnings and losses were based on individual participant investment choices. All contributions/investments were participant directed. The benefit to which a participant was entitled was the benefit that could be provided from the participant's account.

Vesting - Participants were 100% vested in their accounts at all times.

Notes Receivable from Participants - Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever was less. The notes were secured by the balance in the participant's account and bear interest at rates which were commensurate with prevailing rates as determined by the Plan Administrator. There are no outstanding notes receivable from participants as of May 1, 2024. Outstanding notes receivable from participants as of December 31, 2023 carried interest rates which range from 4.25% to 9.50%. Principal and interest were paid per the terms of the note and in accordance with plan provisions. The Plan Administrator established the specific terms and conditions of such notes.

Payment of Benefits - Upon the satisfaction of certain distributable events, participants or their beneficiaries could elect to receive their account balance and were paid in accordance with plan provisions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by Fidelity. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Contributions - Contributions from plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability. As of May 1, 2024 and December 31, 2023, there were no material excess contributions payable.

Plan Expenses - For the period January 1, 2024 to May 1, 2024, some plan fees were paid by the Company and these amounts are excluded from the Plan's financial statements. Certain participant transaction fees, investment advisory fees, investment/fund fees, and recordkeeping fees were paid through the Plan and charged to participant accounts when applicable. The Plan has a Revenue Credit Program which is funded by participants and can be used to pay certain plan fees. In situations where recordkeeping revenue received in connection with plan services exceeds agreed-upon compensation, Fidelity can allocate such excess revenue to eligible participants as Revenue Credits.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events through January 17, 2025, the date the financial statements were available to be issued.

NOTE 3 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at May 1, 2024 and December 31, 2023, dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants for the period January 1, 2024 to May 1, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 1, 2024 and December 31, 2023.

BrokerageLink Accounts: Accounts primarily consist of various types of marketable securities which are valued on the basis of readily determinable market prices listed on publicly traded exchanges. Cash is valued on a cash equivalency basis.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts: The trusts are valued at fair value based on the underlying investments which are actively traded funds and various securities. The unit value is calculated based on a compilation of primarily observable market information based on the underlying assets. The number of units of the trust that are outstanding on the calculation date is derived from observable purchases and redemption activity in the trust. The NAV is used as a practical expedient to estimate fair value for the trusts. This practical expedient would not be used if it is determined to be probable that the trusts will sell the investments for an amount different from the reported NAV. For the collective investment trusts, there are no unfunded commitments, the units can be redeemed daily, and there is no redemption notice period.

NOTE 6 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Plan investments were held by Fidelity. Any purchases and sales of these investments are performed in the open market at fair value. Plan related fees were paid to Fidelity and an investment advisory firm. The Plan had other service providers. All these transactions while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 7 - TAX STATUS

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated June 30, 2020 from the IRS. The Plan has been amended since, however, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The differences between the information reported on the financial statements and the information reported on the Form 5500 arise primarily from presenting the financial statements on the accrual basis of accounting and Form 5500 on the cash basis.
