### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Acuant Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the Acuant Inc. 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that was adopted by Acuant Inc. (the Company), effective June 29, 2020, and is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code of 1986 (IRC), as amended. The Plan was formed in 2020 in order to move out of a "multiple" employer plan and form a separate plan for employees of the newly reorganized plan sponsor. The purpose of the Plan is to provide retirement benefits for all employees who meet the Plan's eligibility requirements. The Plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility**

Employees are eligible to participate in the employee deferral and employer matching contributions of the Plan immediately upon hire. Participants are also eligible for a discretionary profit-sharing contribution if they meet the eligibility requirements above and are employed on the last day of the Plan year.

**Contributions**

Participants may opt out or change their deferral rates at any time. Participants may contribute up to 100% of their pretax annual compensation not to exceed the maximum deferral limitation, as defined in the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, which are presented as rollover contributions in the statements of changes in net assets available for benefits. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may elect to contribute after-tax contributions to a Roth account as defined by the Plan. In accordance with the plan document, the Company makes safe harbor matching contributions of 100% of participant contributions, up to 4% of plan compensation. The Company may also make a matching or profit-sharing contributions to the Plan each year.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions, and allocations of plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants vest immediately in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20% vested each year after two years of service and is considered to be 100% vested after six years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**Benefit Payments**

If a participant's employment ceases as a result of death or disability, the entire account becomes fully vested and the participant or the participant's beneficiary(ies) is entitled to receive the contents of the account. If participation is terminated for any other reason, the participant is entitled to receive only the vested percentage of the account. Participants or their beneficiaries may elect to receive benefits in a single lump sum or in installments. Vested balances less than \$1,000 may be distributed in a lump-sum amount without the participant's consent, and vested balances between \$1,000 and \$5,000 may be automatically rolled into a qualified individual retirement account in the participant's name without his or her consent. Additionally, under certain circumstances of financial hardship or upon attaining the age of 59½, participants are allowed to withdraw funds from the Plan.

**Forfeitures**

There were no forfeitures from participant accounts in 2023, 2022 or 2021.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). References to the "ASC" hereafter refer to the Accounting Standards Codification established by the Financial Accounting Standards Board (FASB) as the source of authoritative U.S. GAAP.

**Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires the use of estimates and assumptions regarding certain types of assets, liabilities, revenues and gains, and expenses and losses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from those estimated amounts.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains and/or losses are reported the day after the trade date.

Brokerage fees are added to the acquisition costs of assets purchased and subtracted from the proceeds of assets sold.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of February 7, 2023 or December 31, 2022 or 2021. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. The majority of administrative expenses incurred by the Plan are absorbed by the Company except for service fees, which are deducted from the applicable participants' accounts.

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through January 19, 2024, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION PREPARED AND CERTIFIED BY ASCENSUS TRUST COMPANY**

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at February 7, 2023 and December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments and interest and dividends for the period ended February 7, 2023 and the years ended December 31, 2022 and 2021, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus, LLC as agent for Ascensus Trust Company, the trustee of the Plan.

**NOTE 4 FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2022 and 2021. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Fund:* Valued at its amortized cost, which approximates fair value.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 RISKS, AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, all participants would become fully vested in their accounts.

**NOTE 7 TAX STATUS**

The Plan is based on the Prototype Non-Standardized Profit Sharing Plan with Ascensus, Inc., which received an opinion letter from the Internal Revenue Service (IRS) stating that the prototype plan was designed in accordance with the provisions of the IRC. The Plan has not filed for its own determination letter from the IRS. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The related trust, therefore, is not subject to tax under present income tax law.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTIES IN INTEREST**

Plan investments in mutual funds and the money market account are managed by Vanguard, who also serves as an administrator of the Plan, and therefore, these investments qualify as party-in-interest transactions. The Plan also has a number of service providers. Such providers were parties in interest under ERISA.

**NOTE 9 MERGER TO SUCCESSOR PLAN**

The Employer, as permitted by the Plan document, resolved to merge the Acuant, Inc 401(K) Plan into the Trinet 401(k) Plan, effective January 1, 2023 or as soon as administratively possible after that date. Effective February 7, 2023, total assets transferred were \$7,459,124, which includes \$58,848 of Employer receivable for the 2022 plan year end for the Plan that was subsequently deposited into the Trinet 401(k) plan in 2023.
