## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Astadia Incorporated 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of May 23, 2024 (liquidation) and December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the period from January 1, 2024 to May 23, 2024 (liquidation) and years ended December 31, 2023 and 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of May 23, 2024 and December 31, 2023 and 2022, and for the period from January 1, 2024 to May 23, 2024 and years ended December 31, 2023 and 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

## **Basis for Opinion**

As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 and 2022 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audits of the Financial Statements**

## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Plan Description**

The following is a summary of certain provisions of the Astadia Incorporated 401(k) Plan (the "Plan"). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**Participation** – The Plan is a defined contribution plan, established September 1, 2018, covering certain employees of Astadia Incorporated (the "Company") who meet the minimum service requirements. Employees who are scheduled to work 1,000 hours or more are eligible to participate in the Plan after 60 days of service and attaining age 21. This eligibility becomes effective on the first day of the month coinciding with or next following the date on which the employee meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan is administered by the Company which is responsible for controlling and managing the operations and administration of the Plan.

During 2023, the Company was acquired. As a result of this acquisition, all employees became eligible participants in the acquiring company's plan in October 2023 and the Plan was terminated. Remaining balances were distributed based on individual participant elections.

**Contributions** – Participants may elect to make contributions of a specific percentage or dollar amount of their eligible earnings on a "pre-tax" or Roth basis subject to certain limitations of the Plan and the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan provides for discretionary employer matching and profit-sharing contributions. During 2023 and 2022, the Company matched 50% of the first 2% of compensation contributed by participants. No profit-sharing contributions were made during 2024, 2023 or 2022.

**Participant Accounts** – Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are at all times vested in their elective and voluntary contributions and earnings thereon. Participants vest in the Company contributions 25% each year starting with the first year of service until fully vested after four years. In the event of termination due to disability, a participant's Company contributions become 100% vested.

**Payment of Benefits** – A participant, upon retirement, termination, disability or the attainment of age 59½ or a participant's beneficiary upon the participant's death, may elect to receive a lump-sum amount equal to the value of his or her vested account balance. In the case of a severe financial hardship, the administrator, in its sole discretion, may direct distribution of all or a portion of the participant's voluntary contributions, subject to certain restrictions.

**Forfeitures** – Forfeitures may be used to pay any plan expenses or to reduce any employer contributions. There were \$1,010, \$5,625 and \$14,216 of forfeitures were used to offset administrative expenses during 2024, 2023 and 2022, respectively. Unallocated forfeitures at 2023 and 2022 were \$1,056 and \$3,376, respectively.

**Note 1. Plan Description (Continued)**

Notes Receivable From Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates at prime plus 1%. Principal and interest is paid ratably through payroll deductions.

**Note 2. Summary of Significant Accounting Policies**

Basis of Accounting – As a result of the Plan termination described in Note 1, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 and 2022 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements in accordance with the accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation and income recognition policies utilizing information provided by the custodian and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2023 or 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants on a timely basis.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of the Plan are paid by the Company or the Plan at the Company's discretion. Fees related to benefit payments and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events – The Plan has evaluated subsequent events through January 21, 2025, the date of which the financial statements were available to be issued.

#### Note 3. Unaudited Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the statements of net assets available for benefits at May 23, 2024 (liquidation) and December 31, 2023 and 2022, the supplemental schedule at December 31, 2023, the related investment and notes receivable interest activity reflected in the statements of changes in net assets available for benefits for the period from January 1, 2024 to May 23, 2024 (liquidation) and years ended December 31, 2023 and 2022 and investment related information in the accompanying notes to the financial statements. The information is unaudited by independent accountants.

#### Note 4. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for plan assets measured at fair value:

- *Mutual funds, common stock and money market funds:* The fair value of investments held in these accounts is based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.
- *Collective trust funds:* The investments in the collective trust funds are held and managed by Invesco. The fair value of investments held in these accounts is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs and the market value of the underlying investments, and is classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2022 to May 23, 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Party-in-Interest Transactions**

Fidelity Management Trust Company is Trustee as defined by the Plan and is related to Fidelity Investments Institutional Operations Company, Inc. (the "Recordkeeper") and Fidelity Investments. Certain Plan investments are in a money market fund and mutual funds managed by Fidelity Investments, and certain administrative expenses are paid to the Recordkeeper. These transactions qualify as party-in-interest transactions.

**Note 6. Income Tax Status**

The Plan has adopted an approved volume submitter plan document. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.
